Work Session

SB 505

Directs the Oregon Department of Emergency Management to develop and implement a grant program to distribute moneys to certain counties to fund emergency preparedness coordinators.

SB 807 **

**Subsequent Referral(s) to Ways and Means

Authorizes the Adjutant General to pay a reenlistment or retention bonus to a member of the Oregon National Guard.

SB 668

Expands tuition benefits available to disabled veterans to permit veterans who are Oregon residents and are 80 percent or more disabled, and the spouse and child of disabled veterans, to have tuition waived for enrollment in a vocational program or an associate degree, baccalaureate degree or master's degree program at community colleges, public universities and the Oregon Health and Science University.

SB 798

Provides out-of-state members of the Oregon National Guard with in-state tuition and other higher education benefits.

SB 806

Allows the Civil Air Patrol to use Oregon National Guard armories and facilities for official business at no cost.

Public Hearing

SB 823

Authorizes the Oregon Department of Emergency Management to purchase or contract for certain materials, supplies and equipment.

SB 826

Transfers duties, functions and powers related to the Oregon Statewide Communication Interoperability Plan from the State Chief Information Officer to the Oregon Department of Emergency Management.
