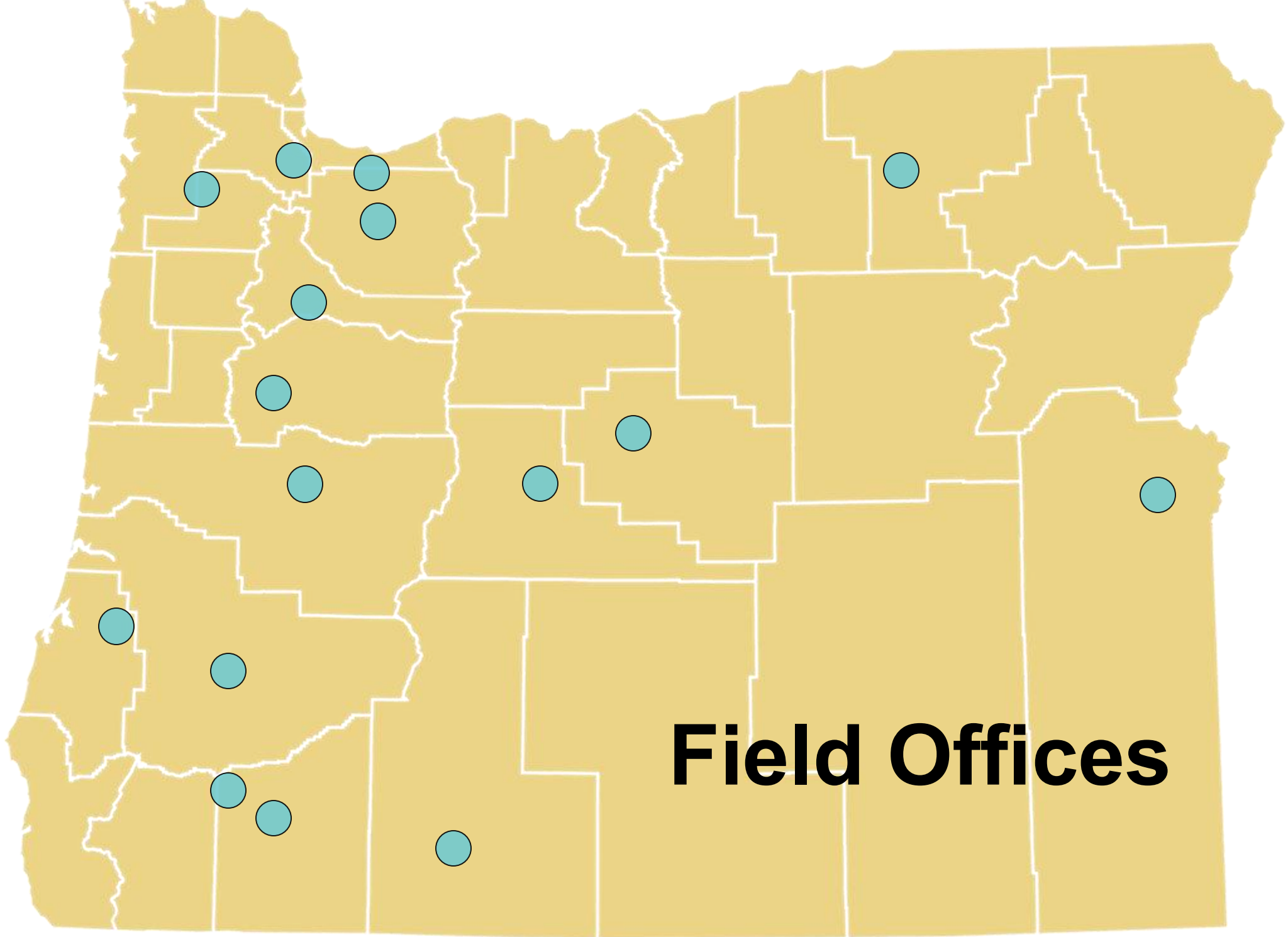

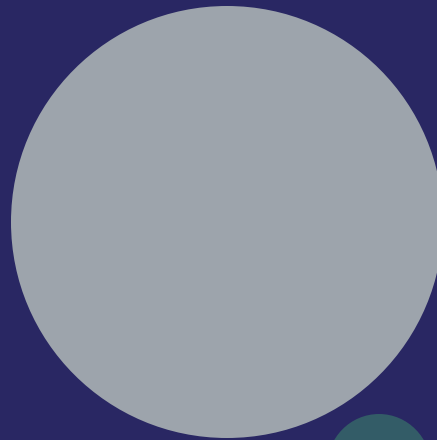


Oregon's Juvenile Justice System

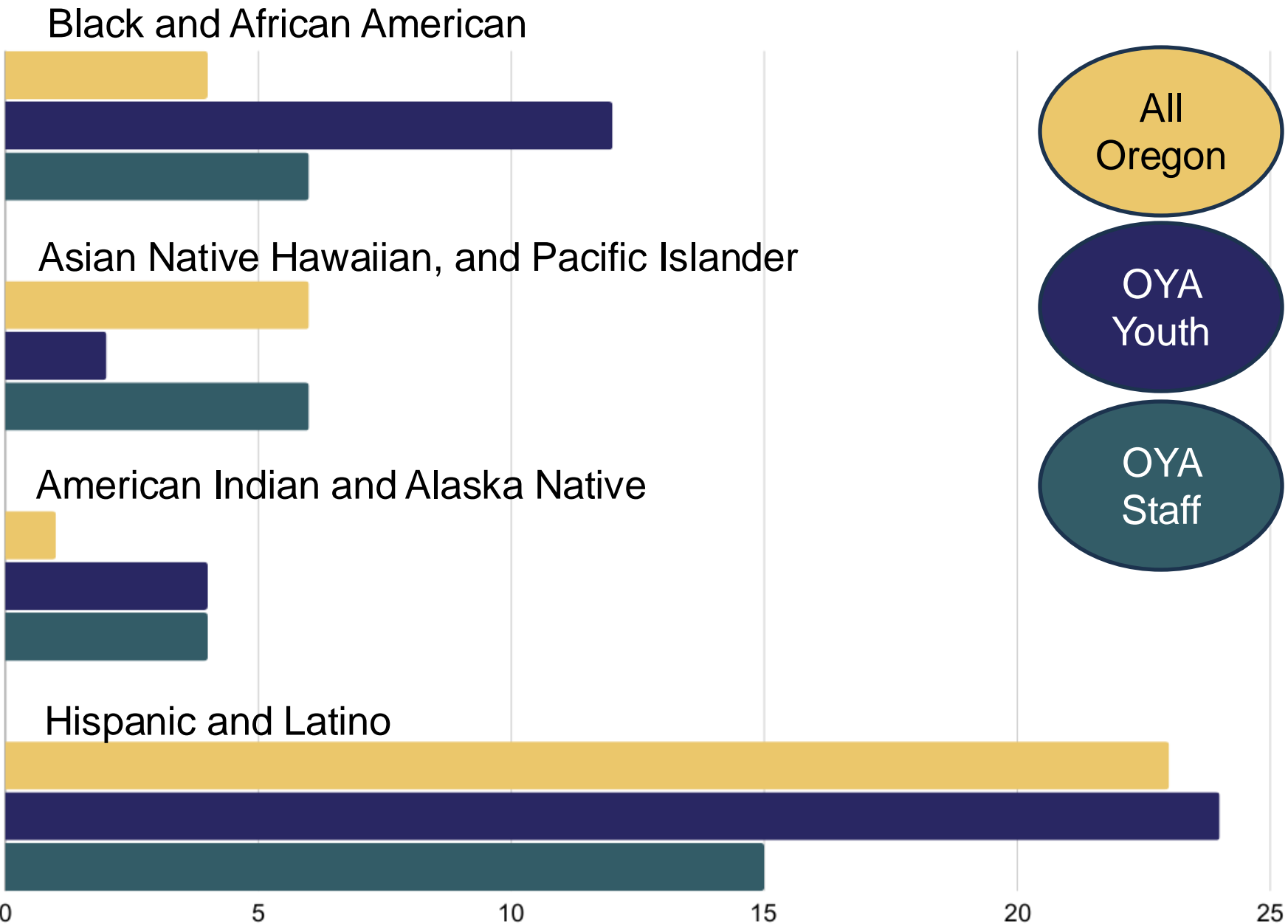


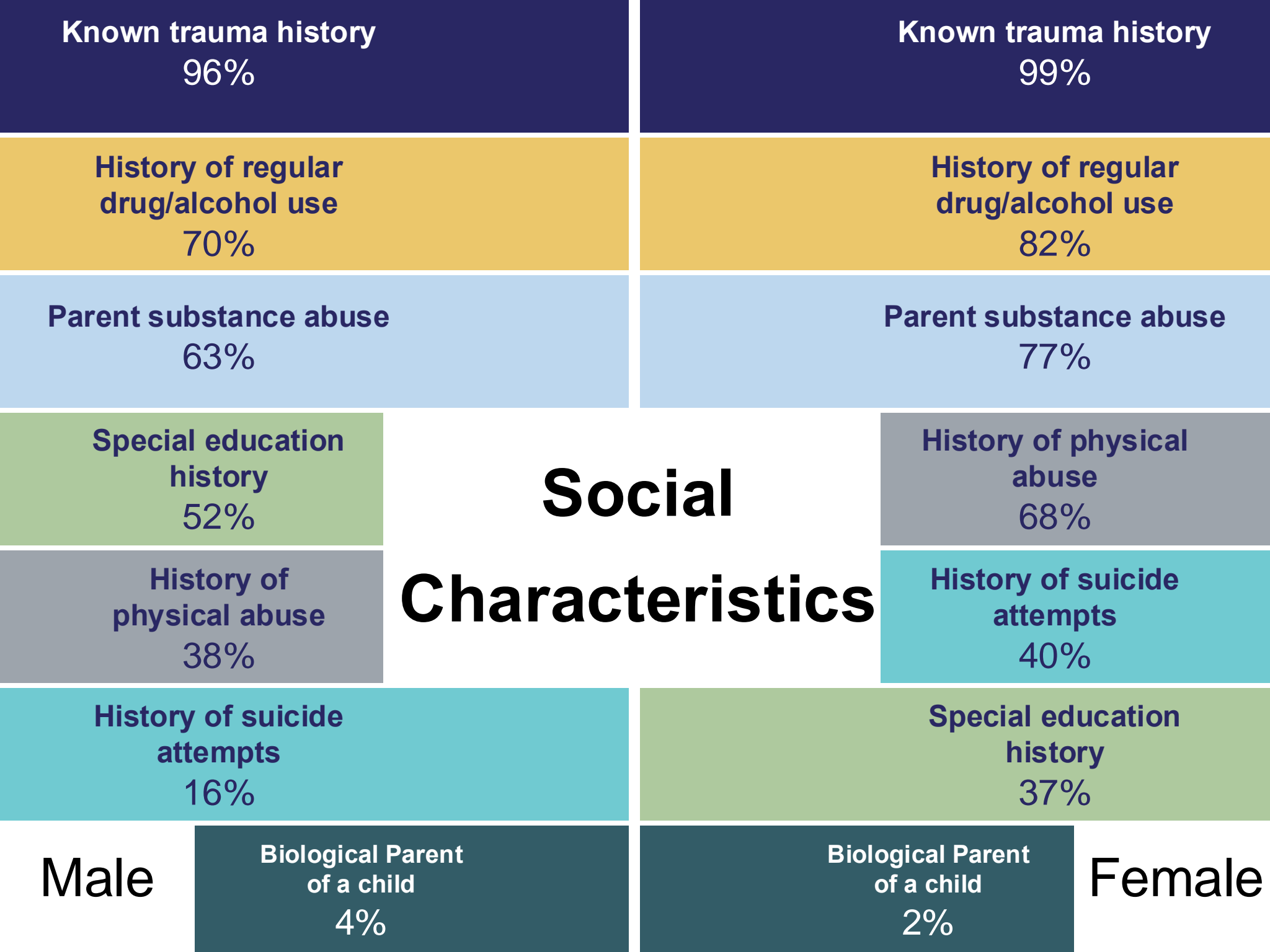

Sex Offense	235	26%
Property	158	18%
Person-to-Person	260	29%
Robbery	66	7%
Drugs/Alcohol-Related	12	1%
Weapon-Related	65	7%
Homicide-Related	49	6%
Criminal Other	35	4%
Arson	4	1%
Public Order	6	1%

Racial Disparities At OYA (by %)





Since 2022, 86% of OYA youth have current or past substance abuse

60% of OYA boys and 82% of OYA girls have a diagnosed mental health disorder

29% increase in trauma-related diagnoses among males committed to OYA since 2020

97% of the youth entering our facilities recently have known trauma history

- Adopt the Governor's Proposed Budget for OYA

Strengthen Infrastructure
