


What is the Department of Land Conservation and Development (DLCD)?

- Established in 1973 by SB 100
- Operationalizes the state's land use planning program
- Writes rules and guidance for 19 planning goals
- Reviews comprehensive plans from cities and counties
- Provides technical assistance and grants to local governments

Goal 10 is "Housing" Goal 14 is "Urbanization"

Housing Services Division: Middle Housing

HB 2001 in 2019 legalized middle housing on most urban singlefamily lots across the state

> SB 458 in 2021created middle housing land divisions to facilitate homeownership options

> > HB 3395 in 2023 expanded middle housing to smaller cities

Housing Services Division: Oregon Housing Needs Analysis (OHNA)

- HB 2003 (2019) -> Directs pilot OHNA methodology
- HB 5006 (2021) -> Directs DLCD to make recommendations for implementation
- HB 2001 & 2889 (2023) -> Establishes OHNA in statute
- HB 4063 (2024) -> Extends OHNA requirements to unincorporated urban lands in Metro counties

Housing Services Division: Oregon Housing

Oregon Housing Needs Analysis (OHNA)

- Oregon Housing Needs Analysis (OHNA) reforms state's housing planning program
- OHNA changes the way cities estimate need and plan for:
 - Housing (Statewide Planning Goal 10)
 - Urban Growth Boundaries (Statewide Planning Goal 14)
- Reduces local analytical burden, provides data and information for local decision-making
- Directs focus of local governments towards taking actions within their control to affirmatively further fair housing and to facilitate greater housing production, affordability, and choice

Update on Rulemaking and Implementation

- DLCD is halfway through rulemaking process
- ✓ DAS published methodology and inaugural housing production targets and needed housing allocations
- ✓OHCS published housing production and equity indicator dashboards

By December 31, 2024:

- 2 of 3 sets of DLCD rules
- Dashboards
- Methodology/Results

By December 31, 2025:

• 3rd set of rules

Beyond 2025

• Guidance, Tools, Resources

Housing Services Division: Model Codes

- Per SB 1564, DLCD will be developing a set of three model housing codes for cities:
 - 2,500>
 - 2,500 24,999
 - 25,00+
- The Land Conservation and Development Commission will adopt them by January 1, 2026

Housing Accountability and Production Office

Established by SB 1537 (2024)

Also known as "HAPO"

Purpose: Boost housing production via support to developers and cities

Approach: Collaboration first, enforcement last

- Venue for ensuring local land use codes and decisions meet state law
- Technical assistance funds for local governments
- Produces studies, research, guidance, and best practices to reduce barriers to housing production to include model code and 'ready-build' plans
- Avenue for resolving disputes prior to more formal Commission or appeal processes
- Voluntarily compliance mechanisms and, if needed, mandatory compliance mechanisms

Operative date of office: July 1, 2025

SB 1537 (2024): Boosting Housing Production

- Opting into amended housing regulations the 'Goal-Post Rule'
- Attorney fees
- Housing land use adjustments
- Limited land use decisions

- Provide timely technical support and dispute resolution

- Collaborate with our DLCD partners and help foster pursuit of our state's housing initiatives
