#### **SUMMARY**

Digest: The Act lets police agencies release booking photos to licensed PIs. The Act takes effect on the 91st day after sine die. (Flesch Readability Score: 72.6).

Authorizes law enforcement agencies to release booking photos to licensed private investigators.

Takes effect on the 91st day following adjournment sine die.

#### A BILL FOR AN ACT

- Relating to the release of booking photos; amending ORS 133.870; and pre-2 3 scribing an effective date.
- Be It Enacted by the People of the State of Oregon: 4
- **SECTION 1.** ORS 133.870 is amended to read: 5
- 133.870. (1) Notwithstanding ORS 192.311 to 192.478, a law enforcement 6
- agency may not release a booking photo except as provided in subsection (2) 7
- of this section. 8

- 9 (2) A law enforcement agency may release a booking photo described in subsection (1) of this section: 10
  - (a) To the person depicted in the booking photo;
- (b) To another law enforcement agency, or to a law enforcement officer 12 employed by another law enforcement agency, for a law enforcement purpose;
- (c) To the public, if the law enforcement agency determines that there is 14
- a law enforcement purpose for the release, including but not limited to as-15
- sistance with the apprehension of a fugitive or a suspect in a criminal in-16
- vestigation, or the identification of additional criminal activity; 17
  - (d) To a state mental hospital upon the admission to the hospital of the

- 1 person depicted in the booking photo;
- 2 (e) To a party in a criminal proceeding resulting from the arrest during 3 which the booking photo was obtained;
- 4 (f) To the victim of the offense for which the person depicted in the 5 booking photo was arrested;
- 6 (g) To the court, if the booking photo is part of a pretrial release report 7 or is provided to the court as part of the pretrial release process for the 8 purposes of confirming the identity of a defendant; [or]

## (h) To an investigator licensed under ORS 703.430; or

- [(h)] (i) Upon the conviction of the person depicted in the booking photo, if the conviction results from the arrest during which the booking photo was obtained.

- 14 (a) "Booking photo" means a photograph of a person taken by a law 15 enforcement agency for identification purposes when the person is booked 16 into custody.
- 17 (b) "Law enforcement agency" has the meaning given that term in ORS 18 131.915.
- 19 (c) "Law enforcement officer" means an officer, deputy, member or em-20 ployee of a law enforcement agency.
- 21 <u>SECTION 2.</u> This 2025 Act takes effect on the 91st day after the date 22 on which the 2025 regular session of the Eighty-third Legislative As-23 sembly adjourns sine die.
