Re: Responses to Committee Questions on February 26, 2025

Dear Co-Chair Broadman and Co-Chair Evans:

Thank you again for giving us time to present on the Oregon Judicial Department (OJD) budget and Policy Option Packages on February 26, 2025. I am writing to provide additional information related to questions asked by committee members.

1. Representative Helfrich asked if we could send information about the Department of Administrative Services (DAS) surcharges and how they impact our overall budget.

State Government Service Charges (SGSC) are expenses allocated to an agency's budget to support statewide services. These funds primarily sustain operations and systems within DAS, including IT infrastructure, human resources, Workday, real estate, procurement, surplus property, the motor pool, and the State Library. OJD has little to no control over the amount allocated or required for SGSC payments, which are reviewed and approved by the legislature in the DAS budget.

OJD pays the SGSC, listed in the table below, and in addition pays approximately \$4.9 million per biennium for the following DAS charges for services specific to OJD:

- Rent/Facilities (Justice Building/Anderson): \$2.4 million
- Mail: \$1.2 million
- Duplicating Services: \$500,000

• Financial: \$400,000

- Motor Pool: \$250,000
- Other/Miscellaneous: \$170,000

The CSL budget is initially built to cover these projected costs. However, if costs increase later, additional funding is not always provided. More importantly, any across-the-board budget reductions cannot be applied to this category, meaning those cuts must be absorbed elsewhere in the budget.

The table on the below includes the full list of SGSC charges for the OJD 2025–27 CSL budget.
