2. Do you have something like Struggle Well or mental health resiliency program?

We have invited Struggle Well to put on several trainings for us in the past few years. Those who have attended the Struggle Well training have provided very positive feedback. The content is very applicable to the work our agency does in all our disciplines. We have been working toward getting a small team of our employees trained through their train-the-trainer program so we can make it more accessible.

Additionally, we also have similar content that the Health, Wellness, and Resiliency Unit presents in smaller bites in various training formats (Academy, in-service, quarterly meetings, and new employee orientation). The Struggle Well program is a two-day training.

3. Are there enough mental health professionals for law enforcement and fire communities?

The short answer is no. We have a group of about twelve clinicians that we work with on a regular basis providing individual crisis response and critical incident response. These clinicians are overwhelmed by the demand and are often not accepting new patients. It often takes several months to get an appointment with a clinician.

There are several ways to advocate for encouraging more clinicians to meet the demand. Specialized training for clinicians to treat public safety personnel. And incentives like scholarships and loan forgiveness for those who have public safety experience to become clinicians.
