

## HB 3148 -1 STAFF MEASURE SUMMARY

#### WHAT THE MEASURE DOES:

The measure makes various changes to the Oregon Public Utilities Commission's (PUC) low-income telecommunications assistance plan. It declares an emergency and is effective on passage.

#### Detailed Summary:

Names the Oregon Public Utilities Commission's (PUC) low-income telecommunications assistance plan the "Oregon Lifeline" plan (the plan).

Adds a one-time personal computing benefit to the plan. Directs the plan to provide low-income customers with a new or refurbished Internet-enabled desktop computer, laptop, or tablet plus any ancillary devices, such as a keyboard or mouse. Sets benefit limits at \$100 for a benefit recipient and at \$600 for the total retail price of the personal computing device and ancillary devices. Allows the PUC to contract with third parties to help provide these benefits.

Sets the maximum limit to be received by the PUC for the Residential Service Protection Fund for the 2025-27 biennium at \$25,877,295.

Removes language allowing public utilities, cooperative corporations, or unincorporated associations providing local exchange telecommunications to apply to establish an alternative plan for their own customers.

Directs the PUC to adopt rules necessary to carry out the duties, functions, and powers conferred by the measure by March 1, 2026. Directs the PUC to send a report to the Legislative Assembly and the Legislative Counsel upon the adoption of these rules.

Repeals statute that sunsets the program. Repeals statute establishing the Oregon Telephone Assistance Program Advisory Committee.

Allows the PUC to define low-income customer by rule. Updates references.

Declares an emergency, effective on passage.

-1 The amendment moves the deadline for the PUC to adopt rules necessary to carry out the duties, functions, and powers conferred by the measure from March 1 to December 1, 2026.

House Bill 2663 (1987) initially established the requirement that all Oregonians have access to adequate and affordable telephone service. Senate Bill 69 (2019) amended the law to include high-speed internet service. As a result, the Oregon Public Utility Commission (PUC) established [Oregon Lifeline](#) and several other programs. The Oregon Lifeline plan is an existing program that gives qualifying low-income Oregon households a monthly discount on phone or high-speed internet service. The Oregon Lifeline Advisory Committee advises the PUC on outreach and marketing strategies to increase participation in the program.

House Bill 3148 makes various changes to the Oregon Lifeline plan. It repeals statute that sunsets the program, adds a one-time personal computing benefit, sets maximum limits, and removes statute establishing an advisory committee.
