
## Oregon Housing and Community Services 2025-27 Governor's Budget Overview



## **Emerging Issues**

- One-time funding for housing and homeless programs established in 2023-25
- Continuation of work associated with Executive Orders 23-02, 24-02 (further extended in 25-01)
- Lack of affordable housing in Oregon
- Significant growth of the agency since 2015-17


## Oregon Housing and Community Services Expenditure History + 2025-27 Governor's Budget




## Agency Budget by Expenditure Category



#### Oregon Housing and Community Services 2025-27 Governor's Budget by Program (in millions)





### Oregon Housing and Community Services Revenue Sources



- General Fund -\$1,144.0 million (26 percent of agency revenues)
  - 24 percent is for debt service for previous bond sales

#### Lottery Funds - \$46.7 million (1 percent of agency revenues)

100 percent is for debt service for previous bond sales

#### Other Funds - \$2,634.3 million (61 percent of agency revenues)

 Housing Division Loan Repayments; Public Utility Fees; Lottery Bond proceeds; Article XI-Q bond proceeds; Interest Income; Transfers from General Fund; Administrative and Service Charges; and Miscellaneous Other Revenue; and Transfers from Oregon Department of Revenue, Oregon Department of Human Services; Oregon Health Authority

#### Federal Funds – \$524.3 million (12 percent of agency revenues)

 US Department of Housing and Urban Development; US Department of Health and Human Services; US Department of Energy; US Department of the Treasury; and Bonneville Power Administration

## Oregon Housing and Community Services 2025-27 Governor's Budget



#### **Key Investments**

- Maintain programs started in 2023-25 related to homelessness \$802.5 million
  - Shelter Programs \$217.9 million General Fund
  - Rehousing Programs \$398.6 million General Fund and Other Funds
  - Eviction Prevention \$173.2 million General Fund
  - Tribal Homelessness \$12.8 million General Fund
- Maintain Permanent Supportive Housing (PSH) for existing clients and expand PSH \$11.1 million
  - Maintenance \$8.6 million General Fund
  - Expansion \$2.5 million General Fund
- Housing and Manufactured Parks Preservation \$198.8 million
  - Housing Preservation \$161.4 million Other Funds (Lottery Bonds); \$4.9 million Lottery Funds Debt Service
  - Manufactured Parks Preservation \$25.3 million Other Funds (Lottery Bonds); \$1.2 million Lottery Funds Debt Service

#### Key Investments (cont.)

- Local Innovation and Fast Track (LIFT) Rental Housing and PSH \$822.1 million
  - Construction \$700 million Other Funds (Article XI-Q Bonds)
  - PSH \$80 million Other Funds (Article XI-Q Bonds)
  - Debt Service \$36.7 million General Fund
- LIFT Homeownership and Homeownership Development Incubator Program (HDIP) \$139.1 million
  - Construction \$100 million Other Funds (Article XI-Q Bonds)
  - HDIP \$16.9 million General Fund; \$17.5 million Other Funds
  - Debt Service \$4.7 million General Fund
- Down Payment Assistance \$37.5 million General Fund; \$37.5 million Other Funds
- Disaster Recovery & Resiliency \$7.3 million Other Funds; \$163.5 million Federal Funds
- Staffing necessary for efficient delivery of programs \$13.2 million Total Funds/42.74 FTE
