





Pkg 090 Analyst Adjustments

Pkg 090 implements a **(\$931,508)** General Fund reduction across three areas:

- Vacancy Savings Reduction (\$174,657) personnel saving on anticipated vacancies
- Predator Control Program (\$545,660) Eliminates funding to USDA Wildlife Services.
- Economic Development Position (\$211,191) Eliminates position

2025 ODA Legislative Bills



SB 809 – Expands Oregon's State Meat Inspection Program to include poultry, supporting local processors for a complete as equal to USDA program.

SB 832 – Grants ODA civil penalty authority for animal health, feed, and disease control violations, shifting enforcement away from criminal penalties for minor infractions.

SB 833 – Aligns Oregon's fertilizer regulations with updated AAPFCO standards, ensuring consistency and clarity for the agricultural industry.

Natural Resource Division (NRD)



✓ Water Quality

Collaborative compliance with agricultural producers to protect the long-term health of Oregon's water resources and working lands by minimizing runoff and soil loss.

✓ Agriculture & Consumer Products

Supports agricultural producers in the responsible use of pesticides, fertilizers, and soil amendments through education and compliance, ensuring safe and productive farming practices.

✓ Natural Resource Protection

Incorporate Oregon's land use, CAFO, and Right to Farm laws to sustain natural resources for future generations.



NRD 2023-25 Highlights



✓ State Nitrate Reduction Plan

Collaborated to implement a targeted plan addressing nitrate concerns in the Lower Umatilla Basin GWMA. This plan prioritizes clean drinking water and includes actions to mitigate further nitrate contamination.

✓ CAFO program improvements


Implemented SB 85 through rulemaking and clarity for small livestock operations. Conducted statewide outreach and education for new requirements.

✓ Modernizing Systems

Upgraded digital systems from static PDFs to digital, enhancing GIS capabilities, and streamlining processes for improved efficiency and data management.

2025 Legislative Fee Bill

HB 2809 – Adjusts the fee cap for pesticide product registration from \$400 to \$550 for the long-term budget of the Pesticides Program and supporting education, training, and compliance.



Plant Protection & Conservation (PPCP)



✓ Nursery, Christmas Tree & Hemp

Supports the health and marketability of Oregon's nursery stock and Christmas trees through inspection, certification, and enforcement of plant health standards. Licenses and regulates hemp producers to strengthen integrity and opportunities.

✓ Insect Pest Prevention & Noxious Weeds

Protects working lands by monitoring, managing, and preventing the spread of pests and invasive species. Early detection and rapid response safeguards agricultural productivity and environmental health.

✓ Plant Conservation

Conserves native plant species through permitting and restoration projects that supports Oregon's native seed strategies.



PPCP 2023-25 Highlights



✓ Pest Response

Led emergency response to a novel plant pathogen in partnership with USDA APHIS, preventing permanent quarantines and protecting Oregon's nursery industry. Continued efforts to contain vine mealybug to safeguard vineyards and nursery stock.

✓ Funding Opportunities


Granted over \$1.6 million to invasive species management and conservation; efforts to control invasive annual grasslands; advance the Native Seed Strategy; tribal conservation initiatives; and Japanese beetle eradication.

✓ Advancing Strategies

Developed a comprehensive pest grasshopper field guide to support surveyors in identification. Refined Oregon's Noxious Weed list by removing ten species to improve management priorities.

Food Safety and Animal Health (FS/AH)



✓ Food Safety Program

Ensures the safety of Oregon's food supply by conducting inspections, enforcing sanitation standards, and educating businesses to prevent foodborne illness.

✓ Animal Health

Promotes livestock health through disease prevention, emergency planning, and regulatory oversight, ensuring a safe and sustainable food system.

✓ Lab Services

Provides accredited testing and diagnostic services to support compliance work, agricultural industries, and public health protection.



FS/AH 2023-25 Highlights



✓ Keeping Food Safe

Identified and removed lead-contaminated cinnamon products from retail shelves protecting consumers. Managed extensive sampling, closures, and reopening of shellfish and crab harvesting during biotoxin events to safeguard Oregon's seafood sector.

Highly Pathogenic Avian Influenza


Continuing response to HPAI with detection of novel spillover events into new species and transmission sources. Collaborated with dairy producers through surveillance and biosecurity measures.

✓ Lab Services

Successfully relocated laboratory operations ensuring continued service and accreditation. Established a cannabis reference lab in partnership with OLCC.

2025 Legislative Fee Bill

HB 2805 – Makes permanent the authority to adjust fees annually providing a predictable funding mechanism for ODA's Food Safety Program by, protecting public health and maintaining consumer confidence in food products.



Agriculture Services



✓ Certification & Inspection

Promotes economic opportunities by certifying grades, sizes, and quality of commodities for market access. Administers Livestock ID for ownership verification and interstate commerce.

✓ Plant Health & Seed Services

Enhances marketability of specialty seed, grass seed, and nursery stock through testing, certification, and pest prevention. Diagnostic services and surveys support trade compliance and economic growth.

✓ Weights and Measures/Motor Fuels

Ensures fair commerce by verifying accuracy in scales, meters, and fuel dispensers. Protects consumers with fuel quality standards and fraud prevention.



Agriculture Services 2023-25 Highlights



✓ Strategic Realignment

Established the Agriculture Services Division to deliver high-quality services by consolidating field service programs, improving operational efficiency, reducing costs, and enhancing customer service.

✓ Inspections & Testing

Inspected 7.5 billion pounds of commodities for shipment, 1.1 million livestock for ownership verification, 21,000 acres for pest and disease control, and 52,175 weighing and measuring devices. Conducted 21,000 seed tests, supporting the export of 257 million pounds of seed.


✓ Service and Safety Training

Strengthened safety and compliance by conducting 52 on-farm readiness reviews and training 485 producers through 26 grower training safety classes, across agricultural operations.

2025 Legislative Fee Bill

HB 2806 – Updates the Weights and Measures Program fee structure to increase fee caps by 30% to maintain fairness in commercial transactions, consumer confidence.

✓ Board of Agriculture

A 10-member, Governor-appointed board of producers and public representatives to advise on the evolving needs of Oregon's agricultural and food systems.

✓ Director's Office

Provides strategic leadership, coordination, and communication through policy development, economic initiatives, and engagement to strengthen a competitive and resilient agricultural community.

✓ Agency Support Services

Powers the agency's effectiveness by delivering financial management, human resources, technology, and facility operations. Ensures ODA can efficiently execute its mission and strategic goals for Oregon agriculture.

✓ Agency Realignment

Reorganized the agency's structure and budget to improve efficiency, adaptability, and long-term sustainability, ensuring that ODA effectively meets the evolving needs of Oregon agriculture.

✓ Strategic Planning


Developed and implementing the ODA Strategic Plan and IT Strategic Plan, establishing a clear, forwardthinking direction for growth over the next three years.




