# Oregon's Water Story

Foundational Water Laws

Oregon's lands have been stewarded by Indigenous people since time immemorial.

Oregon adopts the *Prior Appropriation Doctrine* and declares that all water in Oregon **belongs to the public.** 

Oregon Groundwater Act establishes a statewide groundwater permitting system

> In-Stream Water Rights Act Established

> The Tribes have expressed their desire and right to be more directly involved in water decisions that impact their communities.

Oregon's Water Reality What's changed? Is the system working?

### **Water Scarcity**

In today's Oregon, virtually all the surface water has been appropriated, and groundwater supplies are increasingly strained

> Impacts the timing, magnitude and frequency of flows and the prevalence of high temperature events

### **Endangered Species**

Culturally and economically important fish species have been listed and most remain so today

Recognition that many people rely on water and have interest in water but don't **hold** water rights, and the growing need to ensure their interests are accounted for in decision-making.

### **Sovereign Tribal Nations**

Address and correct the reality that sovereign tribes have historically been left out of water management and water rights decisions

**Oregon's Reality: A Water Scarce Future** Oregon's streams are over-appropriated, aquifers are declining, and water demands continue to exceed supply.

The demands that are putting pressure on Oregon's water supply are likely to continue to grow, which raises the need for action to ensure the ongoing sustainability of our water.

# Updating Water Rights Transfers **Present Day**

Water Transfers Today: To permanently change the point of diversion or appropriation, the place of use, or the beneficial use of the right from that for which the right was originally issued, OWRD must determine that the proposed change will not enlarge the water right and will not injure other existing water rights.

> The existing water transfer process does not consider the impact and consequences on the public or on sovereign tribal nations.

Why Now? Current statutes do not allow a targeted look at impacts to at-risk species or water quality and the frequency of transfer requests is increasing.

> Our challenges will only intensify; a hard look at our water laws is long overdue.

# Updating Water Rights Transfers The Problem

Approval of transfer application that moves diversion point from downstream to upstream results in a diminished streamflow between the two points, potentially harming:

- > Fish Habitats
- > Water Quality



# Updating Water Rights Transfers Targeted Review of Transfer Requests

When an amendment to a permitted right is being sought by the water right holder, the public's interest in the impacts of that change to the resource can and should be meaningfully considered as part of the decision.

## SB1153:

- $\succ$  Targeted review of transfer application to determine whether the proposed changes will result in additional loss of instream habitat for sensitive, threatened or endangered aquatic species or will further impair a designated water quality limited stream
- **Creates a process for Oregon tribes to review transfers in selected areas**
- Clear conditioning authority for water right transfer approvals for water-level or water-use measurement and reporting, or screening a new point of diversion

# What the Bill Does

Targeted to STE/WQ impairment as compared to baseline condition

## Strategic

does not apply to reaches with instream water right

## Efficient

most of the analysis to undertake this review is already accommodated by OWRD's review

# What the Bill Doesn't Do

This is not a restoration bill. It is a status quo bill. Leave things as you found them.

Does not apply to existing water rights that are not requesting a change

## Does not implicate all transfers.

# **Updating Water Rights Transfers** Tribal Engagement

The State is falling short in appropriately recognizing and incorporating Indigenous knowledge into natural resource decision-making and policy development. Sovereign tribal nations have historically been left out of water rights decision in Oregon.

## SB1153:

- > Moves toward more direct engagement of sovereign tribes in water management processes.
- Establishes a time-limited process for sovereign tribes to opt-in to transfer application review in select areas and directly engage with OWRD and the applicant on concerns.
- Promotes a "Do No Harm" Philosophy.

Our understanding of these truths is based upon a legacy of survival and reliance on our Oregon rivers and lakes. This is the reason for our perseverance and the heartbeat of our culture.
