Measure Description

The measure directs the Housing and Community Services Department (HCSD) to distribute funds to Bridge Meadows to be used for expansion of the Bridge Meadows model of multigenerational housing across the state; development and construction of new housing units; and administrative costs related to the distribution of these funds. The measure directs to oversee the use of the funds distributed to ensure they are used only for the purposes specified in the measure.

The measure requires HCSD to submit a report on the progress and impact of the distribution of the funds to interim legislative committees by December 31 of each year, beginning in 2026 and ending in 2030. The measure makes a one-time appropriation of \$1 million General Fund to HCSD in the 2025-27 biennium to implement the measure.

Fiscal Analysis

The fiscal impact of the measure is \$1 million General Fund in the 2025-27 biennium. To administer this program, HCSD will distribute \$995,000 to Bridge Meadows to support the expansion of the Bridge Meadows model across the state. HCSD anticipates using \$5,000 for legal review of the grant agreement. HCSD will be able to absorb the expected increase in workload with existing staff. Assuming no additional funding is provided, the measure is anticipated to have a minimal fiscal impact on HCSD in the 2027-29 biennium.

Relevant Dates

The measure takes effect on January 1, 2026. Therefore, the General Fund appropriation to HCSD will not become available until January 1, 2026.
