Measure Description

The measure requires applicants for a psilocybin manufacturer license, a marijuana production license, or a marijuana processor license to provide the legal address and owner name of the business' location. The measure is operative January 1, 2026, and takes effect on the 91st day after sine die.

Fiscal Analysis

Oregon Liquor and Cannabis Commission

The Oregon Liquor and Cannabis Commission (OLCC) reports that in at least 90% of cases, license applicant names do not match the property owner names. Each licensing renewal cycle, a significant number of licensees update or amend their licensing information to include new business names or partnerships, so despite an existing moratorium on new licensees, a significant amount of time and staffing resources are required to update, verify, and background check information each renewal cycle. OLCC would need an additional full-time permanent Administrative Specialist 2 position (0.75 FTE in the 2025-27 biennium) at a cost of \$165,461 Other Funds to prepare and follow up on certified letters and amend documents for licensee files. Additional costs include \$33,750 Other Funds for the estimated cost of certified mail to 95% of licensees.

Oregon Health Authority

Implementation costs for OHA are minimal but may increase depending on the number of applications OHA receives that require additional verification. Currently the projected workload increase is indeterminate. Should the implementation of the measure result in a significant increase in workload or mailing costs, OHA may return to the legislature to request additional resources.

Relevant Dates

The measure declares an emergency and takes effect on passage.

The measure is operative January 1, 2026.
