## Agency with Choice: background

The 2024 Legislative session advanced Agency with Choice by passing two key bills:

#### Senate Bill 1521



#### House Bill 4129





# Office of Developmental Disabilities Services SB 1521: legislative history

#### 2022

- **SB 1548** directed ODHS Office of Developmental
- Disabilities (ODDS) to create service option called Agency with Choice (AWC).
- Service would support people who experience intellectual and developmental disabilities (I/DD) to self-direct their care.

#### 2023

- **SB 104** modified the AWC scope from direct services to individuals to supports for employers of Personal Support Workers (PSWs).
- Directed ODDS to contract with at least one provider of AWC services by July 1, 2024.

#### 2024

- **SB 1521** changed the name of SB 104's AWC services to "Enhanced Employer Supports"
- Redefined AWC, resembling the original model introduced by SB 1548
- New worker type: Direct Support Workers (DSWs)
- AWC providers must be certified and endorsed Medicaid agencies.

Effective January 1, 2026

#### Aging and People with Disabilities and Oregon Health Authority HB 4129 requirements

#### **ODHS and OHA must:**

- License no more than two Agency with Choice providers
- Ensure the rates paid to direct support workers are comparable to rates for homecare workers and personal care attendants
- Develop rules to ensure financial transparency.

- ODHS and OHA intend to jointly contract with up to two Agency with Choice providers
- Selected providers must support self-direction
- Creates a new provider type: Direct Support Worker (DSW).

### Office of Developmental Disabilities Services What is Agency with Choice in SB 1521?

Agency with Choice is an in-between option for people who live in their own or family home. It is more self-directed than traditional options with less responsibility than employing a Personal Support Worker (PSW) directly.

ODDS to adopt rules for AWC provider and service requirements

AWC is an endorsement option open to all willing and qualified providers

AWC assumes full employer responsibilities but supports self-direction and day-to-day co-management with individual

AWC available to all individuals who receive in-home services.

#### Aging and People with Disabilities and Oregon Health Authority What is Agency with Choice in HB 4129?

AWC is a proposed alternative to the current consumer-employer program.


APD and OHA would contract with up to two agencies to provide AWC.

AWC contractors would assume full employer responsibilities but support self-direction.

AWC would be available to all individuals who receive inhome services.

Individuals would choose to be consumer employers, use an in-home care agency or an AWC.

# Agency with Choice: Individual and consumer support

- Maximize autonomy and self-direction
- Meet with individuals to plan their supports
- Help individuals to:
  - Recruit, select and train DSW
  - Direct day-to-day services
  - Coordinate DSW schedule and activities
  - Maintain a safe workplace for DSW
- Help with planned DSW absences
- For APD and OHA: Create and maintain advisory committees
- For ODDS: Create feedback and engagement process



# Agency with Choice: Support for direct support workers

- Provide and verify completion of required training
- Involve DSWs in decisions about the work
- Minimize and mitigate negative impacts related to service disruptions, cancelations
- APD and OHA :
  - Enhance DSW's role as part of the care team
  - Ensure access to support coordination and services.



## Agency with Choice: Administration


- Recruit, hire and dismiss DSWs
- Ensure time capture compliance
- Manage payroll, benefits and time off
- Bill ODHS/OHA for services provided
- Maintain a quality assurance system and performance improvement plans
- Report abuse and critical incidents.

Population served	Older adults and people with physical disabilities	People with behavioral health conditions	People of all ages with intellectual and developmental disabilities.
Provider type	Contractor		Medicaid agency

Effective date	January 2026





## Budget overview: positions

ODDS positions hired: 2 2025-27 Positions: 3 OHA positions hired: 5 Recruitments pending: 1

#### Aging and People with Disabilities and Oregon Health Authority Minimum rate requirements

DSW wages and benefits must be at least equal to that of homecare workers and personal care attendants. Rates must allow the agency to minimize lost wages and hours for DSWs.

Support substitute DSW staffing needs due to:

- Cancelled shifts
- Absences
- Respite care.

Rates need to meet the requirements for training and supports for DSWs and for individuals.

### Office of Developmental Disabilities Services Implementation updates: milestones



Hosted workgroups in 2022 (SB 1548) and 2023(SB 104) to inform self-direction expectations under AWC and differences between SMA and AWC services and provider qualifications.




Fully implemented SMA provider type: rules, guidance, rates, and enforcement.



Implemented Enhanced Employer Supports for people who employ PSWs.

### Aging and People with Disabilities and Oregon Health Authority Implementation updates: milestones



Hosted ad hoc consumer advisory committee in 2024 to inform self-direction expectations under AWC.



Consulted with Oregon Department of Justice on ways to streamline OHA and APD partnering on rules, licensing and contracting.



Developed proposed rate methodology.



Hosted initial rule advisory committees.
