WHAT THE MEASURE DOES:

The measure requires the owner or operator of a municipal solid waste landfill to conduct surface emissions monitoring and report data as specified to the Department of Environmental Quality.

Requires the Environmental Quality Commission (Commission) to establish rules for surface emissions monitoring and mitigation of methane gas emissions from municipal solid waste landfills. Requires, as of July 1, 2026, an owner/operator of a municipal solid waste landfill required to conduct surface emissions monitoring to:

- use advanced methane detection technology to conduct surface emissions monitoring above all surface areas
 of the landfill;
- report results, including specific information to the Department of Environmental Quality (DEQ);
- maintain monitoring records for at least five years; and
- remoniter, after taking corrective action, within 10 days of any exceedance; and submit a mitigation plan to DEQ for approval if owner/operator cannot take corrective action because the exceedance is located within the active or working face of the landfill.

Takes effect on 91st day following adjournment sine die.

ISSUES DISCUSSED:

EFFECT OF AMENDMENT:

- -2 Requires the advanced methane detection technology used by the owner or operator of municipal solid waste landfill to use technology that meets minimum standards established by the Environmental Quality Commission. Extends the implementation date from July 1, 2026 to January 1, 2027.
- -3 Modifies the definition of "municipal solid waste landfill" to comply with federal requirements. Requires the advanced methane detection technology used by the owner or operator of municipal solid waste landfill to use technology that meets minimum standards established by the Environmental Quality Commission. - -4 Replaces the measure. Requires the Department of Environmental Quality (DEQ) to establish a pilot program for landfills to use OTM-51 to conduct surface emissions monitoring. Stipulates requirements for owner or operator that voluntarily agrees to participate in pilot program. Requires DEQ to use data received by pilot program and other information collected to take certain actions including but not limited to evaluate the creation of Oregon -specific requirements and reimburse pilot program participants for the costs of conducting monitoring. Requoires DEQ to report to Interim committee related to environment no later than December 15, 2026, Declares emergency, effective on passage.

BACKGROUND:

According to the Department of Environmental Quality (DEQ) Landfill gas is a natural byproduct of the decomposition of organic material in landfills and is composed of approximately 50 percent methane. Methane is more than 80 times as potent as carbon dioxide in the short-term according to DEQ. In October 2021, the

Environmental Quality Commission adopted new rules which regulate landfill gas emissions. The rules require many landfills in Oregon to obtain an Air Contaminant Discharge Permit to submit data on the landfill characteristics and potentially monitor, collect and/or control landfill gas emissions.
