Measure Description

The measure authorizes the Oregon Business Development Department (OBDD) and the Governor to award grants and make loans from moneys in the Oregon CHIPS Fund to businesses that have not applied for federal semiconductor financial assistance, but that meet the definition of a covered entity. The measure removes the sunset date for the Oregon CHIPS Fund and the requirement that any remaining moneys in the Oregon CHIPS Fund must revert to the General Fund. The measure provides OBDD \$15 million in Other Funds expenditure limitation from the Oregon CHIPS Fund for the 2025-27 biennium to award grants and make loans to covered entities.

Fiscal Analysis

The fiscal impact of the measure is \$15 million Other Funds in the 2025-27 biennium. OBDD currently awards grants and makes loans from the Oregon CHIPS Fund to businesses applying for federal semiconductor financial assistance. The measure would expand the pool of eligible applicants by removing the requirement that a business must first apply for federal semiconductor financial assistance. These changes will enable OBDD to continue providing additional financial assistance to covered entities in the 2025-27 biennium. OBDD anticipates providing \$15 million in new grants in the 2025-27 biennium with this expanded authority and the requisite expenditure limitation. Additional administrative costs associated with the Oregon CHIPS Fund program are anticipated to be minimal and absorbable within agency existing resources.

Although not included in this measure, OBDD has also requested an additional \$27.5 million in carry-forward Other Funds expenditure limitation in the 2025-27 biennium for projects currently under contract, which may be included in a policy option package in OBDD's budget bill, HB 5024 (2025). The Oregon CHIPS Fund currently has sufficient funds to fully utilize this proposed additional expenditure limitation.

Measure: HB 2277 - 2

The measure is not anticipated to have a fiscal impact on the Office of the Governor.

Relevant Dates

The measure declares an emergency and takes effect on passage.

The measure removes the June 30, 2025, sunset date for the Oregon CHIPS Fund, and thereby, extends the fund indefinitely. Any remaining moneys in the Oregon CHIPS Fund on June 30, 2025, will remain in the Oregon CHIPS Fund instead of reverting to the General Fund.
