WHAT THE MEASURE DOES:

The measure establishes the Task Force on Recruitment and Retention of Case Managers and Adult Protective Service Workers, specifies the task force membership and structure, and directs the task force to study and make recommendations that address barriers and best practices to recruit and retain case managers and adult protective services workers. The measure directs the task force to submit a report, including recommendations, to interim committees of the Legislative Assembly by December 15, 2026, and appropriates unspecified General Fund moneys to the Department of Human Services (DHS) for the task force.

Detailed Summary:

- Establishes the Task Force on the Recruitment and Retention of Case Managers and Adult Protective Service Workers (task force) and outlines the membership and structure of the task force.
- Instructs the task force to identify:
 - barriers to the recruitment and retention of adult protective services workers and case managers who serve individuals receiving Medicaid-funded long term care services,
 - o recruitment and retention best practices from other states, and
 - o solutions to improve recruitment and retention rates.
- Specifies scope of the task force's work and outlines operational requirements.
- Requires the task force to submit a report and recommendations to interim committees of the Legislative Assembly related to health by December 15, 2026.
- Sunsets December 31, 2026.
- Appropriates unspecified General Funds moneys to the Department of Human Services to conduct the task force.
- Declares an emergency, effective July 1, 2025.

REVENUE: No revenue impact.

FISCAL: May have fiscal impact, but no statement yet issued.

ISSUES DISCUSSED:

EFFECT OF AMENDMENT:

-1 The amendment entitles members of the task force to receive compensation end expenses, rather than being volunteers of the task force.

BACKGROUND:

HB 2061 -1 STAFF MEASURE SUMMARY

Oregon's Medicaid program, called the <u>Oregon Health Plan (OHP)</u> provides payment for long-term care for people who meet certain eligibility requirements. Services may include help with daily activities, health-related tasks, and other services. The Department of Human Services' Office of Aging and People with Disabilities (APD) is responsible for licensing, regulating, and overseeing the state's providers of long term care services, including in-home care and residential care facilities such as nursing facilities, assisted living, memory care, and adult foster homes. APD also provides and coordinates, through local Area Agencies on Aging, case management for individuals who receive these services through OHP and investigates instances of reported abuse of vulnerable adults through the Adult Protective Services program, as required by the federal Older Americans Act. <u>According to APD</u>, Adult Protective Services investigated 25,769 alleged incidents of abuse, and more then 57,000 people received support through Medicaid long-term services and supports in the two-year period ending in June 2023.
