Measure Description

The measure directs the Health Licensing Office, budgeted within the Oregon Health Authority (OHA), to issue a nutritionist license to qualified applicants. The Board of Licensed Dietitians is renamed to the Board of Licensed Dietitians and Nutritionists. The measure permits licensed dietitians and nutritionists to provide medical nutrition therapy via telehealth.

Fiscal Analysis

The fiscal impact of the measure is \$583,119 Other Funds and three positions (2.00 FTE). OHA estimates the Board of Licensed Dietitians will double membership with the addition of licensed nutritionists, for a total of 10,500 licensees. With the addition of licensed nutritionists, OHA projects a biennial increase of \$595,000 Other Funds in Revenue. OHA will begin to collect these fees in the 2027-29 biennium following fee ratification. Positions required to support the board are paid by the licensing fees the board collects. While new fees are not expected to generate revenue until 2027-29, there are sufficient fees within the Health Licensing Office to temporarily cover the cost for additional staff. To manage the increased workload, OHA will require up to three additional permanent positions, the estimated cost for these positions including personal services and position-related services and supplies costs is \$508,119 Other Funds. New positions include one full-time Operations and Policy Analyst 3 position to review and analyze licensing applications, one full-time Compliance Specialist 2

position to create the registration process and enforce compliance and one part-time Fiscal Analyst 2 position to track, analyze, project, and manage increased revenue. In 2027-29 costs increase to \$630,639 Other Funds and reflect a full biennium of position costs.
