WHAT THE MEASURE DOES:

The measure requires the Oregon Department of Emergency Management to develop a registry of people willing and able to provide volunteer services related to emergency response; requires the department to provide training to volunteers listed in the registry; and requires the Legislature dedicate unexpended funds to emergency volunteer purposes.

Detailed Background

- Requires the department to develop and maintain the registry; describes conditions for registry inclusion; allows the department to allow other persons on the registry.
- Allows the department to require evidence of qualifications; training experience; and criminal background checks.
- Describes what information will be included in the registry.
- Requires the department to make the registry accessible to emergency management agencies; emergency program mangers; and others that the department deems as necessary for public safety.
- Allows the department to establish procedures for communicating with appropriate entities on the registry.
- Requires the department to develop and administer a statewide training program for volunteers on the registry; requires consultation with the Department of Public Safety Standards and Training.
- Requires the department to base the training on curriculum established by the Federal Emergency
 Management Agency; requires the department to offer the training remotely; and requires consultation with
 other agencies to develop the training.
- Establishes that the Legislative Assembly during each odd-numbered year regular session, dedicate a
 percentage of money from the General Fund that are unexpended at the end of the biennium to emergency
 volunteer purposes.

 Commission to adapt the Oregon Volunteers in Disaster (ORVID) database to include a registry of persons who
 are able and willing to provide volunteer emergency response services.
- Describes conditions for registry inclusion; allows the department to allow other persons on the registry.
- Allows the department to require evidence of qualifications; training experience; and criminal background checks.
- Describes what information will be included in the registry.

BACKGROUND:

Oregon Volunteers in Disaster (ORVID) is an online statewide, disaster volunteer management system, licensed and managed by OregonServes. ORVID is a free system that provides emergency response managers the ability to manage, track and credential volunteers, and for volunteers to connect to opportunities to help in their communities. Volunteers create a comprehensive profile in ORVID, including their expertise and availability, and disaster response organization list specific projects and volunteer needs on the database. According to OregonServes, ORVID is currently designed to support the recruitment and coordination of spontaneous volunteers.
