# Composition<sup>3</sup>

The board consists of seven Oregon residents:4

- five naturopathic physicians (EL-HASHEMY, LARIVEE, MARTIN, MINARIK, ROBLES-HERNANDEZ); and
- two public members who are not naturopathic physicians or a spouse, domestic partner, child, parent, or sibling of a naturopathic physician (LUPER, WATKINSON-WRIGHT).

The naturopathic physicians may be selected from a list of nominees submitted by professional organizations. They must have each practiced continuously in Oregon for the five years immediately prior to the date of appointment.

Members serve three-year terms and are eligible for reappointment, limited to two consecutive full terms. A member must be removed immediately if they fail to retain

qualifications for appointment or have three consecutive unexcused absences. The board annually elects its chair.<sup>5</sup>

### **Duties**<sup>6</sup>

The board licenses and regulates naturopathic physicians. The board must

- administer licenses for naturopathic physicians,
- adopt and assess fees for specified services,
- · when proposing discipline, give opportunity for an administrative hearing, and
- appoint a member to the Council on Naturopathic Physicians Formulary.
