## BOARD OF MEDICAL IMAGING

---

The Governor has appointed the following individual to the Board of Medical Imaging subject to Senate confirmation.<sup>1</sup>

### New Appointee

Monica Johnson of Portland

### Term

May 1, 2025 – April 30, 2028

### Appointment/Confirmation Authority

### Statement of Economic Interest<sup>2</sup>

Not required.

### Composition<sup>3</sup>

The board consists of 12 Oregon residents:

- one radiologist (**JOHNSON**);
- three licensed physicians (BIROUTI, KHAROTI, WHETSTONE);
- five individuals who are actively engaged medical imaging licensees, including:
  - one diagnostic medical sonographer (WOGU);
  - one magnetic resonance imager (VACANT);
  - one nuclear medicine technologist (BREAZEAL);
  - one radiation therapist (GILLILAND); and
  - one radiographer (MUMPER-ABDELQADER); and
- three public members (DEGMAN, HEMPHILL, VACANT).

The Oregon Health Authority Radiation Protection Services section manager, or designee, is an advisory member of the board for the purpose of providing counsel.

If not enough applications are received for the three licensed physician positions, the Governor may appoint these members from applicants who have been retired for fewer

than six years and who are either registered with the board as retired emeritus physicians or who provide the board with notice of retirement. If that fails to yield sufficient applications, the Governor may appoint the remaining board members among any combination of the following:

- a licensed chiropractic physician who is certified by the American Chiropractic Board of Radiology as a Diplomate of the American Chiropractic Board of Radiology,
- an actively engaged medical imaging licensee,
- a permitted limited X-ray machine operator, or
- a member of the public.

Licensee members may be selected by the Governor from a list of three to five nominees for each vacancy, submitted by a professional organization representing medical imaging licensees. Public members may not be otherwise eligible for appointment or be related to a person issued a license or permit by the board.

Members serve three-year terms. Seven members constitutes a quorum.

## **Duties<sup>4</sup>**

The board regulates the practice of medical imaging. The board must

- annually elect a chair and a vice chair,
- meet at least once every three months,
- issue licenses and permits,
- adopt rules,
- establish and collect reasonable fees,
- approve continuing education programs in medical imaging modalities and for limited X-ray machine operators,
- oversee examinations given each year for a limited X-ray machine operator permit, and
- require each licensee and permittee to submit evidence of continuing education pertinent to the license or permit.
