## OREGON STATE BOARD OF PHARMACY

---

The Governor has appointed the following individual to the Oregon State Board of Pharmacy subject to Senate confirmation.<sup>1</sup>

### New Appointee

Bryan Smith of Milwaukie

### Term

July 1, 2025 – June 30, 2029

### Appointment/Confirmation Authority

### Statement of Economic Interest<sup>2</sup>

Not required.

### Composition<sup>3</sup>

The board consists of nine Oregon residents:<sup>4</sup>

- five licensed pharmacists (HALL, KIRKBRIDE, KROEGER, PATEL, **SMITH**);
- two licensed pharmacy technicians (JOYCE, PINEDO); and
- two public members who are not licensed pharmacists or directly related to pharmacist (CHINN, HEMMING).

Members serve four-year terms. The pharmacists must be licensed and in good standing, engaged in the practice of pharmacy, and have five years of post-licensure experience. The pharmacy technicians must be licensed and in good standing, engaged as a pharmacy technician, and have at least three years of post-licensure experience. Public members may not currently have, or have formerly had, any material financial interest in pharmacy services, and may not have engaged in any activity directly related to the practice of pharmacy.

The board elects its president and vice president and must meet at least once every three months.

### **Duties<sup>5</sup>**

The board administers licensing for pharmacists, technicians, interns, and drug outlets and regulates the manufacture and distribution of drugs.

The board must

- annually print and circulate copies of applicable changes in the laws and rules,
- appoint advisory committees,
- determine fees to be collected for specified services, and
- make, adopt, amend, and repeal such rules as may be deemed necessary.
