## STATE BOARD OF LICENSED SOCIAL WORKERS

The Governor has appointed the following individuals to the State Board of Licensed Social Workers subject to Senate confirmation.<sup>1</sup>

#### **New Appointees**

Olivia Bormann of Portland Julie Magers of Beaverton Nicole Pantley of Pendleton

#### Reappointees

Julie Magers of Beaverton Nicole Pantely of Pendleton

#### Terms

Bormann: May 1, 2025 – June 30, 2027 Magers and Pantley: May 1, 2025 – June 30, 2025 Reappointees: July 1, 2025 – June 30, 2029

#### **Appointment/Confirmation Authority**

ORS 675.590 (2023)

#### **Composition**<sup>3</sup>

The board consists of seven Oregon residents:

- three licensed clinical social workers (ASHTON-WILLIAMS, FARR, JANSENN);
- one licensed baccalaureate social worker, a licensed master's social worker, or a certified clinical social work associate (BORMANN); and
- three public members with interest in clinical social work, who are not regulated social workers or a spouse, domestic partner, child, parent, or sibling of a regulated social worker (MAGERS, PANTLEY, VACANT).

Regulated social workers are appointed from lists of nominees submitted by relevant professional organizations. Members serve four-year terms and are eligible for reappointment. A member is removed if they fail to maintain appointment criteria or have three consecutive unexcused absences.

#### **Duties**<sup>4</sup>

The board regulates the practice of clinical social work. The board must

- administer licensing for regulated social workers;
- adopt rules for the administration of specified laws;
- establish and collect specified fees;
- formulate and enforce a code of professional conduct;
- annually publish a list of authorized regulated social workers;
- establish a voluntary arbitration procedure to resolve disputes between clients and workers; and
- report to the Legislative Assembly on its activities regarding authorizations to practice regulated social work during the preceding biennium.
