Dear Co-Chairs Sollman and Ruiz,

During the **April 22, 2025** community college presentations on the higher education and training budget (SB 5525), Sen. Frederick asked a question about higher education in prison opportunities in Oregon's correctional institutions. We wanted to take this opportunity to share information about the educational opportunities currently available to Oregon's Adults in Custody (AICs).

- Adult Basic Skills (ABS)/GED programs are provided by four community colleges (Central Oregon, Chemeketa, Portland, and Treasure Valley) at Oregon's 12 adult correctional institutions.
- Registered Apprenticeship programs in occupations such as boiler operators, cabinet
 makers, limited maintenance electricians, and plumbers are available at correctional
 institutions across the state, but serve only a small number of AICs, primarily due to the
 required journeyperson/apprenticeship ratios.
- Certificate and associate degree programs are provided by the four community colleges that also offer ABS/GED programs and are available to AICs in nine correctional institutions.
- Bachelor's degrees and other courses are offered by Lewis and Clark College, Corban University, Portland State University, and the University of Oregon in seven correctional institutions.
