Dear Co-Chair Broadman, Co-Chair Evans, and Members of the Committee:

Thank you for the opportunity to present and respond to questions yesterday on County Deflection Programs in relation to House Bill 5005. The attached table outlines data to a specific request to provide county level deflection referral counts, arrests with a PCS (possession of controlled substance) charge, and arrests that include charges for PCS only. Please note that eight counties did not apply for Behavioral Health Deflection grant funds: Curry, Coos, Douglas, Lake, Jefferson, Wheeler, Sherman, and Wallowa. These counties are included in the table for context and the deflection referral count is zero. Three counties are implementing deflection programs but have not yet entered referral data into the REDCap data system: Tillamook, Gilliam, and Morrow. Hood River and Wasco have a combined program, and the arrest counts for the two counties are combined in the table.
