Re: Follow up questions on the Title V Budget Note, submitted April 13, 2025

How many Title V permits are currently past the expiration date? For each of those permits, can you provide the amount of fees you have collected since the last permit issuance? So, if the permit was last issued in 2009, what is the sum of annual fees you have collected since then, including 2025?

The following table shows all facilities with an administratively extended permit. Because DEQ issues invoices annually, due between September and October, no facilities have been invoiced for 2025. As noted previously, federal law requires the entire Title V program be fee-funded, meaning fees support the all aspects of Title V permitting and oversight, including permit issuance, providing technical assistance to permit-holders, and performing compliance assurance activities (e.g. reviewing source-test reports, reviewing annual reports, investigating complaints, etc.).

DEQ does not charge a fee for a permit renewal. We have included a summary of amendments and modifications for each permit to provide a sense of permitting actions that continue regardless of permit status.
