Attached are the Legislative Fiscal Office (LFO) recommendations for the 2025-27 biennial budget and Key Performance Measures for the Oregon Advocacy Commissions Office. The recommended budget of \$1,685,008 General Fund, \$25,432 Other Funds and four positions (4.00 FTE) represents a 23.9% decrease from the 2023-25 legislatively approved budget (LAB), and a 0.9% increase from the current service level budget. The decrease from the 2023-25 LAB is primarily due to the phase-out of three limited duration positions and associated costs related to the work performed under HB 2925 (2023).
