Subject: HB 5033 – Department of Public Safety Standards and Training - Fee Ratification

Work Session Recommendations

HB 5033 is the fee ratification bill for the Department of Public Safety Standards and Training (DPSST). The bill, as amended by the -1, provides the enabling legislation necessary to ratify fees adopted through administrative rule hearings and approved by the Department of Administrative Services during the 2023-25 biennium. Statute requires all new agency fees or fee increases adopted between regular sessions of the Legislative Assembly be authorized by enabling legislation or rescinded upon adjournment of the next regular session.

The Board administratively increased the following fees:

ORS 181A.870 allows the Board on Public Safety Standards and Training, in collaboration with the Private Security and Investigator Policy Committee, to establish fees for issuing certifications and licenses to private security providers. The fees may not exceed the costs for administration of the certification and licensing program, the criminal records check, and any training program required by rule. The most recent change to these fees was 2023.

ORS 181A.900 allows the Board on Public Safety Standards and Training to establish fees for issuing licenses to private security entities. The fees may not exceed the costs for administration of the licensing program, the license examination, and the investigation of each applicant's character, competence, and reliability. There have been no changes since this was established in 2023.

ORS 703.480 allows the Board on Public Safety Standards and Training, in collaboration with the Private Security and Investigator Committee, to establish fees for applications and issuing licenses to private investigators. The fees may not exceed the costs for administration of the program. The most recent change to these fees was 2022.

The -1 amendment removed the use of an acronym and removed a fee from the introduced bill that had been included in error.

DPSST anticipates the fee increases will generate approximately \$1 million of Other Funds revenue during the 2025-27 biennium based on the most recent 12-month average of licenses and certifications.
