Department of Administrative Services Compensation Plan Changes

Request: Acknowledge receipt of a report on compensation plan changes.

Analysis: ORS 291.371 requires the Department of Administrative Services (DAS) to report to the Joint Committee on Ways and Means on changes to the state's compensation plan prior to implementation.

The current report submitted by DAS contains the following compensation plan changes for the Association of Engineering Employees (AEE), effective June 1, 2025:

- Selective increases for certain Engineering Specialists and Associate in Engineering classifications.
- Establishes an Engineering Specialist 4 classification.
- Abolishes the Student Engineering Specialist classification.

DAS estimates the total 2023-25 cost of these changes is \$586,751 total funds, which includes \$1,350 General Fund, \$8,508 Lottery Funds, and \$576,894 Other Funds. For the 2025-27 biennium, the cost of these compensation changes is anticipated to be \$14,082,028 total funds, including \$32,389 General Fund, \$204,189 Lottery Funds, and \$13,845,450 Other Funds.

Recommendation: The Legislative Fiscal Office recommends acknowledging receipt of the report.

Discussion: This report, by the Department of Administrative Services (DAS), is for Executive branch compensation plan changes required by ORS 291.371. This report includes information on the implementation of compensation plan changes for the Association of Engineering Employees (AEE) union. The adjustments change salary ranges on six classifications, establish a new classification, and abolish one classification.

The total cost of changes in the 2023-25 biennium are \$586,751, with \$576,894 coming from Other Funds sources. Roll up costs for the 2025-27 biennium are \$32,389 General Fund, \$204,189 Lottery Funds, and \$13,845,450 Other Funds.
