## **State-Funded Recovery**

### Wildfire Recovery and Resilience Account (WRRA)

- 450 impacted households supported with intermediate housing assistance
- 867 impacted households supported with permanent recovery, including assistance with purchase or replacement of a manufactured home

### **Developments funded with state wildfire dollars**

- Royal Oaks 118 modular homes in Jackson County
- Talent Mobile Estates 87 manufactured homes in Jackson County
- Lincoln County
  - Depoe Bay 12 townhomes
  - Coastal Vineyard 12 tiny homes
  - Otis Lot and Garden Estates (single lots with manufactured homes)
- Lazy Days 20 modular homes and 10 tiny homes in Lane County
- 15-acre land acquisition in Marion County
- 5-acre land acquisition in Lane County















# Community Development Block Grant Disaster Recovery (CDBG-DR) - \$422M

CDBG-DR **long-term recovery** funds are used to help individuals, communities, and businesses impacted by the 2020 Labor Day Disasters, especially with housing recovery.

- At least 70% of the program allocation must be spent on benefitting households on low to moderate incomes.
- CDBG-DR is intended to be funding of last resort.

CDBG-DR **mitigation** funds are used to help make individuals and communities more resilient to current and future disasters.

At least 15% of the allocation must be spent on mitigation activities.

**Substantial Action Plan Amendment** completed in January to expand affordable housing eligible uses, re-allocate funding, and include reimbursement.

Funds must be drawn by **February 2029** (six years after HUD-OHCS grant agreement signature).







### **CDBG-DR Timeline**





#### Sept. 2021

 Program authorized by Congress

#### Aug. 2022

 HUD approved first ReOregon Action Plan.

#### Feb. 2023

•Grant agreement signed (allows program expenditures to begin).

#### Aug. 2023

 PIER program began soliciting for projects via selection committees.

#### March 2024

•HARP became available.

#### Jan.-Feb. 2025

- •Intermediate Housing Assistance became available.
- •AHD became available (subrecipient agreements executed)
- •HUD approved Substantial Action Plan Amendment.

#### March 2025

•Legal Services Program Policy approved by HUD.

### Later in 2025

- •Housing Counseling
- •Down Payment Assistance












# **CDBG-DR Program Allocations**





Of the total funding allocation, 80.6% has been dedicated to housing recovery:

- **Housing:** \$340.5M
  - o HARP: \$165.6M
  - Housing Support Services: \$47.6M
  - o AHD: \$127.3M
- Planning, Infrastructure, and Economic Revitalization (PIER): \$45.6M (10.8%)
- **Public Services:** \$12.1M (2.9%)
  - Housing Recovery Services and Legal Services
- **Planning:** \$3M (0.7%)
- **Administration:** \$21.1M (5.0%)















# ReOregon: Planning, Infrastructure, and Economic Revitalization (PIER)

PIER funds are allocated to eligible counties for infrastructure, economic revitalization, local planning, and mitigation purposes.

Six of seven regional project selection committees have concluded, recommending 23 eligible projects whose funding makes up an estimated 71% of PIER's total funding allocation.

# **ReOregon: Affordable Housing Development (AHD)**

AHD funds are allocated to eligible counties to develop and increase affordable rental or homeownership opportunities. Subrecipients include counties, housing authorities, and nonprofits and will choose and design their programs based on need and community input.

## **ReOregon: Housing Support Services**

support.

Housing Support Services includes Intermediate Housing Assistance (IHA), Down Payment Assistance (DPA), and Housing Counseling run by local providers. IHA provides up to 24 months of rent and utility support. IHA replaces Emergency Rental Assistance support, which was offered in each county between close of WRRA and launch of IHA. Over 600 households received rent and utility support over an 18-month period.


### ReOregon: Public Services & Resilience Planning

### **Resilience Planning provides support for:**

 Regional and statewide recovery, resilience, and mitigation planning involving areas such as infrastructure, barriers to affordable housing creation, spurring economic growth, and creating jobs

### **Public Services provides funding for:**

- Legal assistance for impacted households facing barriers to recovery and;
- Disaster case management and housing navigation through outreach, support, counseling, and addressing unmet needs.









## ReOregon: HARP Updates (All Applicants)

Updated: 5/22/2025

HARP funding currently provides for purchasing a move-in ready home, replacing manufactured housing on owned or leased sites, repair of manufactured housing or site-/"stick"-built homes, reconstruction of site-/"stick"-built homes, and reimbursement, which came online this month.



### **Lessons Learned from a First-Time Grantee**

- Data sharing: Federal, state agency, and local partners
- Local implementation: Leveraging community relationships and engaging culturally specific organizations
- CDBG-DR funding comes with greater restrictions: Leverage other programs that have more flexibility to support as many impacted households as possible
- Pair Disaster Case Management (DCM) with local expertise: Allows local organizations to use resources that help them better support on-the-ground needs
- Communication and engagement: Coordinate communication and engagement strategies to share information and set clear expectations for survivors







## Lessons Learned: Disaster Recovery Plan

- Updated housing recovery workflow toward permanent housing solutions
  - Shelter and Temporary Housing (ODHS)
  - Permanent Housing (OHCS)
- Allow for survivors to continue to receive **wraparound services** throughout recovery process.
- **Streamline experience** for survivors and DCM casework with DCM services through Temporary Housing.
- DCM services close when Permanent Housing is achieved.
- Coordination, relationships, and support of long-term recovery groups,
   community action agencies, and other organizations are essential to this work.
  - Local community knowledge/expertise helps understand unique needs of individual communities.
