



GOAL

We are seeking funding to construct an ADAaccessible facility that will serve Veterans with mobility challenges in Eugene and surrounding areas.

This capital project will ensure that all Veterans regardless of physical ability—can access vital services, programs, and community support in a safe, inclusive environment.





Current Problems

Many of our local Veterans face barriers to accessing services due to mobility limitations and the lack of ADA-compliant infrastructure in our current facility.

1 in 4 Veterans in our region lives with a service-connected disability.

Our current building lacks ramps, accessible restrooms, and automatic doors.

This limits social connection, participation in programs and creates safety risks.

Project Overview



We propose the construction of a 5,000 sq. ft. ADA-compliant building that includes:

- Single Level facility on existing property
- Wheelchair-accessible entrances and hallways
- ADA-compliant restrooms and commercial kitchen facilities
- Accessible parking and drop-off zones
- A multi-purpose room for therapy, workshops, and community events

Goal: Ensure equitable access to services for all Veterans.

Objectives:

- - Complete construction by Q1 2027
- - Increase Veteran participation in programs by 40%
- - Create daily access for camaraderie
- - Host 50+ accessible events annually



Increased capacity to serve Veterans

Improved mental health and social connection through accessible programs

Increased volunteer engagement and community partnerships

Long-term cost savings through energy-efficient, modern design








Total Project Cost: \$2.1 million

- Construction: \$1,700,000
- ADA Fixtures & Equipment: \$200,000
- Permits & Professional Fees: \$100,000
- Contingency: \$100,000

Funding

- Internal Fundraising to date: \$225,000
- In-kind Contributions: \$400,000
- Private Donor Potential: \$200,000
