WHAT THE MEASURE DOES:

The measure transfers duties, functions, and powers from the State Chief Information Officer regarding the Oregon Statewide Communication Interoperability Plan to the Oregon Department of Emergency Management. It declares an emergency and takes effect on July 1, 2025.

Detailed Summary

- Transfers duties, functions, and powers from the State Chief Information Officer (CIO) relating to the Oregon Statewide Communication Interoperability Plan (OSCIP) to the Oregon Department of Emergency Management (OEM).
- Specifies this covers records, property, and employees, with the Governor resolving disputes.
- Transfers unexpended balances of amounts authorized to be expended for OSCIP and maintains any existing expenditure classifications.
- Maintains existing and pending OSCIP-related activities; liabilities, duties, and obligations; and agency rules in their transfer to OEM jurisdiction.
- Directs OEM to estimate expenses to carry out provisions of this Act each biennium, including the biennium beginning July 1, 2025, and to charge assessments to public bodies to recoup those expenses.
- Establishes the Statewide Interoperability Fund in the State Treasury, separate from the General Fund, and appropriates moneys from the Fund to OEM to carry out provisions of this Act.
- Updates OSCIP-related references in uncodified laws and resolutions, rules, documents, records, or
 proceedings of the Legislative Assembly, as well as provisions of Chapter 403 of the Oregon Revised Statutes
 regarding the State Interoperability Executive Council, to point to OEM, its director, and relevant legislative
 committees.
- Declares emergency, effective July 1, 2025.

ISSUES DISCUSSED:

EFFECT OF AMENDMENT:

The amendment directs the Oregon Department of Emergency Management (OEM) to estimate expenses to carry out provisions of this Act each biennium, including the biennium beginning July 1, 2025, and to charge assessments to public bodies to recoup those expenses. It establishes the Statewide Interoperability Fund in the State Treasury, separate from the General Fund, with moneys continuously appropriated to OEM to carry out provisions of this Act.

SB 826 A STAFF MEASURE SUMMARY

The <u>Oregon Statewide Communication Interoperability Plan</u> (OSCIP) is a multi-jurisdictional and multidisciplinary statewide plan to enhance emergency communications. A statewide communication operability plan is required by the United States Department of Homeland Security for grant funding and can often be required by other agencies as well.

The <u>State Interoperability Executive Council</u> (SIEC) is the statewide interoperability governing body which serves as the primary steering group for the OSCIP, with its duties laid out in <u>Chapter 403.455</u> of the Oregon Revised Statutes. The SIEC is to annually update and monitor implementation of the OSCIP, with the goal of achieving statewide interoperability of public safety communications systems.

Both the OSCIP and SIEC are currently under the jurisdiction of the State Chief Information Officer and are housed in Enterprise Information Services.

Senate Bill 826 A transfers responsibility of the OSCIP and SIEC to the Oregon Department of Emergency Management.
