The measure restricts the Oregon Health Authority (OHA) from sharing information obtained in an investigation of a psilocybin training program, licensee, or applicant, except as necessary to state boards or other agencies. It permits licensed health care providers to provide psilocybin in the context of other health care or behavioral health services. It requires applicants for psilocybin services licenses to submit fingerprints and permits OHA to deny applications for failure to pass a criminal background check. Declares an emergency, effective on passage.

Detailed Summary:

- Requires the Oregon Health Authority (OHA) to keep confidential information obtained in an investigation of a psilocybin training program, licensee, or applicant.
 - Permits disclosure of information to the extent necessary to state boards or agencies (including from another state), district attorneys, the Department of Justice, and law enforcement agencies.
- Specifies information that OHA must disclose when issuing a notice of intent to deny a license or permit or to impose disciplinary action.
 - Specifies exceptions.
- Prohibits Oregon Board of Licensed Professional Counselors and Therapists, Oregon Board of Naturopathic Medicine, Oregon Board of Psychology, Oregon Medical Board, Oregon State Board of Nursing, State Board of Licensed Social Workers, and State Board of Pharmacy from taking disciplinary action against a licensee for providing psilocybin services.
- Permits OHA to require fingerprints of psilocybin service applicants for the purpose of requesting a criminal records check.
- Permits OHA to deny issuance of psilocybin services license based on inability to pass a criminal records check.
- Modifies membership of Oregon Psilocybin Advisory Board, including reducing membership from 14-16 down to nine.
- Adds veteran status to information that a psilocybin service center must collect from clients.
- Adds to requirement that psilocybin products include psilocin content on label in addition to potency.

ISSUES DISCUSSED:

- Current restrictions on health care providers administering psilocybin.
- Psilocybin access protocols.
- Ownership structures of psilocybin manufacturers and service centers.

EFFECT OF AMENDMENT:

No amendment.

BACKGROUND:

HB 2387 A STAFF MEASURE SUMMARY

[Psilocybin](#) is a naturally occurring psychedelic compound found in over 200 species of mushrooms. In November 2020, Oregon voters passed Ballot Measure 109, directing the Oregon Health Authority (OHA) to license and regulate the manufacturing, transportation, delivery, sale, and purchase of psilocybin products and the provision of psilocybin services. The [Oregon Psilocybin Services Section](#) of OHA began accepting applications for licensure on January 2, 2023, and psilocybin service centers began opening in the summer of 2023. A person interested in accessing psilocybin services in Oregon meets with a [licensed facilitator](#) for a preparation session, an administration session at a [licensed service center](#), and an optional integration session.

House Bill 2387 A modifies laws governing the provision of psilocybin services in Oregon.
