Summary of Revenue Changes

Funding for the Oregon Government Ethics Commission (OGEC) comes from an assessment. 50% of the agency’s revenue comes from state agencies, and 50% comes from local and regional governments. State agencies and public universities are assessed based upon their number of full-time equivalent positions. A portion of these assessment revenues originate as General Fund. Local entities are assessed based upon a formula connected to the Municipal Audit charge collected by the Secretary of State. Additionally, the Commission collects fines and forfeitures through the imposition of civil penalties. These revenues are transferred to the General Fund and are not used to support agency operations.

Summary of General Government Subcommittee Action

The mission of OGEC is to impartially administer and enforce Oregon’s government ethics laws. Oregon Government Ethics law, Lobbying Regulation law, and the executive session provisions of Oregon Public Meetings law are within the regulatory jurisdiction of the OGEC. The Commission and its staff educate public officials and lobbyists on government ethics, lobby regulation, and executive session provisions of public meeting laws through on-line and in-person training. Over 200,000 public officials and lobbyists are subject to the Commission’s jurisdiction.

The Subcommittee recommended a budget of \$7,093,909 Other Funds. The recommended budget is a 24.5% increase from the 2023-25 legislatively approved budget and includes 15 positions (15.00 FTE). The Subcommittee recommended the following packages:

- Package 100: DOJ Fee Increases. This package increases Other Funds expenditure limitation by \$600,000 to address the increase in legal costs resulting from a higher volume of requests for advice, investigations, and opinions.
- Package 101: Position Reclassification. This package increases Other Funds expenditure limitation by \$40,710 to cover the difference in Personal Services costs resulting from the reclassification of an Operations and Policy Analyst 2 to a Policy, Planning, and Development Manager 2, as approved by the Department of Administrative Services Chief Human Resources Office. This reclassification allows the existing position to be more aligned with current duties.
- Package 102: Training Upgrades. This package increases Other Funds expenditure limitation by \$75,000 to cover costs of providing additional in-person and remote training events due to increased demand for services. Of this amount, \$42,000 is for system updates, subscriptions for software services, and online courses, and \$33,000 is for travel costs.
- Package 103: Upgrades to CMS/EFS. This package provides a one-time increase in Other Funds expenditure limitation by \$300,000 for Case Management System (CMS) and Electronic Filing System (EFS) upgrades. These upgrades will improve effectiveness of the systems, agency productivity, and ease the use of CMS/EFS for staff and the public.
- Package 801: LFO Analyst Adjustments. This package provides a one-time increase of Other Funds expenditure limitation by \$259,740 for the Case Management System and Electronic Filing System upgrades that needs to be carried forward from the 2023-25 biennium. The project was delayed due to the prioritization of system updates related to the implementation of House Bill 2038 (2023).
