WHAT THE MEASURE DOES:

The measure establishes the Legislative Performance Oversight and Government Accountability (LPOGA) Officer, selected by the Joint Legislative Audit Committee (JLAC), with the approval of the Senate President and House Speaker, to investigate, review, or conduct performance audits or evaluations of executive branch agencies, programs, or functions, and to report to the JLAC and appropriate policy and budget committees. It changes the statutory authority related to audits and audit reviews from the Legislative Fiscal Office to the LPOGA Officer and authorizes the Officer to hire necessary staff and to enter into contracts to carry out assigned functions. The measure takes effect on the 91st day following adjournment sine die, but most provisions do not become effective until January 1, 2026.

ISSUES DISCUSSED:

EFFECT OF AMENDMENT:

The amendment changes the Legislative Audit Officer to the Legislative Performance Oversight and Government Accountability Officer, and requires the approval of the President of the Senate and the Speaker of the House of Representatives for the Joint Legislative Audit Committee to appoint the Officer. It includes budget committees in the types of committees that the Officer provides information to about the audits undertaken by the Officer or the Division of Audits and makes a conforming amendment to ORS 276A.306.

BACKGROUND:

The Joint Legislative Audit Committee (JLAC) is a statutory committee consisting of the cochairs of the Joint Committee on Ways and Means (JWMs), and other members appointed by the Speaker and Senate President. The Committee is staffed by the Legislative Fiscal Office (LFO), and its statutory duties are to:

- select audit reports for its review and make recommendations to other committees;
- review requests for performance audits and related proposed legislation;
- recommend audits and audit follow-up reviews to be conducted by the Secretary of State (SOS) Audits Division;
- review audit follow-up reviews completed by legislative staff and the SOS Audits Division;
- assign related tasks to LFO, including conducting performance assessments of state agency programs and management, and reviews of agency or statewide processes; and
- review agency performance measures and make recommendations for change, when requested by JWMs.

Section 2, Article VI, of the Oregon Constitution provides that the Secretary of State, by virtue of holding the office, is the Auditor of Public Accounts. The SOS Audits Division conducts financial, performance, and information technology audits.

ORS 297.065 (2) gives the JLAC the authority to provide oversight of the conduct of performance audits and program evaluations that are outside the authority of the Secretary of State under section 2, Article VI of the Oregon Constitution, and that are conducted on state departments, boards, commissions, institutions, and state-aided institutions and agencies.

In 2024, a bipartisan workgroup of House members, the Legislative Oversight, Effectiveness, and Accountability workgroup, met 10 times to learn about existing legislative oversight tools in Oregon, engage with Oregon and national oversight experts, and develop recommendations. For audits, the workgroup discussed using and empowering the JLAC, building the legislative branch's capacity for audits, and connecting audits to the budget process and policy committees. The workgroup recommended the creation of a new audit office or officer to support the JLAC and do audits and investigations for members and the committee.
