Summary of Revenue Changes

The Oregon Advocacy Commissions Office’s (OACO) core operations are supported by General Fund. While OACO and the four commissions also benefit from Other Funds through donations, it represents a small fraction of the overall budget. Donation funds received are dedicated, by statute, to the commission to which the donation was made and must be expended in accordance with the conditions and purposes of the donation.

Summary of General Government Subcommittee Action

OACO was established in 2005, and provides coordinated administrative, research, and other support to the following four commissions: the Commission on Asian and Pacific Islander Affairs, Commission on Black Affairs, Commission on Hispanic Affairs, and Commission for Women. The Commissions serve as liaisons between minority and underrepresented communities and government entities working to establish economic, social, legal, and political equality in Oregon. OACO provides equity-focused policy research and analysis, staffs the four Commissions, coordinates the legislative advocacy of the Commissions, and manages collaborations with community stakeholders, policy makers, and formal research partners on behalf of the Commissions.

The Subcommittee recommended a budget of \$1,710,440, including \$1,685,008 General Fund and \$25,432 Other Funds expenditure limitation. The recommended budget is a 23.9% decrease from the 2023-25 legislatively approved budget and a 0.9% increase from current service level.

The decrease is primarily due to the phase-out of three limited duration positions associated with House Bill 2925 (2023). The recommended budget includes four permanent full-time positions (4.00 FTE). The Subcommittee recommended the following package:

Package 090: Analyst Adjustments. This package increases Other Funds expenditure limitation by \$14,747 to allow the Commissions to expend donations received for program support and events. This package will increase each Commission's Other Funds expenditure limitation from \$2,671 to \$6,358 per biennium.
