**Bill Title:** Relating to water.

**Measure Description**

The measure establishes new approval standards for the Water Resources Department (WRD) when reviewing certain water right transfer applications that may reduce streamflow in ways that harm fish habitat or degrade water quality. These standards apply to applications proposing changes such as moving a point of diversion upstream or relocating a point of appropriation closer to a stream where no permanent in-stream water right exists. The measure exempts applications involving municipal water use, aquatic restoration projects, and transfers proposing the use of water outside the basin of origin. The Water Resources Commission may adopt rules for review of transfer applications that share similar characteristics.

The measure updates WRD's tribal consultation process by requiring consultation upon request, with a 90-day default timeline unless extended by the applicant. The measure also allows tribes to protest preliminary determinations or orders related to water right changes. WRD is authorized to impose conditions on approved transfers to mitigate harm to tribal rights, instream habitat, or water quality, and applicants may request proportional mitigation measures in lieu of standard conditions. The measure also clarifies that in-stream leases are not subject to WRD review.

WRD and the Office of Administrative Hearings (OAH) must adopt a default hearing schedule for contested case proceedings, with a target timeline of 180 days, unless extended under specified conditions. The measure allows WRD to reimburse the Oregon Department of Fish and Wildlife (ODFW) for services rendered under voluntary agreement. WRD must report to the Joint Committee on Ways and Means by December 15, 2026, and

December 15, 2028, on water right transfer activity since January 1, 2026, including volumes, outcomes, and protest data.

**Fiscal Analysis**

The total estimated fiscal impact of the measure is \$310,986 General Fund and one permanent, full-time position (1.00 FTE) in the 2025-27 biennium, and \$310,986 General Fund in the 2027-29 biennium.

**Water Resources Department**

The fiscal impact for WRD is \$310,986 General Fund and a permanent, full-time Natural Resource Specialist 5 (1.00 FTE) in the 2025-27 biennium, and \$310,986 General Fund in the 2027-29 biennium. The measure requires WRD to conduct additional review and coordination when evaluating certain water right transfer and permit amendment applications, particularly those involving streamflow reductions or impacts to fish habitat and water quality. WRD must also implement new tribal consultation requirements, which include consulting with a tribe upon request within a 90-day period, unless an extension is granted by the applicant.

The Natural Resource Specialist 5 position would be established in the Water Rights Services Division to lead tribal consultation efforts, including negotiating and managing agreements with tribes. Additional work includes rule development, application processing, revising application materials and review guidance, developing interagency procedures with ODFW, and conducting joint training to identify sensitive stream reaches and water quality-limited streams. The additional work is absorbable within the resources of the Water Right Services division.

**Local Governments**

The fiscal impact to cities, counties, and special districts is indeterminate and will vary based on the frequency and nature of water right transfers. While not all local governments engage in such transfers, entities involved in transfers may incur increased costs related to legal review, tribal consultation, or mitigation requirements. Costs could range from minimal to significant depending on the type of water right, proposed changes, and site-specific conditions.

**Other entities**

The fiscal impact of this measure to tribes is indeterminate pending the Legislative Commission on Indian Services' receipt and review of information provided by the tribes. If additional information is provided that changes the measure's current indeterminate impact on tribes, the Legislative Fiscal Office will issue a revised fiscal impact statement. A minimal impact is anticipated for the Oregon Department of Fish and Wildlife and no fiscal impact for the Oregon Employment Department.

**Relevant Dates**

WRD must report to the Joint Committee on Ways and Means by December 15, 2026, and December 15, 2028, on water right transfer activity since January 1, 2026.

The measure takes effect on January 1, 2026.
