Summary of Revenue Changes

House Bill 2677 appropriates \$194,019 General Fund and \$5,960 Federal Funds expenditure limitation to the Oregon Youth Authority (OYA) in the 2025-27 biennium to support the anticipated increase in workload resulting from passage of the bill.

Summary of Public Safety Subcommittee Action

House Bill 2677 requires a county juvenile department to file an expunction application with the juvenile court within 90 days of an individual who turns 18 when four years have elapsed since their most recent termination, or upon receiving a request to file an application from an individual over the age of 18 as of January 1, 2026. The measure adds certain offenses that the county juvenile department is required to file for expunction, specifies in which instances a juvenile court is required to grant an expunction without a hearing, and clarifies which cases an application for expunction may not be filed.

For the 2025-27 biennium, the measure provides \$194,019 General Fund, \$5,960 Federal Funds expenditure limitation, and one permanent, full-time Administrative Specialist 1 position (0.75 FTE) to OYA to assist with locating, gathering, and preparing files for review related to the individuals and associated charges to be expunged.
