Summary of Revenue Changes

Senate Bill 163 makes a one-time appropriation of \$598,249 General Fund and increases Other Funds expenditure limitation by \$1,647,546 to the Oregon Health Authority (OHA) and increases Other Funds expenditure limitation by \$183,402 for the Department of Justice (DOJ) to implement changes made to Oregon Parentage laws. Other Funds revenues for OHA will be covered by existing fees collected by the Vital Records program and Other Funds revenues for DOJ will be covered by transfers from the Oregon Department of Human Services Child Welfare Division. Certain changes go into effect January 1, 2026, and others on January 1, 2027.

Summary of Public Safety Subcommittee Action

Senate Bill 163 incorporates updates to parentage laws based on the Uniform Parentage Act. The measure updates definitions to legal terminology, procedures related to adjudicating parentage cases, and addresses parentage carried out through assisted reproduction and surrogacy. Both agencies will need to make updates to training materials, communications, websites, and existing systems to comply with the new laws. In addition, new training will be provided to partner agencies to ensure that future casework practices align with new laws.

Oregon Health Authority

The Subcommittee recommended budget for OHA includes a one-time appropriation of \$598,249 General Fund and an increase of Other Funds expenditure limitation by \$1,647,546 to hire five positions (4.09 FTE).

Public Health

The Subcommittee's recommended budget funds three positions (2.25 FTE) in the Public Health Division and Center for Health Statistics. These positions include: one limited duration Administrative Specialist 1 (0.25 FTE) to support administrative functions related to implementing program changes, one limited duration Operations and Policy Analyst 3 (1.00 FTE) to provide project management for implementation of the required program changes, and one limited duration Program Analyst 2 (1.00 FTE) to coordinate and prepare new forms for implementing the program.

While this budget increase covers position costs, it does not cover the costs related to making changes to the Oregon Vital Events Registration System, the state's vital records and statistics electronic systems. OHA will cover those costs by utilizing Other Funds revenue generated from the Vital Records fees already in place.

Shared Services

The Subcommittee's recommended budget funds two positions (1.84 FTE). These positions include one limited duration Information Systems Specialist 8 (0.92 FTE) to oversee and coordinate changes to the vital records system and one permanent, full-time Information Systems Specialist 8 position (0.92 FTE in the 2025-27 biennium and 1.00 FTE in the 2027-29 biennium) to map new requirements to existing processes and identify system gaps.

Department of Justice

The Subcommittee recommended budget for DOJ includes an Other Funds expenditure limitation increase by \$183,402 to hire one permanent, part-time position (0.38 FTE in the 2025-27 biennium and 0.50 FTE in the 2027-29 biennium). This position, located in DOJ's Child Advocacy and Protection Division, will develop and present trainings regarding changes in parentage laws and assist partner agencies with training and revising forms, as well as supporting agencies on future cases involving child welfare and dependency issues.
