Summary of Revenue Changes

Senate Bill 968 appropriates \$114,461 to the Bureau of Labor and Industries (BOLI) for one position (0.50 FTE) to provide the resources necessary to implement and administer the bill.

Summary of Transportation and Economic Development Subcommittee Action

Senate Bill 968 authorizes public employers, in certain circumstances, to deduct overpayments from a public employee's wages, provided the overpayment occurred in the past 364. The bill requires the employer to provide notice with specific statements 10 days prior to the deduction. The deduction may not exceed 5% of the employee's gross pay each pay period. BOLI anticipates the bill will increase the number of wage claims filed with the Wage and Hour Division. The Subcommittee recommended \$114,461 General Fund for one permanent, part-time Compliance Specialist 2 position to cover the expected increase in wage and hour claims filed.
