Summary of Revenue Changes

Senate Bill 842 appropriates \$63,860 General Fund for the Oregon State Hospital (OSH) to pay increased hospital license fees for the Salem and Junction City campuses. The measure is projected to generate \$2.8 million in revenue for the Oregon Health Authority (OHA) in the 2025-27 biennium through increased licensing fees.

Summary of Capital Construction Subcommittee Action

Senate Bill 842 increases the annual license fees that hospitals pay to OHA, makes information obtained during an intake, triage, or investigation of a complaint confidential, and allows OHA to accept federal certifications and accreditations in lieu of in-person inspections if a facility provides summary documentation within a specified timeframe.

The measure is projected to generate \$2.8 million in revenue for the 2025-27 biennia. As a hospital subject to state licensing, OSH expects to pay an additional \$63,860 General Fund for the increased fees in the 2025-27 biennium, of which \$43,860 is for the Salem Campus and \$20,000 is for the Junction City Campus.
