Summary of Revenue Changes

Senate Bill 807 appropriates \$2,500,000 General Fund to the Oregon Military Department (OMD) in the 2025-27 biennium to support the recruitment and retention of members of the Oregon National Guard.

Summary of Public Safety Subcommittee Action

Senate Bill 807 makes a one-time General Fund appropriation of \$2.5 million to OMD and allows the Adjutant General to pay a bonus to a member of the Oregon National Guard who reenlists or extends their period of service for at least three years. Under the measure, OMD will establish a Retention Bonus Program (RBP) to offer eligible members a one-time bonus of \$5,000 to improve recruiting and retention within the organization. There are currently federal retention incentives available to National Guard members; however, the incentives do not apply to full-time members or those who have more than 12 years of service with the National Guard. The RBP acts to fill the gap for those National Guard members who are ineligible for federal retention incentives.

At a funding level of \$2.5 million, the program is estimated to provide funding for 500 eligible service member bonuses. OMD is able to absorb administrative costs of the program within current operations.
