## **Summary of Revenue Changes**

House Bill 3064 increases Other Funds expenditure limitation by \$1,109,179 for the Public Employees' Benefit Board (PEBB) and \$291,077 for the Oregon Educators Benefit Board (OEBB) to update health plans and provide access to perimenopause, menopause, and post-menopause services for plan holders.

## **Summary of Human Services Subcommittee Action**

House Bill 3064 expands benefits under PEBB and OEBB plans to cover access to access to perimenopause, menopause, and post-menopause services for plan holders. The measure limits coverage to prescription drugs that have been approved by the United States Food and Drug Administration. Both PEBB and OEBB plans must provide this benefit beginning January 1, 2026.

The bill includes an Other Funds expenditure limitation increase of \$1,109,179 for PEBB and \$291,077 for OEBB. The total increase is due to the estimated increase in premium costs for Providence, Moda, and Kaiser Permanente health plans offering access to the prescription drugs required under the bill.
