# Summary of Revenue Changes

For the 2025-27 biennium, House Bill 3544 appropriates \$226,420 General Fund to establish a uniform process and timeline for contested case proceedings on new water right and water right transfer applications, administered by the Water Resources Department (WRD).

## Summary of Natural Resources Subcommittee Action

The Water Resources Commission, in coordination with the Office of Administrative Hearings, is directed to adopt rules establishing uniform hearing schedules and procedural standards. These rules must include a 180-day hearing timeline, provisions for remote participation, the use of administrative law judges for settlement, and consistent timelines for determining party status. House Bill 3544 also revises the requirements for protest submissions, establishes deadlines and criteria for party status requests, limits appeals, and clarifies when contested case hearings must occur.

To fund implementation of this measure, \$226,420 General Fund is appropriated to the Department's Water Right Services Division to establish a permanent, full-time Natural Resources Specialist 4 (0.75 FTE), including position-related services and supplies for the 2025-27 biennium. This position will also be able to address the cumulative impact to the Water Right Services division from the passage of additional measures related to water right transaction processing during the 2025 legislative session.
