**Summary of Revenue Changes**

House Bill 2059 appropriates \$65,000,000 General Fund to the Oregon Health Authority (OHA) on a one-time basis and increases expenditure limitation by \$106,387 Other Funds and \$714,558 Federal Funds to establish the Residential Behavioral Health Capacity Program (RBHC).

**Summary of Human Services Subcommittee Action**

House Bill 2059 provides funding to OHA for the RBHC program. Through the program, OHA will distribute \$63.8 million in funding to behavioral health programs to fund facilities that increase the capacity of residential behavioral health services providing withdrawal management, residential treatment, and psychiatric inpatient care services.

OHA will contract with a vendor to complete annual reporting. Contract costs are estimated to cost \$200,000 total funds. To support the new program and the providers gained from this program, OHA will establish seven full-time, limited duration positions: a Public Service Representative, four Operation and Policy Analysts, a Compliance Specialist, and an Administrative Specialist.

The measure is repealed January 2, 2027.
