

## HOUSE AMENDMENTS TO HOUSE BILL 2005

By JOINT COMMITTEE ON ADDICTION AND COMMUNITY SAFETY RESPONSE

1 In line 2 of the printed bill, delete the period and insert “; creating new provisions; amending  
2 ORS 127.700, 127.736, 135.748, 161.362, 161.365, 161.370, 161.371, 166.273, 181A.290, 183.635, 197.660,  
3 197.665, 426.005, 426.060, 426.070, 426.072, 426.074, 426.075, 426.090, 426.100, 426.130, 426.133, 426.155,  
4 426.160, 426.180, 426.223, 426.225, 426.228, 426.231, 426.232, 426.233, 426.234, 426.235, 426.236, 426.237,  
5 426.238, 426.241, 426.301, 426.385 and 426.701; repealing ORS 197.670; and declaring an emergency.

6 “Whereas Oregon has a high population of individuals who report living with mental illness, and  
7 who need mental health and substance use disorder treatment; and

8 “Whereas the Oregon Legislative Assembly finds that the increase in fentanyl and metham-  
9 phetamine use has led to an increase in individuals who need a higher level of mental health and  
10 substance use disorder care; and

11 “Whereas the United States and Oregon Constitutions protect the rights of defendants in the  
12 criminal justice system and defendants must be mentally fit to proceed in their criminal cases, and  
13 if a defendant is not fit to proceed because of a mental illness, the case must be paused until the  
14 defendant is restored to fitness; and

15 “Whereas there has been a steady increase in the number of individuals in the last several years  
16 who are found not fit to proceed, or ‘unable to aid and assist’ in their own defense; and

17 “Whereas many of these individuals who are charged with a crime and determined to be unable  
18 to aid and assist in their own defense who are referred to the Oregon State Hospital for care are  
19 not admitted within seven days, as required by a federal court order; and

20 “Whereas the population of individuals admitted to the Oregon State Hospital has shifted to  
21 increasing numbers of aid and assist patients rather than guilty except for insanity and civilly  
22 committed patients; and

23 “Whereas increased demand for restoration services for defendants at the Oregon State Hospital  
24 has limited the beds available for individuals obtaining treatment through civil commitment; and

25 “Whereas ensuring the rights of defendants to timely transportation to a therapeutic setting for  
26 restoration treatment will require significant financial investments and strategic initiatives from the  
27 state; and

28 “Whereas the state must protect the rights of victims of crime and ensure improved public  
29 safety; and

30 “Whereas public safety improves when individuals can access mental health treatment and ser-  
31 vices within the criminal justice system, the Oregon State Hospital and the community; and

32 “Whereas protecting the rights of defendants while ensuring public safety requires solutions of  
33 many different types and the recognition that one idea will not solve this problem; and

34 “Whereas the three branches of Oregon’s government are committed to ongoing efforts, both in  
35 statute and in budget allocations, to solving this ongoing dilemma; and

1       “Whereas the Oregon Legislative Assembly has determined that additional treatment capacity  
2 is critical to support Oregonians in need of mental health and substance use disorder treatment and  
3 has committed increased funding to support additional treatment capacity; and

4       “Whereas it is the intention of the Oregon Legislative Assembly to increase support and ca-  
5 pacity for individuals needing mental health and substance use disorder care and treatment, and to  
6 reduce the delay in admittance experienced by defendants needing restoration services at the  
7 Oregon State Hospital; now, therefore,”.

10                                   **“CIVIL COMMITMENT**

11                               **“(Person with a Mental Illness)**

12  
13       **“SECTION 1. Sections 2 and 3 of this 2025 Act are added to and made a part of ORS**  
14 **426.070 to 426.170.**

15       **“SECTION 2. (1) A person has a mental illness and is in need of treatment for purposes**  
16 **of ORS 426.005 to 426.390 if the person is in need of treatment because the person:**

17           **“(a) Is a danger to self;**

18           **“(b) Is a danger to others;**

19           **“(c) Is unable to provide for basic personal needs; or**

20           **“(d) Has a chronic mental disorder.**

21       **“(2) A person is a danger to self for purposes of this section if, because of a mental dis-**  
22 **order:**

23           **“(a) The person engaged in or threatened to engage in behavior that resulted in or was**  
24 **likely to result in serious physical harm to self; and**

25           **“(b) Taking into consideration the person’s particular history and circumstances, it is**  
26 **reasonably foreseeable that the person will engage in such behavior in the near future, even**  
27 **if such behavior is not imminent.**

28       **“(3) A person is a danger to others for purposes of this section if, because of a mental**  
29 **disorder:**

30           **“(a) The person engaged in or threatened to engage in behavior that resulted in or was**  
31 **likely to result in physical harm to another person; and**

32           **“(b) Taking into consideration the person’s particular history and circumstances, it is**  
33 **reasonably foreseeable that the person will engage in such behavior in the near future, even**  
34 **if such behavior is not imminent.**

35       **“(4) A person is unable to provide for basic personal needs for purposes of this section**  
36 **if, because of a mental disorder:**

37           **“(a) The person is unable to provide for basic personal needs that are necessary for the**  
38 **person to avoid reasonably foreseeable serious physical harm in the near future, even if the**  
39 **serious physical harm is not imminent; and**

40           **“(b)(A) The person is not receiving such care as is necessary to avoid such harm; or**

41           **“(B) If the person is involuntarily confined in a custodial setting, it is reasonably fore-**  
42 **seeable that upon release the person will not receive such care as is necessary to avoid such**  
43 **harm.**

44       **“(5) A person has a chronic mental disorder for purposes of this section if:**

45           **“(a) The person is a person with a chronic mental illness, as defined in ORS 426.495; and**

1       “(b) Within the previous three years the person has twice been placed in a hospital or  
2 approved inpatient facility by the Oregon Health Authority under ORS 426.060.

3       “SECTION 3. (1) When determining whether a person has a mental illness and is in need  
4 of treatment, the court may consider information that assists the court in making its de-  
5 termination, including but not limited to any of the following:

6           “(a) The person’s insight into the person’s mental illness.

7           “(b) The impact of the person’s insight or lack of insight on the person’s ability to follow  
8 a recommended treatment plan.

9           “(c) The likelihood that, absent treatment, the person will become a danger to self, a  
10 danger to others or unable to provide for basic personal needs, as described in section 2 of  
11 this 2025 Act, in the near future.

12           “(d) When possible, a clinical perspective on paragraph (c) of this subsection.

13       “(2) When determining whether a person is in need of treatment because the person is  
14 a danger to self as described in section 2 of this 2025 Act, the court may consider information  
15 that assists the court in making its determination, including but not limited to any of the  
16 following:

17           “(a) The person’s recent overt acts causing or attempting to cause serious physical harm  
18 to self.

19           “(b) Recent acts placing the person in circumstances that resulted in or were likely to  
20 result in serious physical harm to self.

21           “(c)(A) The person’s recent threats to cause serious physical harm to self and the se-  
22 verity of the harm threatened;

23           “(B) Absent treatment, the likelihood of such threats being carried out; and

24           “(C) Absent treatment, the likelihood of such threats reoccurring.

25           “(d) Any past behavior and patterns of deterioration resulting from a mental disorder  
26 that contributed to prior involuntary hospitalizations for being a danger to self, how recently  
27 the past behavior occurred and the frequency and severity of the past behavior.

28       “(3) When determining whether a person is in need of treatment because the person is  
29 a danger to others as described in section 2 of this 2025 Act, the court may consider infor-  
30 mation that assists the court in making its determination, including but not limited to any  
31 of the following:

32           “(a)(A) Recent overt acts causing or attempting to cause physical harm to another per-  
33 son; and

34           “(B) The frequency and severity of such acts.

35           “(b) Recent destructive acts against property that were reasonably likely to place others  
36 at risk of physical harm.

37           “(c)(A) Recent threats to cause physical harm to another person;

38           “(B) The severity of the harm threatened;

39           “(C) Absent treatment, the likelihood of such threats being carried out; and

40           “(D) Absent treatment, the likelihood of such threats reoccurring.

41           “(d)(A) Any past behavior and patterns of deterioration resulting from a mental disorder  
42 that contributed to prior involuntary hospitalizations for being a danger to others;

43           “(B) How recently the past behavior occurred; and

44           “(C) The frequency and severity of the past behavior.

45           “(e) When possible, a clinical perspective on the person’s risk of causing physical harm

1 to another person.

2 “(4) The court may not find that a person is in need of treatment because the person has  
3 a chronic mental disorder, as described in section 2 of this 2025 Act, unless the court finds  
4 that:

5 “(a) The person is exhibiting symptoms or behavior substantially similar to those that  
6 preceded and led to one or more of the hospitalizations or inpatient placements referred to  
7 in section 2 (5)(b) of this 2025 Act; and

8 “(b) Absent treatment, the person will continue, to a reasonable medical probability, to  
9 physically or mentally deteriorate so that the person will become a danger to self, a danger  
10 to others or unable to provide for the person’s basic personal needs, as described in section  
11 2 (2) to (4) of this 2025 Act.

12 “**SECTION 4.** ORS 426.005 is amended to read:

13 “426.005. (1) As used in ORS 426.005 to 426.390, unless the context requires otherwise:

14 “(a) ‘Community mental health program director’ means the director of an entity that provides  
15 the services described in ORS 430.630 (3) to (5).

16 “(b) ‘Director of the facility’ means a superintendent of a state mental hospital, the chief of  
17 psychiatric services in a community hospital or the person in charge of treatment and rehabilitation  
18 programs at other treatment facilities.

19 “(c) ‘Facility’ means a state mental hospital, community hospital, residential facility,  
20 detoxification center, day treatment facility or such other facility as the authority determines suit-  
21 able that provides diagnosis and evaluation, medical care, detoxification, social services or rehabil-  
22 itation to persons who are in custody during a prehearing period of detention or who have been  
23 committed to the Oregon Health Authority under ORS 426.130.

24 “(d) ‘Licensed independent practitioner’ means:

25 “(A) A physician, as defined in ORS 677.010;

26 “(B) A nurse practitioner licensed under ORS 678.375 and authorized to write prescriptions un-  
27 der ORS 678.390; or

28 “(C) A naturopathic physician licensed under ORS chapter 685.

29 “(e) ‘Nonhospital facility’ means any facility, other than a hospital, that is approved by the au-  
30 thority to provide adequate security, psychiatric, nursing and other services to persons under ORS  
31 426.232 or 426.233.

32 “(f) ‘Person with mental illness’ means a person **described in section 2 (1) of this 2025 Act.**  
33 *[who, because of a mental disorder, is one or more of the following:]*

34 “*[(A) Dangerous to self or others.]*

35 “*[(B) Unable to provide for basic personal needs that are necessary to avoid serious physical harm*  
36 *in the near future, and is not receiving such care as is necessary to avoid such harm.]*

37 “*[(C) A person:]*

38 “*[(i) With a chronic mental illness, as defined in ORS 426.495;]*

39 “*[(ii) Who, within the previous three years, has twice been placed in a hospital or approved inpa-*  
40 *tient facility by the authority or the Department of Human Services under ORS 426.060;]*

41 “*[(iii) Who is exhibiting symptoms or behavior substantially similar to those that preceded and led*  
42 *to one or more of the hospitalizations or inpatient placements referred to in sub-subparagraph (ii) of*  
43 *this subparagraph; and]*

44 “*[(iv) Who, unless treated, will continue, to a reasonable medical probability, to physically or*  
45 *mentally deteriorate so that the person will become a person described under either subparagraph (A)*

1 or (B) of this paragraph or both.]

2 “(g) ‘Physical harm’ means physical injury, physical pain or other physiological impair-  
3 ment, other than an injury, pain or impairment that is trivial in terms of pain or other bodily  
4 impact.

5 “[g] (h) ‘Prehearing period of detention’ means a period of time calculated from the initiation  
6 of custody during which a person may be detained under ORS 426.228, 426.231, 426.232 or 426.233.

7 “(i) ‘Serious physical harm’ means physical injury, physical pain or other physiological  
8 impairment that places a person at risk of:

9 “(A) Death;

10 “(B) Serious and irreversible deterioration of health; or

11 “(C) Serious and irreversible deterioration of any bodily organ.

12 “(2) Whenever a community mental health program director, director of the facility, super-  
13 intendent of a state hospital or administrator of a facility is referred to, the reference includes any  
14 designee such person has designated to act on the person’s behalf in the exercise of duties.

15 “**SECTION 5.** ORS 426.130 is amended to read:

16 “426.130. (1) After hearing all of the evidence, and reviewing the findings of the examiners, the  
17 court shall determine whether, **by clear and convincing evidence**, the person has a mental illness  
18 and is in need of treatment.

19 “(2) [If, in the opinion of the court,] **If the court determines under subsection (1) of this**  
20 **section that** the person:

21 “(a) [Is a person with mental illness based upon clear and convincing evidence,] **Has a mental**  
22 **illness and is in need of treatment**, the court:

23 “(A) Shall order the release of the person and dismiss the case if:

24 “(i) The person is willing and able to participate in treatment on a voluntary basis; and

25 “(ii) The court finds that the person will probably do so.

26 “(B) May order conditional release under this subparagraph subject to the qualifications and  
27 requirements under ORS 426.125. If the court orders conditional release under this subparagraph,  
28 the court shall establish a period of commitment for the conditional release.

29 “(C) May order commitment of the person [with mental illness] to the Oregon Health Authority  
30 for treatment if, in the opinion of the court, subparagraph (A) or (B) of this paragraph is not in the  
31 best interest of the person. If the court orders commitment under this subparagraph:

32 “(i) The court shall establish a period of commitment.

33 “(ii) The authority may place the committed person in outpatient commitment under ORS  
34 426.127.

35 “(D) Shall order that the person be prohibited from purchasing or possessing a firearm if, in the  
36 opinion of the court, there is a reasonable likelihood the person [would constitute] **is** a danger to self  
37 or others, or to the community at large, as a result of the person’s mental or psychological state  
38 as demonstrated by past behavior or participation in incidents involving unlawful violence or threats  
39 of unlawful violence, or by reason of a single incident of extreme, violent, unlawful conduct. When  
40 a court makes an order under this subparagraph, the court shall cause a copy of the order to be  
41 delivered to the sheriff of the county who will enter the information into the Law Enforcement Data  
42 System.

43 “(b) [Is not a person with mental illness] **Is not a person with a mental illness who is in need**  
44 **of treatment**, the court shall release the person from custody if the person has been detained under  
45 ORS 426.070, 426.180, 426.228, 426.232 or 426.233 and:

1       “(A) Dismiss the case; or

2       “(B) Order the person to participate in assisted outpatient treatment in accordance with ORS

3 426.133. The court may continue the proceeding for no more than seven days to allow time for the

4 community mental health program director to develop the person’s assisted outpatient treatment

5 plan.

6       “[(2)] (3) A court that orders a conditional release, a commitment or assisted outpatient treat-

7 ment under this section shall establish a period of commitment or treatment for the person subject

8 to the order. Any period of commitment ordered for commitment or conditional release under this

9 section shall be for a period of time not to exceed 180 days. A period of assisted outpatient treat-

10 ment shall be for a period of time not to exceed 12 months.

11       “[(3)] (4) If the commitment proceeding was initiated under ORS 426.070 (1)(a) and if the notice

12 included a request under ORS 426.070 (2)(d)(B), the court shall notify the two persons of the court’s

13 determination under [subsection (1) of] this section.

14       “[(4)] (5) If the court finds that the person [*is a person with mental illness*] **has a mental illness**

15 **and is in need of treatment** and either orders commitment under subsection [(1)(a)(B)] (2)(a)(B)

16 or (C) of this section or enters an order under subsection [(1)(a)(D)] (2)(a)(D) of this section, the

17 court shall notify the person that the person is prohibited from purchasing or possessing a firearm

18 under state and federal law unless the person obtains relief from the prohibition from the Psychi-

19 atric Security Review Board under ORS 166.273 or under federal law.

20       “**SECTION 6.** ORS 426.070 is amended to read:

21       “426.070. (1) Any of the following may initiate commitment procedures under this section by

22 giving the notice described under subsection (2) of this section:

23       “(a) Two persons;

24       “(b) The local health officer; or

25       “(c) [Any] **A magistrate mentioned in ORS 133.030** or a judge of a court of a federally recog-

26 nized Indian tribe located in this state.

27       “(2) For purposes of subsection (1) of this section, the notice must comply with the following:

28       “(a) It must be in writing under oath;

29       “(b) It must be given to the community mental health program director or a designee of the di-

30 rector in the county where the person alleged to have a mental illness resides;

31       “(c) It must state that a person within the county other than the person giving the notice [*is a*

32 *person with*] **has a mental illness** and is in need of treatment, care or custody;

33       “(d) If the commitment proceeding is initiated by two persons under subsection (1)(a) of this

34 section, it may include a request that the court notify the two persons:

35       “(A) Of the issuance or nonissuance of a warrant under this section; or

36       “(B) Of the court’s determination under ORS 426.130 [(1)]; and

37       “(e) If the notice contains a request under paragraph (d) of this subsection, it must also include

38 the addresses of the two persons making the request.

39       “(3) Upon receipt of a notice under subsections (1) and (2) of this section or when notified by

40 a circuit court that the court received notice under ORS 426.234, the community mental health

41 program director, or designee of the director, shall:

42       “(a) Immediately notify the judge of the court having jurisdiction for that county under ORS

43 426.060 of the notification described in subsections (1) and (2) of this section.

44       “[(b) Immediately notify the Oregon Health Authority if commitment is proposed because the person

45 *appears to be a person with mental illness, as defined in ORS 426.005 (1)(f)(C). When such notice is*

1 received, the authority may verify, to the extent known by the authority, whether or not the person meets  
2 the criteria described in ORS 426.005 (1)(f)(C)(i) and (ii) and so inform the community mental health  
3 program director or designee of the director.]

4 “(b) Immediately notify the Oregon Health Authority if commitment is proposed because  
5 the person appears to be a person who is in need of treatment because of a chronic mental  
6 disorder, as described in section 2 (5) of this 2025 Act. When such notice is received, the  
7 authority may verify, to the extent known by the authority, whether or not the person meets  
8 the criteria described in section 2 (5) of this 2025 Act and so inform the community mental  
9 health program director or designee of the director.

10 “(c) Initiate an investigation under ORS 426.074 to determine whether there is probable cause  
11 to believe that the person [*is in fact a person with mental illness*] **in fact has a mental illness and**  
12 **is in need of treatment.**

13 “(4) Upon completion, a recommendation based upon the investigation report under ORS 426.074  
14 shall be promptly submitted to the court. If the community mental health program director deter-  
15 mines that probable cause does not exist to believe that a person released from detention under ORS  
16 426.234 (2)(c) or (3)(b) [*is a person with mental illness*] **has a mental illness and is in need of**  
17 **treatment**, the community mental health program director may recommend assisted outpatient  
18 treatment in accordance with ORS 426.133.

19 “(5) When the court receives notice under subsection (3) of this section:

20 “(a) If the court, following the investigation, concludes that there is probable cause to believe  
21 that the person investigated [*is a person with mental illness*] **has a mental illness and is in need**  
22 **of treatment**, it shall, through the issuance of a citation as provided in ORS 426.090, cause the  
23 person to be brought before it at a time and place as it may direct, for a hearing under ORS 426.095  
24 to determine whether the person [*is a person with mental illness*] **has a mental illness and is in**  
25 **need of treatment.** The person shall be given the opportunity to appear voluntarily at the hearing  
26 unless the person fails to appear or unless the person is detained pursuant to paragraph (b) of this  
27 subsection.

28 “(b)(A) If the court finds that there is probable cause to believe that failure to take the person  
29 into custody pending the investigation or hearing would pose serious harm or danger to the person  
30 or to others, the court may issue a warrant of detention to the community mental health program  
31 director or designee or the sheriff of the county or designee directing the director, sheriff or a  
32 designee to take the person alleged to have a mental illness into custody and produce the person  
33 at the time and place stated in the warrant.

34 “(B) At the time the person is taken into custody, the person shall be informed by the commu-  
35 nity mental health program director, the sheriff or a designee of the following:

36 “(i) The person’s rights with regard to representation by or appointment of counsel as described  
37 in ORS 426.100;

38 “(ii) The warning under ORS 426.123; and

39 “(iii) The person’s right, if the community mental health program director, sheriff or designee  
40 reasonably suspects that the person is a foreign national, to communicate with an official from the  
41 consulate of the person’s country. A community mental health program director, sheriff or designee  
42 is not civilly or criminally liable for failure to provide the information required by this sub-  
43 subparagraph. Failure to provide the information required by this sub-subparagraph does not in itself  
44 constitute grounds for the exclusion of evidence that would otherwise be admissible in a proceeding.

45 “(C) The court may make any orders for the care and custody of the person prior to the hearing

1 as it considers necessary.

2 “(c) If the notice includes a request under subsection (2)(d)(A) of this section, the court shall  
3 notify the two persons of the issuance or nonissuance of a warrant under this subsection.  
4

5 **“(Prehearing Treatment)”**  
6

7 **“SECTION 7. Section 8 of this 2025 Act is added to and made a part of ORS 426.070 to**  
8 **426.170.**

9 **“SECTION 8. (1) At any time before the conclusion of a hearing under ORS 426.095, the**  
10 **community mental health program director may offer a person alleged to have a mental ill-**  
11 **ness and to be in need of treatment a diversion from commitment as an opportunity for in-**  
12 **tensive treatment if:**

13 **“(a) The community mental health program director and a licensed independent practi-**  
14 **tioner of a hospital or nonhospital facility have probable cause to believe the person has a**  
15 **mental illness and is in need of treatment; and**

16 **“(b)(A) The hospital or nonhospital facility is approved by the Oregon Health Authority;**  
17 **and**

18 **“(B) The community mental health program director and the licensed independent prac-**  
19 **titioner agree that the hospital or nonhospital facility can provide the intensive care or**  
20 **treatment for mental illness that is necessary and sufficient to meet the emergency psychi-**  
21 **atric needs of the person.**

22 **“(2)(a) The community mental health program director shall provide notice of the offer**  
23 **of diversion from commitment:**

24 **“(A) In writing to the court having jurisdiction under ORS 426.060; and**

25 **“(B) Orally and in writing to the person alleged to have a mental illness and to be in need**  
26 **to treatment.**

27 **“(b) The notice under this subsection must include all of the following:**

28 **“(A) A written statement by the community mental health program director and the li-**  
29 **censed independent practitioner, attesting that the director and the practitioner have prob-**  
30 **able cause to believe the person has a mental illness and is in need of treatment.**

31 **“(B) A diversion treatment plan described in subsection (3) of this section.**

32 **“(C) Notice of the person’s right to request and be provided with a hearing under ORS**  
33 **426.070 to 426.170 at any time during the diversion from commitment.**

34 **“(D) Notice of the person’s rights regarding representation by or appointment of counsel.**

35 **“(E) The date and time the notice was given to the person.**

36 **“(3)(a) A licensed independent practitioner who files a statement described in subsection**  
37 **(2)(b)(A) of this section must, in consultation with the community mental health program**  
38 **director, prepare a diversion treatment plan for the person alleged to have a mental illness**  
39 **and to be in need of treatment.**

40 **“(b) The treatment plan must describe, in general terms, the types of treatment and**  
41 **medication to be provided to the person during the diversion.**

42 **“(c) The treatment plan must include, at a minimum:**

43 **“(A) A description of the medications to be administered;**

44 **“(B) The mental health interventions, therapies or diagnostic procedures to be employed;**

45 **“(C) The person’s preferences for medications and therapies;**



1       “(D) Limitations on specific medications or therapies;

2       “(E) The location of services; and

3       “(F) Other conditions or limitations for treatment the practitioner determines are rele-  
4 vant.

5       “(4) Immediately upon receipt of a notice under subsection (2) of this section, the court  
6 shall:

7       “(a) Appoint legal counsel for the person, subject to ORS 426.100; and

8       “(b) Provide notice of the offer of diversion from commitment to the person’s legal  
9 counsel.

10       “(5)(a) Not later than close of the judicial day immediately following receipt of the notice  
11 under subsection (4) of this section, the person’s legal counsel, if any, shall review with the  
12 person the notice and the contents of the treatment plan.

13       “(b) If the person, after consultation with the person’s legal counsel, if any, does not  
14 consent to the offer of diversion from commitment, the hearing required by ORS 426.070  
15 must be held no later than five judicial days following the person’s date of detention.

16       “(c) If the person, after consultation with the person’s legal counsel, if any, consents to  
17 the offer of diversion from commitment as set forth in the notice, the court shall postpone  
18 the hearing required by ORS 426.070 for 14 days from the date of consent.

19       “(6)(a) The community mental health program director may offer to extend the duration  
20 of a person’s diversion from commitment for up to 14 additional days if the criteria under  
21 subsection (1) of this section continue to be met.

22       “(b) If the person consents to the extension, the court shall postpone the hearing re-  
23 quired under ORS 426.070 by an additional 14 days from the date of the person’s consent to  
24 the extension.

25       “(c) A person consenting to an extension under this subsection may not be held without  
26 a hearing as provided in ORS 426.070 for longer than 28 days from the date the person ini-  
27 tially consented to the diversion from commitment.

28       “(7) During the period of a person’s diversion from commitment:

29       “(a) The person may not be subjected to unusual or hazardous treatment procedures,  
30 including convulsive therapy, and shall receive usual and customary treatment in accordance  
31 with medical standards in the community.

32       “(b) Except when the person expressly refuses treatment, the treating licensed inde-  
33 pendent practitioner shall treat the person within the scope of the treatment plan provided  
34 to the person with the notice of the offer of diversion from commitment.

35       “(c) If the person expressly refuses treatment:

36       “(A) The treating licensed independent practitioner shall notify the community mental  
37 health program director;

38       “(B) The community mental health program director shall immediately notify the person  
39 and the person’s legal counsel, if any, that the person’s refusal of treatment may result in  
40 the recommencement of commitment proceedings; and

41       “(C) If, after providing the person with at least one judicial day to resume treatment  
42 following receipt of the notice under subparagraph (B) of this paragraph, the community  
43 mental health program director determines that the person is likely to continue to refuse  
44 treatment, the community mental health program director may request a hearing as pro-  
45 vided in subsection (12) of this section.

1       “(d)(A) If the person is in a hospital, the licensed independent practitioner who is treat-  
2       ing the person shall discharge the person from the hospital and the community mental  
3       health program director shall transfer the person to the nonhospital facility for the re-  
4       mainder of the diversion from commitment if the community mental health program director  
5       and the treating licensed independent practitioner agree that the nonhospital facility can  
6       provide the care or treatment for mental illness that is necessary and sufficient to meet the  
7       emergency needs of the person.

8       “(B) Notwithstanding subparagraph (A) of this paragraph, the treating licensed inde-  
9       pendent practitioner shall retain the person in the hospital if, in the opinion of the treating  
10      licensed independent practitioner, the person’s condition requires the person to receive  
11      medical care or treatment in the hospital.

12      “(e) If the person is in a nonhospital facility, the community mental health program di-  
13      rector shall transfer the person to a hospital approved by the authority under the following  
14      conditions:

15      “(A) If, in the opinion of a licensed independent practitioner, the person’s condition re-  
16      quires the person to receive medical care or treatment in a hospital; and

17      “(B) The licensed independent practitioner agrees to admit the person to a hospital, ap-  
18      proved by the authority, where the licensed independent practitioner has admitting privi-  
19      leges.

20      “(f) If the person is transferred as provided in paragraph (d) or (e) of this subsection, the  
21      community mental health program director shall provide notice of the person’s location to  
22      the person’s legal counsel, if any, and the circuit court in the county where the notice under  
23      subsection (2) of this section was filed. The person may appeal the transfer as provided by  
24      rules of the authority.

25      “(8) A person may be discharged from the diversion from commitment at any time if:

26      “(a) The person is in a hospital and the licensed independent practitioner who is treating  
27      the person has:

28          “(A) Determined that the person no longer requires care in the hospital setting;

29          “(B) Informed the community mental health program director; and

30          “(C) Conferred with the person’s next of kin and, if applicable, guardian, to the extent  
31          allowed under ORS 192.567.

32      “(b) The person is in a nonhospital facility and the community mental health program  
33      director has:

34          “(A) Determined that the person no longer requires care in the nonhospital facility;

35          “(B) Conferred with the licensed independent practitioner who is treating the person; and

36          “(C) Conferred with the person’s next of kin and, if applicable, guardian, if the person  
37          consented to the consultation.

38      “(9) Immediately upon a person’s discharge from the diversion from commitment, if the  
39      person was discharged pursuant to subsection (8) of this section, the community mental  
40      health program director shall provide notice of the person’s discharge to the person’s legal  
41      counsel, if any, and the circuit court in the county in which the notice under subsection (2)  
42      of this section was initially filed.

43      “(10) The person may agree to voluntary treatment at any time during the diversion from  
44      commitment. When a person agrees to voluntary treatment under this subsection, the  
45      community mental health program director shall immediately provide notice of the person’s

1 agreement to the person's legal counsel, if any, and the circuit court in the county in which  
2 the notice under subsection (2) of this section was initially filed.

3 “(11) When the circuit court receives notification under subsection (9) or (10) of this  
4 section, the court shall dismiss the case.

5 “(12) The judge of the circuit court shall immediately commence proceedings under ORS  
6 426.070 to 426.170 when the person consenting to a diversion from commitment or the com-  
7 munity mental health program director requests a hearing. The hearing shall be held without  
8 unreasonable delay. In no case may the person be held in a hospital or nonhospital facility  
9 longer than five judicial days after the request for a hearing is made without a hearing being  
10 held under ORS 426.070 to 426.170.

11 “(13) The authority shall adopt rules for the implementation of this section.

12 “SECTION 9. ORS 426.074 is amended to read:

13 “426.074. The following is applicable to an investigation initiated by a community mental health  
14 program director, or a designee of the director, as part of commitment procedures under ORS  
15 426.070 and 426.228 to 426.235:

16 “(1) If the person alleged to have a mental illness **and to be in need of treatment** is held in  
17 custody before the hearing the investigation shall be completed at least 24 hours before the hearing  
18 under ORS 426.095, otherwise the investigation shall comply with the following time schedule:

19 “(a) If the person can be located, the investigator shall contact the person within three judicial  
20 days from the date the community mental health program director or a designee receives a notice  
21 under ORS 426.070 alleging that the person has a mental illness and is in need of treatment.

22 “(b) Within 15 days from the date the community mental health program director or a designee  
23 receives a notice under ORS 426.070, one of the following shall occur:

24 “(A) The investigation shall be completed and submitted to the court.

25 “(B) An application for extension shall be made to the court under paragraph (c) of this sub-

28 an extension of the time under paragraph (b) of this subsection only if one of the following occurs:

37 “(a) The investigation conducted should, where appropriate, include an interview or examination

40 “(b) Whether or not the person consents, the investigation should include interviews with any  
41 individuals that the investigator has probable cause to believe have pertinent information regarding

7 Records and communications described in this paragraph and related communications are not priv-  
8 ileged under ORS 40.230, 40.235, 40.240 or 40.250.

9 “(3) A copy of the investigation report shall be provided as soon as possible, but in no event  
10 later than 24 hours prior to the hearing, to the person and to the person’s counsel. Copies shall  
11 likewise be provided to counsel assisting the court, to the examiners and to the court for use in  
12 questioning witnesses.

13 “(4) **If an investigator has reasonable cause to believe that a person subject to investi-**  
14 **gation under this section has a declaration for mental health treatment as described in ORS**  
15 **127.700 to 127.737, the investigator shall:**

16 “(a) **Immediately provide the person subject to investigation and the person’s legal**  
17 **counsel, if any, with information about the process under section 15 of this 2025 Act for de-**  
18 **terminations of capacity and related timelines.**

19 “(b) **If the declaration appoints an attorney-in-fact, as defined in ORS 127.700, and the**  
20 **investigator is able to locate the attorney-in-fact:**

21 “(A) **Immediately notify the attorney-in-fact that the person subject to investigation un-**  
22 **der this section has an active investigation;**

23 “(B) **Immediately notify the attorney-in-fact that the investigator has reasonable cause**  
24 **to believe the person subject to investigation has a declaration for mental health treatment;**

25 “(C) **Immediately provide the attorney-in-fact with a notice of the person’s legal right to**  
26 **counsel and that legal counsel will be appointed by the court as provided in ORS 426.100; and**

27 “(D) **Immediately provide the attorney-in-fact with a copy of the information provided**  
28 **under paragraph (a) of this subsection.**

29 “(c)(A) **Immediately notify the court that the investigator has reasonable cause to believe**  
30 **that the person who is the subject of the investigation has executed a declaration for mental**  
31 **health treatment and provide the court with all information then available to the investi-**  
32 **gator regarding the declaration, including information regarding the factors relevant to a**  
33 **determination of incapacity as described in section 15 of this 2025 Act; and**

34 “(B) **Serve a copy of the notification and information provided to the court on:**

35 “(i) **Attorneys representing the state, as described in ORS 426.100;**

36 “(ii) **The person subject to investigation and the person’s legal counsel, if any; and**

37 “(iii) **The person’s attorney-in-fact, if any, described in paragraph (b) of this subsection.**

38 “(5) **When, after providing the court with notice under subsection (4) of this section, the**  
39 **investigator receives a judgment described in section 15 of this 2025 Act:**

40 “(a) **If the court does not determine that the person subject to investigation is incapable**  
41 **for purposes of ORS 127.700 to 127.737, the investigation shall continue as provided in sub-**  
42 **sections (1) to (3) of this section.**

43 “(b) **If the court determines that the person is incapable for purposes of ORS 127.700 to**  
44 **127.737:**

45 “(A) **The investigator shall, after consultation with the licensed independent practitioner**

1 who is treating the person, notify the court regarding whether the investigator and the li-  
2 censed independent practitioner agree that the treatment that is authorized under the dec-  
3 laration for mental health treatment is sufficient and available.

4 “(B) If the investigator and the treating licensed independent practitioner agree that the  
5 treatment that is authorized under the declaration for mental health treatment is sufficient  
6 and available, and the court agrees, the court shall release the person from the warrant of  
7 detention, if applicable, dismiss the case and provide written findings in the judgment of  
8 dismissal supporting the reasons for dismissal.

9 “(C) If the investigator and the treating licensed independent practitioner agree that the  
10 treatment that is authorized by the declaration for mental health treatment is insufficient  
11 or unavailable, or if the investigator and the treating licensed independent practitioner do  
12 not agree, the investigation shall continue as provided in subsections (1) to (3) of this section.

13 “(6) A finding of incapacity under section 15 of this 2025 Act may not be used as evidence  
14 that a person subject to investigation has a mental illness and is in need of treatment, as  
15 described in section 2 (1) of this 2025 Act. However, evidence supporting a determination of  
16 incapacity under section 15 of this 2025 Act or evidence of a declaration of mental health  
17 treatment may be considered by the court as the court deems relevant for any determi-  
18 nations made under ORS 426.005 to 426.390.

19 “**SECTION 10.** ORS 426.237 is amended to read:

20 “426.237. (1) During a prehearing period of detention as provided in ORS 426.070, 426.140,  
21 426.232 or 426.233, the community mental health program director shall *[do one of the following]*:

22 “(a) Recommend, in an investigation report as provided in ORS 426.074, that the circuit court  
23 not proceed further in the matter if the community mental health program director does not believe  
24 the person is a person with mental illness or that the person is in need of assisted outpatient  
25 treatment[.];

26 “[*(b) No later than three judicial days after initiation of a prehearing period of detention as pro-*

NOTICE TO PERSON  
MAKING A DECLARATION FOR  
MENTAL HEALTH TREATMENT

This is an important legal document. It creates a declaration for mental health treatment. Before signing this document, you should know these important facts:

This document allows you to make decisions in advance about certain types of mental health treatment: psychoactive medication, short-term (not to exceed [17 days] **the number of days you indicate above**) admission to a treatment facility, convulsive treatment and outpatient services. Outpatient services are mental health services provided by appointment by licensed professionals and programs. The instructions that you include in this declaration will be followed only if a court or two [physicians] **capacity evaluators** believe that you are incapable of making treatment decisions. Otherwise, you will be considered capable to give or withhold consent for the treatments. Your instructions may be overridden if you are being held pursuant to [civil commitment law] **a court order**.

You may also appoint a person as your representative to make treatment decisions for you if you become incapable. The person you appoint has a duty to act consistently with your desires as stated in this document or, if not stated, as otherwise known by the representative. If your representative does not know your desires, he or she must make decisions in your best interests. For the appointment to be effective, the person you appoint must accept the appointment in writing. The person also has the right to withdraw from acting as your representative at any time. A “representative” is also referred to as an “attorney-in-fact” in state law but this person does not need to be an attorney at law.

This document will continue in effect for a period of three years unless you become incapable of participating in mental health treatment decisions. If this occurs, the directive will continue in effect until you are no longer incapable.

You have the right to revoke this document in whole or in part at any time you have not been determined to be incapable. **YOU MAY NOT REVOKE THIS DECLARATION WHEN YOU ARE CONSIDERED INCAPABLE BY A COURT OR TWO [PHYSICIANS] CAPACITY EVALUATORS.** A revocation is effective when it is communicated to your attending physician or other provider.

If there is anything in this document that you do not understand, you should ask a lawyer to explain it to you. This declaration will not be valid unless it is signed by **a notary or** two qualified witnesses who are personally known to you and who are present when you sign or acknowledge your signature.

NOTICE TO PHYSICIAN OR PROVIDER

Under Oregon law, a person may use this declaration to provide consent for mental health treatment or to appoint a representative to make mental health treatment decisions when the person is incapable of making those decisions. A person is “incapable” when, in the opinion of a court or two [physicians] **capacity evaluators**, the person’s ability to receive and evaluate information ef-

1 fectively or communicate decisions is impaired to such an extent that the person currently lacks the  
2 capacity to make mental health treatment decisions. This document becomes operative when it is  
3 delivered to the person's physician or other provider and remains valid until revoked or expired.  
4 Upon being presented with this declaration, a physician or provider must make it a part of the  
5 person's medical record. When acting under authority of the declaration, a physician or provider  
6 must comply with it to the fullest extent possible. If the physician or provider is unwilling to comply  
7 with the declaration, the physician or provider may withdraw from providing treatment consistent  
8 with professional judgment and must promptly notify the person and the person's representative and  
9 document the notification in the person's medical record. A physician or provider who administers  
10 or does not administer mental health treatment according to and in good faith reliance upon the  
11 validity of this declaration is not subject to criminal prosecution, civil liability or professional dis-

39 “(b) If a request for information is made under this subsection and the person is unable to au-

41 of the presence of the person in any facility or nonhospital facility. Information shall not be provided  
42 under this paragraph if the licensed independent practitioner who is treating the person determines

44 formation is prohibited by federal law.

45 “(4) Upon the admission of any person to a facility or nonhospital facility under ORS 426.005 to

2 next of kin, or any other designee of the person, of the person's admission, unless the person re-  
3 quests that this information not be provided. The facility or nonhospital facility shall make reason-  
4 able attempts to notify the person's next of kin, or any other designee of the person, of the person's  
5 release, transfer, serious illness, injury or death upon request of the family member or designee,  
6 unless the person requests that this information not be provided. The person shall be advised by the  
7 facility or nonhospital facility that the person has the right to request that this information not be  
8 provided.

9 “(5) The person who is held in custody shall be notified by the facility or nonhospital facility  
10 that information about the person has been requested. Except as provided in subsection (3) of this  
11 section, the consent of the person who is held is required for release of information under sub-  
12 sections (3) and (4) of this section. If, when initially informed of the request for information, the  
13 person is unable to give voluntary and informed consent to authorize the release of information,  
14 notation of the attempt shall be made in the person's treatment record and daily efforts shall be  
15 made to secure the person's consent or refusal of authorization.

16 “(C) If the transfer is from a facility in one class to a facility in a more restrictive class, by  
17 following the procedures under ORS 426.275.

18 “(c) At any time, for good cause and in the best interest of the person with mental illness, the  
19 authority may transfer a person receiving emergency care and treatment under ORS 426.070 or  
20 426.228 to 426.235, or [*intensive treatment under ORS 426.237*] **diversion from commitment under**  
21 **section 8 of this 2025 Act**, between hospitals and nonhospital facilities approved by the authority  
22 to provide emergency care or treatment as defined by rule of the authority.

23 “(d) Pursuant to its rules, the authority may delegate to a community mental health program  
24 director the responsibility for assignment of persons with mental illness to suitable facilities or  
25 transfer between such facilities under conditions which the authority may define.

26 “**SECTION 20.** ORS 426.072 is amended to read:

27 “426.072. (1) A hospital or nonhospital facility must comply with provisions of subsection (2) of  
28 this section when a person alleged to have a mental illness **and to be in need of treatment** is  
29 placed in custody at the hospital or nonhospital facility:

30 “(a) By a warrant of detention under ORS 426.070;

31 “(b) By a peace officer under ORS 426.228 or other individual authorized under ORS 426.233; or

15 “(a) Inform the person of the person’s right to representation by or appointment of counsel as  
16 described in ORS 426.100;

17 “(b) Give the person the warning under ORS 426.123;

18 “(c) Immediately examine the person;

19 “(d) Set forth, in writing, the condition of the person and the need for emergency care or  
20 treatment; and

21 “(e) If the licensed independent practitioner, nurse or qualified mental health professional rea-  
22 sonably suspects that the person is a foreign national, inform the person of the person’s right to  
23 communicate with an official from the consulate of the person’s country. A licensed independent  
24 practitioner, nurse or qualified mental health professional is not civilly or criminally liable for fail-  
25 ure to provide the information required by this paragraph. Failure to provide the information re-  
26 quired by this paragraph does not in itself constitute grounds for the exclusion of evidence that  
27 would otherwise be admissible in a proceeding.

28 “(2)(a) At the time the person is admitted to or retained in a hospital under ORS 426.232, the  
29 licensed independent practitioner shall contact the community mental health program director of the  
30 county in which the person resides, if the county of residence is different from the county in which  
31 the hospital is located. The community mental health program director may request that the licensed  
32 independent practitioner notify the circuit court in the county in which the person resides. If the  
33 community mental health program director does not make the request, the licensed independent  
34 practitioner shall notify, immediately and in writing, the circuit court in the county in which the  
35 person is hospitalized.

36 “(b) At the time the person is admitted to a hospital under ORS 426.232 after being brought to  
37 the hospital by a peace officer under ORS 426.228, the licensed independent practitioner shall con-  
38 tact the community mental health program director of the county in which the person is hospital-  
39 ized. The community mental health program director of the county in which the person is  
40 hospitalized may request that the licensed independent practitioner notify the circuit court in the  
41 county in which the person is hospitalized. If the community mental health program director does  
42 not make the request, the licensed independent practitioner shall notify, immediately and in writing,  
43 the circuit court in the county in which the person was taken into custody.

44 “(c) If, at any time prior to the hearing under ORS 426.070 to [426.130] **426.170**, the licensed  
45 independent practitioner responsible for a person admitted or retained under ORS 426.232 deter-

1 mines that the person is not [*dangerous*] **a danger** to self or [*to any other person*] **others** and is not  
2 in need of emergency care or treatment for mental illness, the licensed independent practitioner may  
3 release the person from the detention authorized by ORS 426.232. The licensed independent practi-  
4 tioner shall immediately notify the circuit court notified under this subsection and the community  
5 mental health program director of the person's release from detention.

6 “(3)(a) At the time the person is admitted to or retained in a nonhospital facility under ORS  
7 426.233, the community mental health program director in the county where the person was taken  
8 into custody shall contact the community mental health program director of the county in which the  
9 person resides, if the county of residence is different from the county in which the person was taken  
10 into custody. The community mental health program director of the county in which the person re-  
11 sides may request that the community mental health program director of the county in which the  
12 person was taken into custody notify the circuit court in the county where the person resides.  
13 Otherwise, the community mental health program director of the county in which the person was  
14 taken into custody shall notify, immediately and in writing, the circuit court in the county in which  
15 the person was taken into custody.

16 “(b) If, at any time prior to the hearing under ORS 426.070 to [426.130] **426.170**, a community  
17 mental health program director, after consultation with a licensed independent practitioner, deter-  
18 mines that a person admitted or retained under ORS 426.233 is not [*dangerous*] **a danger** to self or  
19 [*to any other person*] **others** and is not in need of immediate care, custody or treatment for mental  
20 illness, the community mental health program director may release the person from detention. The  
21 community mental health program director shall immediately notify the circuit court originally no-  
22 tified under paragraph (a) of this subsection of the person's release from detention.

23 “(4) When the judge of the circuit court receives notice under subsection (2) or (3) of this sec-  
24 tion, the judge immediately shall commence proceedings under ORS 426.070 to [426.130] **426.170**. In  
25 a county having a population of 100,000 or more, and when feasible in a county with a lesser pop-  
26 ulation, the community mental health program director or designee who directs the peace officer  
27 or other authorized individual to take a person into custody under ORS 426.233 [*shall*] **may** not also

18 “426.385. (1) Every person with mental illness committed to the Oregon Health Authority shall  
19 have the right to:

20 “(a) Communicate freely in person and by reasonable access to telephones;

21 “(b) Send and receive sealed mail, except that this right may be limited for security reasons in  
22 state institutions as described in ORS 426.010;

23 “(c) Wear the clothing of the person;

24 “(d) Keep personal possessions, including toilet articles;

25 “(e) Religious freedom;

26 “(f) A private storage area with free access thereto;

27 “(g) Be furnished with a reasonable supply of writing materials and stamps;

28 “(h) A written treatment plan, kept current with the progress of the person;

29 “(i) Be represented by counsel whenever the substantial rights of the person may be affected;

30 “(j) Petition for a writ of habeas corpus;

31 “(k) Not be required to perform routine labor tasks of the facility except those essential for  
32 treatment;

33 “(L) Be given reasonable compensation for all work performed other than personal housekeeping

35 “(m) Daily access to fresh air and the outdoors, except that this right may be limited when it  
36 would create significant risk of harm to the person or others;

37 “(n) Reasonable privacy and security in resting, sleeping, dressing, bathing, personal hygiene  
38 and toileting, except that this right may be limited when it would create significant risk of harm to  
39 the person or others;

40 “(o) Such other rights as may be specified by rule; and

41 “(p) Exercise all civil rights in the same manner and with the same effect as one not admitted  
42 to the facility, including, but not limited to, the right to dispose of real property, execute instru-  
43 ments, make purchases, enter contractual relationships, and vote, unless the person has been adju-  
44 dicated incompetent and has not been restored to legal capacity. Disposal of personal property in  
45 possession of the person in a state institution described in ORS 426.010 is subject to limitation for

1 security reasons.

2 “(2)(a) A person must be immediately informed, orally and in writing, of any limitation:

3 “(A) Of the right to send or receive sealed mail under subsection (1)(b) of this section;

4 “(B) Regarding the disposal of personal property under subsection (1)(p) of this section;

5 “(C) Of the right to reasonable privacy and security in resting, sleeping, dressing, bathing, per-  
6 sonal hygiene and toileting under subsection (1)(n) of this section; and

7 “(D) Of the right to daily access to fresh air and the outdoors under subsection (1)(m) of this  
8 section.

9 “(b) Any limitation under this subsection and the reasons for the limitation must be stated in  
10 the person’s written treatment plan.

11 “(c) The person has the right to challenge any limitation under this subsection pursuant to rules  
12 adopted by the authority. The person must be informed, orally and in writing, of this right.

13 “(3) A person with mental illness committed to the authority shall have the right to be free from  
14 potentially unusual or hazardous treatment procedures, including convulsive therapy, unless the  
15 person has given express and informed consent or authorized the treatment pursuant to **a declara-**  
16 **tion for mental health treatment described in** ORS 127.700 to 127.737. This right may be denied  
17 to a person for good cause as defined in administrative rule only by the director of the facility in  
18 which the person is confined, but only after consultation with and approval of an independent ex-  
19 amining physician. Any denial shall be entered into the person’s treatment record and shall include  
20 the reasons for the denial. A person with mental illness may not be subjected to psychosurgery, as  
21 defined in ORS 677.190 (21)(b).

22 “(4) Mechanical restraints *[shall]* **may** not be applied to a person admitted to a facility unless  
23 it is determined by the chief medical officer of the facility or designee to be required by the medical  
24 needs of the person. Every use of a mechanical restraint and the reasons for using a mechanical

37 “**SECTION 37.** ORS 426.701 is amended to read:

38 “426.701. (1) For the purposes of this section and ORS 426.702:

39 “(a) A person is ‘extremely dangerous’ if the person:

40 “(A) Is at least 18 years of age;

41 “(B) Is exhibiting symptoms or behaviors of a qualifying mental disorder substantially similar  
42 to those that preceded the act described in subsection (3)(a)(C) of this section; and

43 “(C) Because of a qualifying mental disorder:

44 “(i) Presents a serious danger to the safety of other persons by reason of an extreme risk that  
45 the person will inflict grave or potentially lethal physical injury on other persons; and



1       “(ii) Unless committed, will continue to represent an extreme risk to the safety of other persons  
2 in the foreseeable future.

3       “(b) ‘Qualifying mental disorder’ does not include:

4       “(A) A disorder manifested solely by repeated criminal or otherwise antisocial conduct; or

5       “(B) A disorder constituting solely a personality disorder.

6       “(c) A qualifying mental disorder is ‘resistant to treatment’ if, after receiving care from a li-  
7 censed psychiatrist and exhausting all reasonable psychiatric treatment, or after refusing psychiatric  
8 treatment, the person continues to be significantly impaired in the person’s ability to make compe-  
9 tent decisions and to be aware of and control extremely dangerous behavior.

10       **“(d) A person ‘attempted to’ cause a result or engage in specified conduct if the person**  
11 **intentionally engaged in conduct that constituted a substantial step toward causing the re-**  
12 **sult or completing the specified conduct, and the substantial step created an actual and ex-**  
13 **treme risk of grave or potentially lethal physical injury to another person.**

14       “(2)(a) A district attorney may petition the court to initiate commitment proceedings described  
15 in this section if there is reason to believe a person is an extremely dangerous person with mental  
16 illness. Venue is proper in the county in which the person is alleged to have committed the quali-  
17 fying act or the county in which the person lives. The petition shall immediately be served upon the  
18 person.

19       “(b) If a person is committed to a state hospital under ORS 161.365 or 161.370 and the state  
20 hospital intends to discharge the person, the district attorney may provide notice to the super-  
21 intendent of the state hospital indicating an intent to file a petition under this section. Upon receipt  
22 of the notice, the superintendent may delay discharge of the person for up to seven judicial days to  
23 allow for the petition to be filed and for the court to make findings under paragraph (f) of this  
24 subsection.

25       “(c) The person shall be advised in writing of:

26       “(A) The allegation that the person is an extremely dangerous person with mental illness and  
27 may be committed to the jurisdiction of the Psychiatric Security Review Board for a maximum pe-  
28 riod of 24 months; and

29       “(B) The right to a hearing to determine whether the person is an extremely dangerous person  
30 with mental illness, unless the person consents to the commitment by waiving the right to a hearing  
31 in writing after consultation with legal counsel.

32       “(d) A person against whom a petition described in this subsection is filed shall have the fol-  
33 lowing:

34       “(A) The right to obtain suitable legal counsel possessing skills and experience commensurate  
35 with the nature of the allegations and complexity of the case and, if the person is without funds to  
36 retain legal counsel, the right to have the court appoint legal counsel;

37       “(B) The right to subpoena witnesses and to offer evidence on behalf of the person at the hear-  
38 ing;

39       “(C) The right to cross-examine any witnesses who appear at the hearing; and

40       “(D) The right to examine all reports, documents and information that the court considers, in-  
41 cluding the right to examine the reports, documents and information prior to the hearing, if avail-  
42 able.

43       “(e) Upon receipt of the petition, the court shall schedule a hearing and shall appoint an ex-  
44 aminer as described in ORS 426.110 to evaluate the person. If the person is in custody or committed  
45 while the hearing is pending, the hearing must commence within 30 days of filing the petition unless

1 good cause is found by the court. If the court finds good cause, the hearing must commence no later  
2 than 60 days after the filing of the petition or, if the district attorney provided notice under para-  
3 graph (b) of this subsection, the date of the notice, whichever occurs first. As used in this paragraph,  
4 'good cause' means:

5 "(A) The person who would be considered the victim of the act described in subsection (3)(a)(C)  
6 of this section if the act were criminally prosecuted, or an essential witness for either the state or  
7 the person, is unable to testify within the 30-day period.

8 "(B) The attorney for the person cannot reasonably be expected to participate in the hearing  
9 within the 30-day period, cannot be adequately prepared to represent the person at the hearing  
10 within the 30-day period, or has a schedule conflict that cannot be resolved in a manner that allows  
11 the attorney to represent the person at a hearing within the 30-day period.

12 "(C) An examiner cannot be appointed to conduct the examination, or conduct the examination  
13 and prepare a report, within the 30-day period.

14 "(D) If a guardian ad litem is appointed on the case, the guardian ad litem cannot be prepared  
15 for a hearing within the 30-day period.

16 "(f)(A) The court may order that the person be committed to the custody of the superintendent  
17 of a state hospital or the director of a secure mental health facility while the petition is pending if  
18 the court finds probable cause that:

19 "(i) The person is at least 18 years of age;

20 "(ii) The person has a qualifying mental disorder that is resistant to treatment;

21 "(iii) The person committed an act described in subsection (3)(a)(C) of this section; and

22 "(iv) Failure to commit the person while the hearing is pending would pose serious harm or  
23 danger to the person or others.

24 "(B) If a person committed under this paragraph is held in a secure facility other than a state  
25 hospital or secure mental health facility, including but not limited to a jail or prison, at the time  
26 the petition is filed, the court may further order that the person remain at that placement for suf-  
27 ficient time to allow the superintendent or director to safely admit the person. Any order of the  
28 court concerning the placement of a person under this subparagraph must be in accordance with the  
29 person's constitutional right to due process. If the person remains in a secure facility under this  
30 subparagraph, the superintendent, director or designee may consult with the facility to ensure con-  
31 tinuity of care for the person.

32 "(C) Commitment to the custody of the superintendent of a state hospital or the director of a  
33 secure mental health facility under this paragraph may not exceed 60 days. If the hearing does not  
34 occur within 60 days, if the district attorney dismisses the petition, or if the court holds the hearing  
35 but does not commit the person, the person shall be returned to the county in which the petition  
36 was filed and the court shall hold a disposition hearing within five judicial days to determine how  
37 to proceed on the petition and any outstanding criminal charges. A person who is returned to a  
38 secure facility other than a state hospital or secure mental health facility, including but not limited  
39 to a jail or prison, under this paragraph may remain at the placement until the disposition hearing.

40 "(g) If the hearing is not commenced within the time period required by paragraph (e) of this  
41 subsection, the court shall either dismiss the petition or release the person on personal recogni-  
42 zance, to the custody of a third party or upon any additional reasonable terms and conditions the  
43 court deems appropriate.

44 "(3)(a) At the hearing on the petition, the court shall order the person committed as an ex-  
45 tremely dangerous person with mental illness under the jurisdiction of the Psychiatric Security Re-

1 view Board for a maximum of 24 months if the court finds, by clear and convincing evidence, that:

2 “(A) The person is extremely dangerous;

3 “(B) The person suffers from a qualifying mental disorder that is resistant to treatment; and

4 “(C) Because of the qualifying mental disorder that is resistant to treatment, the person com-  
5 mitted one of the following acts:

6 “(i) Caused **or attempted to cause** the death of another person;

7 “(ii) Caused **or attempted to cause** serious physical injury to another person by means of a  
8 dangerous weapon;

9 “(iii) Caused **or attempted to cause** physical injury to another person by means of a firearm  
10 as defined in ORS 166.210 or an explosive as defined in ORS 164.055;

11 “(iv) Engaged **or attempted to engage** in oral-genital contact with a child under 14 years of  
12 age;

13 “(v) Forcibly compelled **or attempted to forcibly compel** sexual intercourse, oral-genital con-  
14 tact or the penetration of another person’s anus or vagina; or

15 “(vi) Caused **or attempted to cause** a fire or explosion that damaged, **or was reasonably**  
16 **likely to damage**, the protected property of another, as those terms are defined in ORS 164.305, or  
17 **that** placed another person in danger of physical injury, and the fire or explosion **or attempted fire**  
18 **or explosion** was not the incidental result of normal and usual daily activities.

19 “(b) The court shall further commit the person to a state hospital for custody, care and treat-  
20 ment if the court finds, by clear and convincing evidence, that the person cannot be controlled in  
21 the community with proper care, medication, supervision and treatment on conditional release.

22 “(c) The court shall specify in the order whether any person who would be considered a victim  
23 as defined in ORS 131.007 of the act described in paragraph (a)(C) of this subsection, if the act had  
24 been criminally prosecuted, requests notification of any order or hearing, conditional release, dis-  
25 charge or escape of the person committed under this section.

26 “(d) The court shall be fully advised of all drugs and other treatment known to have been ad-  
27 ministered to the alleged extremely dangerous person with mental illness that may substantially af-  
28 fect the ability of the person to prepare for, or to function effectively at, the hearing.

29 “(e) The provisions of ORS 40.230, 40.235, 40.240, 40.250 and 179.505 do not apply to the use of  
30 the examiner’s report and the court may consider the report as evidence.

31 “(4) The findings of the court that a person committed an act described in subsection (3)(a)(C)  
32 of this section may not be admitted in a criminal prosecution.

33 “(5)(a) If the court commits a person under this section and the person has pending criminal  
34 charges at the time of the hearing, the court shall dismiss the criminal charges without prejudice,  
35 and if the person is further committed to a state hospital under this section, the dismissal shall not  
36 take effect until the person’s transportation to the state hospital.

37 “(b) If the court commits a person to the state hospital under this section and:

38 “(A) The person is in a setting other than a state hospital, the court may additionally order that  
39 the person remain in that placement until the person can be safely transported to a state hospital  
40 pursuant to the order. Any order of the court concerning the placement of the person under this  
41 subparagraph must be in accordance with the person’s constitutional right to due process.

42 “(B) The person is at a state hospital at the time of the hearing, the person may remain at the  
43 state hospital under the commitment.

44 “(c) A person committed under this section shall remain under the jurisdiction of the board for  
45 a maximum of 24 months unless the board conducts a hearing and makes the findings described in

1 subsection (6)(d) of this section.

2 “(6)(a) The board shall hold a hearing six months after the initial commitment described in  
3 subsection (3) of this section, and thereafter six months after a further commitment described in ORS  
4 426.702, to determine the placement of the person and whether the person is eligible for conditional  
5 release or early discharge. The board shall provide written notice of the hearing to the person, the  
6 person’s legal counsel and the office of the district attorney who filed the initial petition under  
7 subsection (2) of this section within a reasonable time prior to the hearing. The board shall further  
8 notify the person of the following:

9 “(A) The nature of the hearing and possible outcomes;

10 “(B) The right to appear at the hearing and present evidence;

11 “(C) The right to be represented by legal counsel and, if the person is without funds to retain  
12 legal counsel, the right to have the court appoint legal counsel;

13 “(D) The right to subpoena witnesses;

14 “(E) The right to cross-examine witnesses who appear at the hearing; and

15 “(F) The right to examine all reports, documents and information that the board considers, in-  
16 cluding the right to examine the reports, documents and information prior to the hearing if avail-  
17 able.

18 “(b) If the board determines at the hearing that the person still suffers from a qualifying mental  
19 disorder that is resistant to treatment and continues to be extremely dangerous, and that the person  
20 cannot be controlled in the community with proper care, medication, supervision and treatment if  
21 conditionally released, the person shall remain committed to a state hospital.

22 “(c) If the board determines at the hearing that the person still suffers from a qualifying mental  
23 disorder that is resistant to treatment and continues to be extremely dangerous, but finds that the  
24 person can be controlled in the community with proper care, medication, supervision and treatment  
25 if conditionally released, the board shall conditionally release the person.

26 “(d) If the board determines at the hearing that the person no longer suffers from a qualifying  
27 mental disorder that is resistant to treatment or is no longer extremely dangerous, the board shall  
28 discharge the person. The discharge of a person committed under this section does not preclude  
29 commitment of the person pursuant to ORS 426.005 to 426.390.

30 “(7)(a) At any time during the commitment to a state hospital, the superintendent of the state  
31 hospital may request a hearing to determine the status of the person’s commitment under the juris-  
32 diction of the board. The request shall be accompanied by a report setting forth the facts supporting  
33 the request. If the request is for conditional release, the request shall be accompanied by a verified  
34 conditional release plan. The hearing shall be conducted as described in subsection (6) of this sec-  
35 tion.

36 “(b) The board may make the findings described in subsection (6)(c) of this section and condi-  
37 tionally release the person without a hearing if the office of the district attorney who filed the ini-  
38 tial petition under subsection (2) of this section does not object to the conditional release.

39 “(c) At any time during conditional release, a state or local mental health facility providing  
40 treatment to the person may request a hearing to determine the status of the person’s commitment  
41 under the jurisdiction of the board. The hearing shall be conducted as described in subsection (6)  
42 of this section.

43 “(8)(a) If the board orders the conditional release of a person under subsection (6)(c) of this  
44 section, the board shall order conditions of release that may include a requirement to report to any  
45 state or local mental health facility for evaluation. The board may further require cooperation with,

1 and acceptance of, psychiatric or psychological treatment from the facility. Conditions of release  
2 may be modified by the board from time to time.

3 “(b) When a person is referred to a state or local mental health facility for an evaluation under  
4 this subsection, the facility shall perform the evaluation and submit a written report of its findings  
5 to the board. If the facility finds that treatment of the person is appropriate, the facility shall in-  
6 clude its recommendations for treatment in the report to the board.

7 “(c) Whenever treatment is provided to the person by a state or local mental health facility  
8 under this subsection, the facility shall furnish reports to the board on a regular basis concerning  
9 the progress of the person.

10 “(d) Copies of all reports submitted to the board pursuant to this subsection shall be furnished  
11 to the person and to the person’s legal counsel, if applicable. The confidentiality of these reports is  
12 determined pursuant to ORS 192.338, 192.345 and 192.355.

13 “(e) The state or local mental health facility providing treatment to the person under this sub-  
14 section shall comply with the conditional release order and any modifications of the conditions or-  
15 dered by the board.

16 “(9)(a) If at any time while the person is conditionally released it appears that the person has  
17 violated the terms of the conditional release, the board may order the person returned to a state  
18 hospital for evaluation or treatment. A written order of the board is sufficient warrant for any law  
19 enforcement officer to take the person into custody. A sheriff, municipal police officer, parole or  
20 probation officer or other peace officer shall execute the order, and the person shall be returned to  
21 the state hospital as soon as practicable.

22 “(b) The director of a state or local mental health facility providing treatment to a person under  
23 subsection (8) of this section may request that the board issue a written order for a person on con-  
24 ditional release to be taken into custody if there is reason to believe that the person can no longer  
25 be controlled in the community with proper care, medication, supervision and treatment.

26 “(c) Within 30 days following the return of the person to a state hospital, the board shall con-  
27 duct a hearing to determine if, by a preponderance of the evidence, the person is no longer fit for  
28 conditional release. The board shall provide written notice of the hearing to the person, the person’s  
29 legal counsel and the office of the district attorney who filed the initial petition under subsection  
30 (2) of this section within a reasonable time prior to the hearing. The notice shall advise the person  
31 of the nature of the hearing, the right to have the court appoint legal counsel and the right to  
32 subpoena witnesses, examine documents considered by the board and cross-examine all witnesses  
33 who appear at the hearing.

34 “(10)(a) If the person had unadjudicated criminal charges at the time of the filing of the petition  
35 for the person’s initial commitment under this section and the state hospital or the state or local  
36 mental health facility providing treatment to the person intends to recommend discharge of the  
37 person at an upcoming hearing, the superintendent of the state hospital or the director of the fa-  
38 cility shall provide written notice to the board and the district attorney of the county where the  
39 criminal charges were initiated of the discharge recommendation at least 45 days before the hearing.  
40 The notice shall be accompanied by a report describing the person’s diagnosis and the treatment the  
41 person has received.

42 “(b) Upon receiving the notice described in this subsection, the district attorney may request  
43 an order from the court in the county where the criminal charges were initiated for an evaluation  
44 to determine if the person is fit to proceed in the criminal proceeding. The court may order the state  
45 hospital or the state or local mental health facility providing treatment to the person to perform the

1 evaluation. The hospital or facility shall provide copies of the evaluation to the district attorney,  
2 the person and the person's legal counsel, if applicable.

3 "(c) The person committed under this section may not waive an evaluation ordered by the court  
4 to determine if the person is fit to proceed with the criminal proceeding as described in this sub-  
5 section.

6 "(11) The board shall make reasonable efforts to notify any person described in subsection (3)(c)  
7 of this section of any order or hearing, conditional release, discharge or escape of the person com-  
8 mitted under this section.

9 "(12) Unless the court orders otherwise or either party objects, any party or witness may attend  
10 a hearing held under this section via simultaneous electronic transmission.

11 "(13) The board shall adopt rules to carry out the provisions of this section and ORS 426.702.

12 "(14) Any time limitation described in ORS 131.125 to 131.155 does not run during a commitment  
13 described in this section or a further commitment described in ORS 426.702.

#### 14 15 "TRIBAL/STATE COURT INTERSECTION 16

17 "**SECTION 38.** (1)(a) The Judicial Department shall study tribal and state interactions  
18 relating to the involuntary hospitalization and mental or behavioral health treatment of  
19 tribal members in the state civil or criminal justice systems.

20 "(b) The department shall collect the following existing data:

21 "(A) Data related to civil commitment proceedings involving members of one or more  
22 federally recognized tribes;

23 "(B) Data related to competency proceedings for criminal defendants who are members  
24 of one or more federally recognized tribes;

25 "(C) Data related to findings of guilt except for insanity for criminal defendants who are  
26 members of one or more federally recognized tribes;

27 "(D) Data related to the participation of members of one or more federally recognized  
28 tribes in specialty courts, including regarding culturally specific services provided or avail-  
29 able to those members in relation to their participation in the specialty court; and

30 "(E) Other data determined by the department to be relevant to the intersection between  
31 state and tribal mental and behavioral health judicial proceedings.

32 "(c)(A) The department shall prepare a report analyzing the data collected under this  
33 subsection. The department shall include in the report a descriptive analysis of the barriers,  
34 if any, the department encounters collecting or analyzing the data described in this sub-  
35 section.

36 "(B) Data contained in the report must be aggregated at the statewide, countywide and  
37 tribal level for each subject identified in subsection (1) of this section.

38 "(C) The report may not include personally identifiable information regarding any indi-  
39 vidual.

40 "(2)(a) The Oregon Health Authority shall assist the department in the collection of the  
41 data described in subsection (1) of this section and, to the extent permitted by state and  
42 federal law, provide the department with information the department considers necessary to  
43 conduct the study described in subsection (1) of this section.

44 "(b) Information and data collected by the department or the authority under this section  
45 may be used only for statistical purposes.

1       “(3) The department shall submit the report described in subsection (1) of this section in  
2 the manner provided by ORS 192.245, and may include recommendations for legislation, to  
3 the interim committees of the Legislative Assembly related to the judiciary and behavioral  
4 health no later than December 15, 2025.

5       “SECTION 39. (1) The Task Force on the Intersection of Tribal and State Forensic Be-  
6 havioral Health is established.

7       “(2) The task force consists of 17 members appointed as follows:

8       “(a) The Governor shall appoint four members, as follows:

9       “(A) One member who represents the office of the Governor;

10       “(B) One member who represents the Oregon Health Authority;

11       “(C) One member who represents the Department of Justice; and

12       “(D) One member who represents community mental health providers.

13       “(b) The Governor, in consultation with the Commission on Indian Services, shall appoint  
14 11 members, as follows:

15       “(A) Nine members who are tribal court judges or staff or other individuals designated  
16 by an Indian tribe, and who shall each represent one of the nine federally recognized Indian  
17 tribes located in Oregon; and

18       “(B) Two members who represent tribal service providers.

19       “(c) The Chief Justice of the Supreme Court shall appoint two members, as follows:

20       “(A) One member who is a judge with expertise in the competency to proceed process;  
21 and

22       “(B) One member who is a representative of the Tribal, State, and Federal Court Forum.

23       “(3) The task force shall examine tribal and state interactions relating to involuntary  
24 hospitalization and mental or behavioral health treatment of tribal members in the state civil  
25 and criminal systems and:

26       “(a) Identify data sharing needs between tribal service providers, tribal courts and non-  
27 tribal service providers, the Oregon Health Authority and Oregon courts, and identify  
28 methods for resolving barriers to data sharing;

29       “(b) Examine mental and behavioral health care services provided within tribal lands and  
30 to tribal members and identify barriers to providing care to tribal individuals;

31       “(c) Determine barriers to tribal members receiving care at the Oregon State Hospital  
32 pursuant to competency restoration orders or civil commitment;

33       “(d) Examine models for tribal and state interactions relating to mental or behavioral  
34 health;

35       “(e) Examine the results of the study described in section 38 of this 2025 Act; and

36       “(f) Develop recommendations concerning tribal court needs that intersect with state  
37 services and barriers to services.

38       “(4) The task force shall invite and consider perspectives involving forensic or mental  
39 health matters before tribal courts, including prosecutors, defenders, people with lived ex-  
40 perience, family members of persons with unmet behavioral needs and members of tribal  
41 governments.

42       “(5) Members of the task force who are appointed by the Chief Justice of the Supreme  
43 Court are nonvoting members and may act in an advisory capacity only.

44       “(6) Members of the task force who are tribal court judges or staff appointed under  
45 subsection (2)(b)(A) of this section shall act as liaisons between the task force and the tribal

1 government of the tribal court on which the member serves if the tribal government designates the member to act as a liaison and, if so designated, the member shall coordinate with  
2 a person designated by the relevant tribal government, if any, to facilitate inviting and considering the perspectives of tribal members and to consult with the tribal government on the  
3 activities of the task force.  
4

5  
6 “(7) A majority of the voting members of the task force constitutes a quorum for the transaction of business.  
7

8 “(8) Official action by the task force requires the approval of a majority of the voting members of the task force.  
9

10 “(9) The Governor shall select one member of the task force to serve as chairperson and another to serve as vice chairperson, for the terms and with the duties and powers necessary for the performance of the functions of the offices as the Governor determines.  
11  
12

13 “(10) If there is a vacancy for any cause, the appointing authority shall make an appointment to become immediately effective.  
14

15 “(11) The task force shall meet at times and places specified by the call of the chairperson or of a majority of the voting members of the task force.  
16

17 “(12) The task force may adopt rules necessary for the operation of the task force.

18 “(13) The task force shall submit a report in the manner provided in ORS 192.245 regarding the task force’s examinations, identifications, determinations and recommendations described in subsection (3) of this section, and may include recommendations for legislation, to the interim committees of the Legislative Assembly related to the judiciary and behavioral health no later than December 15, 2026.  
19  
20  
21  
22

23 “(14) The Judicial Department shall provide staff support to the task force.

24 “(15) Members of the task force serve as volunteers on the task force and, unless they are qualified members, as defined in ORS 292.495, are not entitled to compensation or reimbursement for expenses.  
25  
26

27 “(16) All agencies of state government, as defined in ORS 174.111, are directed to assist the task force in the performance of the duties of the task force and, to the extent permitted by laws relating to confidentiality, to furnish information and advice the members of the task force consider necessary to perform their duties.  
28  
29  
30

31 “(17) All appointments to the task force made under subsection (2) of this section must be completed on or before December 31, 2025.  
32

33 “(18) The task force shall have its first meeting on or before February 1, 2026.

34 “SECTION 40. Sections 38 and 39 of this 2025 Act are repealed on January 2, 2027.

17 “(p) Local government boundary commissions created pursuant to ORS 199.430.

18 “(q) Public universities listed in ORS 352.002.

19 “(r) Oregon Youth Authority.

20 “(s) Psychiatric Security Review Board.

21 “(t) **Oregon Health Authority, for purposes of contested case hearings involving informed**  
22 **consent at the Oregon State Hospital.**

23 “[t)] (u) Public Utility Commission.

24 “[u)] (v) State Accident Insurance Fund Corporation.

25 “[v)] (w) State Apprenticeship and Training Council.

26 “[w)] (x) State Board of Parole and Post-Prison Supervision.

27 “[x)] (y) State Land Board.

28 “[y)] (z) State Treasurer, except the State Treasurer shall use an administrative law judge for  
29 contested cases involving claims arising under ORS 98.302 to 98.436, 98.992 or 116.253 or any other  
30 claim to escheated or unclaimed property.

31 “(3) The Workers’ Compensation Board is exempt from using administrative law judges assigned  
32 from the office for any hearing conducted by the board under ORS chapters 147, 654 and 656. Except  
33 as specifically provided in this subsection, the Department of Consumer and Business Services must  
34 use administrative law judges assigned from the office only for contested cases arising out of the  
35 department’s powers and duties under:

36 “(a) ORS 86A.095 to 86A.198, 86A.990 and 86A.992 and ORS chapter 59;

37 “(b) ORS chapter 455;

38 “(c) ORS chapter 674;

39 “(d) ORS chapters 706 to 716;

40 “(e) ORS chapter 717;

41 “(f) ORS chapters 723, 725 and 726; and

42 “(g) ORS chapters 731, 732, 733, 734, 735, 737, 742, 743, 743A, 743B, 744, 746, 748 and 750.

43 “(4) Notwithstanding any other provision of law, in any proceeding in which an agency is re-  
44 quired to use an administrative law judge assigned from the office, an officer or employee of the  
45 agency may not conduct the hearing on behalf of the agency.

1 “(5) Notwithstanding any other provision of ORS 183.605 to 183.690, an agency is not required  
2 to use an administrative law judge assigned from the office if:

3 “(a) Federal law requires that a different administrative law judge or hearing officer be used;  
4 or

5 “(b) Use of an administrative law judge from the office could result in a loss of federal funds.

6 “(6) Notwithstanding any other provision of this section, the Department of Environmental  
7 Quality must use administrative law judges assigned from the office only for contested case hearings  
8 conducted under the provisions of ORS 183.413 to 183.470.

18 **“(a) ‘Authority’ means the Oregon Health Authority.**

19 **“(b) ‘Contempt charge’ means a contempt charge alleging the violation of a court order**  
20 **issued under ORS 30.866, 107.700 to 107.735, 124.005 to 124.040, 133.035, 163.730 to 163.750,**  
21 **163.760 to 163.777 or 166.525 to 166.543.**

22 **“(c) ‘Person Class A misdemeanor’ has the meaning given that term in the rules of the**  
23 **Oregon Criminal Justice Commission.**

24 **“(d) ‘Violent felony’ means a felony offense in which there was an actual or threatened**  
25 **serious physical injury to the victim, or a felony sexual offense.**

26 **“(2) When the court has determined that a defendant lacks fitness to proceed under ORS**  
27 **161.370 (2), the provisions of this section and section 45 of this 2025 Act apply**  
28 **notwithstanding any provision to the contrary in ORS 161.370 and 161.371.**

29 **“(3) Notwithstanding ORS 161.370 (4) and 161.371 (8)(a):**

30 **“(a) If the most serious offense in the charging instrument is a violation or a**  
31 **misdemeanor other than a person Class A misdemeanor, the court may not commit the de-**  
32 **fendant to the custody of the superintendent of a state mental hospital or director of a fa-**  
33 **cility designated by the authority if the defendant is at least 18 years of age, or to the**  
34 **custody of the director of a secure intensive community inpatient facility designated by the**  
35 **authority if the defendant is under 18 years of age, under any circumstances.**

36 **“(b) If the most serious offense in the charging instrument is a person Class A**  
37 **misdemeanor or a contempt charge, the maximum time period that the defendant may be**  
38 **committed to the custody of the superintendent of a state mental hospital or director of a**  
39 **facility designated by the authority if the defendant is at least 18 years of age, or to the**  
40 **custody of the director of a secure intensive community inpatient facility designated by the**  
41 **authority if the defendant is under 18 years of age, is 90 days. The time period may be ex-**  
42 **tended by the court as described in subsection (5) of this section by an additional 90 days,**  
43 **up to a total of 180 days.**

44 **“(c) If the most serious offense in the charging instrument is a felony other than ag-**  
45 **gravated murder, a violent felony or a crime listed in ORS 137.700 (2), the maximum time**

1 period that the defendant may be committed to the custody of the superintendent of a state  
2 mental hospital or director of a facility designated by the authority if the defendant is at  
3 least 18 years of age, or to the custody of the director of a secure intensive community in-  
4 patient facility designated by the authority if the defendant is under 18 years of age, is six  
5 months. The time period may be extended by the court as described in subsection (5) of this  
6 section by an additional six months, up to a total of 12 months.

7 “(d) If the most serious offense in the charging instrument is aggravated murder, a vio-  
8 lent felony or a crime listed in ORS 137.700 (2), the maximum time period that the defendant  
9 may be committed to the custody of the superintendent of a state mental hospital or director  
10 of a facility designated by the authority if the defendant is at least 18 years of age, or to the  
11 custody of the director of a secure intensive community inpatient facility designated by the  
12 authority if the defendant is under 18 years of age, is 12 months. The time period may be  
13 extended by the court as described in subsection (5) of this section by an additional six  
14 months, up to a total of 18 months.

15 “(4)(a) The superintendent of the state mental hospital or director of another facility to  
16 which a defendant is committed shall provide notice to the court and the parties that the  
17 defendant is reaching the end of the initial maximum period of commitment described in  
18 subsection (3)(b) to (d) of this section at least 60 days before the end of the period.

19 “(b) Upon the receipt by the court of a petition or other request for an extension of a  
20 maximum period of commitment under subsections (5) to (9) of this section, the defendant  
21 shall remain committed at the state mental hospital or other facility pending a decision on  
22 the request.

23 “(c) Upon reaching a decision on a request for an extension of a maximum commitment  
24 period under subsections (5) to (9) of this section, the court shall prepare a written order,  
25 and shall include in the order the reasons for granting or denying the request.

26 “(5)(a) The court may extend the initial maximum period of commitment, up to the total  
27 amounts specified in subsection (3)(b) to (d) of this section, upon the request of a party as  
28 provided in this subsection.

29 “(b) Upon receipt of the notice described in subsection (4)(a) of this section, a party may  
30 petition for an extension to the initial maximum period of commitment. If the most serious  
31 offense in the charging instrument is a felony, the petition must be filed within 30 days of  
32 receipt of the notice. If the most serious offense in the charging instrument is a  
33 misdemeanor, the petition must be filed no later than five days prior to the end of the initial  
34 maximum period of commitment.

35 “(c) Notwithstanding paragraph (b) of this subsection, if the most serious offense in the  
36 charging instrument is a misdemeanor and the evaluation and notice required under ORS  
37 161.371 (1) is submitted to the court within five days before the expiration of the initial  
38 maximum commitment period, the commitment of the defendant is automatically extended  
39 by five days to allow for the filing of a petition under this subsection.

40 “(d) The court may grant the petition and extend the initial maximum commitment pe-  
41 riod, up to the total amounts specified in subsection (3)(b) to (d) of this section, if the court  
42 finds:

43 “(A) The person continues to meet the requirements for commitment under ORS 161.370  
44 (3)(a) or (4)(a), as applicable; and

45 “(B) There is a substantial probability that continued commitment will lead to a deter-

1 mination that the defendant has gained or regained fitness to proceed within the extension

3 “(e) When making the determinations described in paragraph (d) of this subsection, the

5 “(A) Clinical data of the defendant’s progress toward gaining or regaining fitness to  
6 proceed;

7 “(B) Evidence that the defendant’s lack of fitness is not due to a condition that is un-  
8 likely to result in the defendant gaining or regaining fitness to proceed, such as a significant  
9 neurocognitive disorder or a significant neurodevelopmental disability disorder;

10 “(C) Evidence regarding the outcome of prior efforts at restoring the defendant’s fitness  
11 to proceed; and

12 “(D) Any other relevant information the court decides to consider.

13 “(f) If the court grants the petition and:

14 “(A) The most serious offense in the charging instrument is a felony, the superintendent  
15 or director must receive any order extending the commitment under this subsection prior  
16 to the expiration of the initial maximum commitment period described in subsection (3) of  
17 this section or, if the report required by ORS 161.371 (2)(a) is submitted to the court fewer  
18 than 10 days prior to the expiration of the initial maximum commitment period, no later than  
19 10 days after the receipt of the report.

20 “(B) The most serious offense in the charging instrument is a misdemeanor, the super-  
21 intendent or director must receive any order extending the commitment under this sub-  
22 section prior to the expiration of the initial maximum commitment period described in  
23 subsection (3) of this section or, if the evaluation and notice required under ORS 161.371 (1)  
24 is submitted to the court fewer than five days prior to the expiration of the initial maximum  
25 commitment period, no later than five days after the petition for the extension is filed.

26 “(6)(a) The court may extend the period of commitment by up to 30 days for the purposes  
27 of discharge planning and coordination, as provided in this subsection.

28 “(b) The superintendent of the state mental hospital, the director of the facility to which  
29 the defendant is committed, or the designee of the superintendent or director, shall provide  
30 notice to the court and to the parties if the defendant cannot be placed immediately in an  
31 identified placement after a referral has been submitted, but there is a reasonable expecta-  
32 tion that the placement will be secured within 30 days.

33 “(c) Prior to the end of the commitment period, either party, or the court on its own  
34 motion, may request an extension of the period of commitment of up to 30 days. Either party  
35 may object to the extension.

36 “(d) The court may grant the request for an extension if the court determines that the  
37 defendant cannot be placed immediately in an identified placement after a referral has been  
38 submitted, but there is a reasonable expectation that the placement will be secured within  
39 30 days.

40 “(e) The failure of the community mental health program director to coordinate dis-  
41 charge planning does not constitute justification for granting a request for an extension  
42 under this subsection.

43 “(f) An order granting a request for an extension under this subsection must be received  
44 by the superintendent of the state mental hospital, or the director of the facility to which  
45 the defendant is committed, at least five days prior to the expiration of the applicable max-

1 imum period of commitment described in subsection (3) of this section and any extensions  
2 previously authorized, or within five days of the request for an extension under this sub-  
3 section, if fewer than five days remained in the maximum commitment and extension period  
4 when the request was submitted.

5 “(g) An extension of commitment under this subsection is independent of and may be  
6 authorized in addition to any other extension authorized under this section, but when com-  
7 bined with other extensions the total period of commitment may not exceed the time period  
8 described in subsection (10)(d) of this section.

9 “(7)(a) Notwithstanding subsection (3) of this section, any maximum periods of commit-  
10 ment described in subsection (3)(b) to (d) of this section may be extended when there is evi-  
11 dence that the defendant is engaging in malingering or impression management as provided  
12 in this subsection.

13 “(b) Upon receipt of the notice described in subsection (4)(a) of this section, the district  
14 attorney may petition for an extension to the maximum period of commitment. The petition  
15 must be submitted within 30 days of receipt of the notice.

16 “(c) The court may grant the petition if the court finds that an evaluation prepared by  
17 a certified evaluator states that there is evidence that the defendant is engaging in  
18 malingering or impression management and the evaluator has determined that additional  
19 time is necessary to resolve the defendant’s clinical picture for restoration.

20 “(d) If the court grants the petition:

21 “(A) The superintendent or director must receive any order extending the commitment  
22 under this subsection prior to the expiration of the applicable maximum commitment and  
23 extension period.

24 “(B) The court shall conduct a review hearing on the status of the defendant’s fitness  
25 to proceed at least every 180 days in accordance with ORS 161.371. At each review hearing,  
26 the court may continue the commitment for an additional 180 days if the court makes the  
27 findings described in paragraph (c) of this subsection, but under no circumstances may the  
28 total commitment period, including any other extension authorized under this section, exceed  
29 the time period described subsection (10)(d) of this section.

30 “(8)(a) Notwithstanding subsection (3) of this section, if the most serious charge in the  
31 charging instrument is aggravated murder, a violent felony or a crime listed in ORS 137.700  
32 (2), any maximum period of commitment described in subsection (3)(d) of this section may  
33 be extended as provided in this subsection.

34 “(b) Upon receipt of the notice described in subsection (4)(a) of this section, the district  
35 attorney may petition for an extension to the maximum period of commitment. The petition  
36 must be submitted within 30 days of receipt of the notice.

37 “(c) The court may grant the petition if the court determines:

38 “(A) By clear and convincing evidence, that there is a danger of physical injury or sexual  
39 victimization to the victim or a member of the public if the defendant is discharged from the  
40 hospital or other facility;

41 “(B) The defendant meets the requirements for commitment described in ORS 161.370  
42 (3)(a); and

43 “(C) There is a substantial probability that continued commitment will lead to a deter-  
44 mination that the defendant has gained or regained fitness to proceed within the 180-day  
45 extension.

1       “(d) When making the determinations described in paragraph (c) of this subsection, the  
2 court shall consider:

3       “(A) Clinical data of the defendant’s progress toward gaining or regaining fitness to  
4 proceed;

5       “(B) Evidence that the defendant’s lack of fitness is not due to a condition that is un-  
6 likely to result in the defendant gaining or regaining fitness to proceed, such as a significant  
7 neurocognitive disorder or a significant neurodevelopmental disability disorder;

8       “(C) Evidence regarding the outcome of prior efforts at restoring the defendant’s fitness  
9 to proceed; and

10       “(D) Any other relevant information the court decides to consider.

11       “(e) If the court grants the petition:

12       “(A) The superintendent or director must receive any order extending the commitment  
13 under this subsection prior to the expiration of the applicable maximum commitment period  
14 described in subsection (3) of this section and any extensions previously authorized.

15       “(B) The court shall conduct a review hearing on the status of the defendant’s fitness  
16 to proceed at least every 180 days in accordance with ORS 161.371. At each review hearing,  
17 the court may continue the commitment for an additional 180 days if the court makes the  
18 determinations described in paragraph (d) of this subsection, but under no circumstances  
19 may the total commitment period, including any other extension authorized under this sec-  
20 tion, exceed 36 months.

21       “(9)(a) Upon receipt of a report filed under ORS 161.372 (1) concerning the involuntary  
22 administration of medication to the defendant, the district attorney may file a petition re-  
23 questing an extension to any maximum periods of commitment described in subsection (3)(b)  
24 to (d) of this section as provided in this section.

25       “(b) If the report filed under ORS 161.372 (1) is received within 10 days prior to the end  
26 of a maximum commitment period described in subsection (3)(b) to (d) of this section, the  
27 district attorney may file the petition within 10 days after receipt of the report, and the  
28 commitment of the defendant shall continue until the end of the 10-day time period.

29       “(c) Upon receipt of a petition described in paragraph (a) of this subsection, the court  
30 shall hold a hearing. If the court orders the involuntary administration of medication under  
31 ORS 161.372 at the hearing, the court may extend any maximum periods of commitment de-  
32 scribed in subsection (3)(b) to (d) of this section by up to 180 days. The court may renew the  
33 extension if the court finds that the criteria described in ORS 161.372 (3)(c) continue to be  
34 met.

35       “(d) The superintendent or director must receive any order extending the commitment  
36 under this subsection within 30 days of entry of the order.

37       “(e) An extension of commitment under this subsection is independent of and may be  
38 authorized in addition to any other extension authorized under this section, but when com-  
39 bined with other extensions the total period of commitment may not exceed the time limits  
40 described in subsection (10)(d) of this section.

41       “(10) Notwithstanding ORS 161.371 (8):

42       “(a) The maximum periods for commitment described in this section shall be calculated  
43 beginning on the initial day of commitment.

44       “(b) The defendant may not receive credit toward the maximum period of commitment  
45 for any day the defendant is held in jail before or after the initial date of commitment.

1       “(c) The defendant shall be given credit toward the maximum period of commitment for  
2 any day the defendant is committed to a state mental hospital or other secure residential  
3 treatment facility.

4       “(d) Under no circumstances may the total commitment period, including any extensions  
5 authorized under this section, exceed whichever of the following is shorter:

6       “(A) The statutory maximum sentence of imprisonment the court could have imposed if  
7 the defendant had been convicted of the offense; or

8       “(B) Thirty-six months.

9       “SECTION 45. (1) For purposes of this section, the purpose of community restoration is  
10 the restoration of the defendant’s fitness to proceed in order to continue the criminal case.

11       “(2)(a) If the most serious offense in the charging instrument is a violation or a  
12 misdemeanor other than a Class A misdemeanor, the maximum time period that the de-  
13 fendant may be ordered to engage in community restoration services is 90 days. The time  
14 period may be extended by the court as described in subsection (3) of this section by an ad-  
15 ditional 90 days, up to a total of 180 days.

16       “(b) If the most serious offense in the charging instrument is a Class A misdemeanor  
17 other than a person Class A misdemeanor, the maximum time period that the defendant may  
18 be ordered to engage in community restoration services is 90 days. The time period may be  
19 extended by the court as described in subsection (3) of this section by additional increments  
20 of 90 days, to up to a total of 365 days.

21       “(c) If the most serious offense in the charging instrument is a person Class A  
22 misdemeanor or a contempt charge, the maximum time period that the defendant may be  
23 ordered to engage in community restoration services is six months. The time period may be  
24 extended by the court as described in subsection (3) of this section by additional increments  
25 of six months, to up to a total of 18 months.

26       “(d) If the most serious offense in the charging instrument is a felony other than ag-  
27 gravated murder, a violent felony or a crime listed in ORS 137.700 (2), the maximum time  
28 period that the defendant may be ordered to engage in community restoration services is 12  
29 months. The time period may be extended by the court as described in subsection (3) of this  
30 section by additional increments of six months, to up to a total of 24 months.

31       “(e) If the most serious offense in the charging instrument is aggravated murder, a vio-  
32 lent felony or a crime listed in ORS 137.700 (2), the maximum time period that the defendant  
33 may be ordered to engage in community restoration services is 18 months. The time period  
34 may be extended by the court as described in subsection (3) of this section by additional in-  
35 crements of six months, to up to a total of 24 months.

36       “(3)(a) The court may extend the maximum time periods of community restoration ser-  
37 vices, up to the total amounts specified in subsection (2) this section, upon the request of a  
38 party as provided in this subsection.

39       “(b) A party may petition for an extension to the maximum period of community resto-  
40 ration described in subsection (2) of this section. The petition must be submitted at least five  
41 days prior to the expiration of the maximum period of community restoration. The court  
42 may extend the deadline for filing a petition for good cause.

43       “(c) Upon receipt of a petition described in paragraph (b) of this subsection, the court  
44 shall hold a hearing. The hearing must occur within 30 days after the filing of the petition.

45       “(d) The court may extend the community restoration period if the court finds:

1       “(A) There is clear evidence of progress toward the defendant gaining or regaining fitness  
2 to proceed; and

3       “(B) That appropriate services are being made available to the defendant.

4       “(e) The petitioning party has the burden of proof.

5       “(f) The court may continue the order for the defendant to participate in community  
6 restoration services pending the outcome of the petition.

7       “(4) The following time periods may not be considered when calculating the maximum  
8 period of community restoration services under subsection (2) of this section:

9       “(a) A period of time between a scheduled court appearance at which the defendant fails  
10 to appear and the next scheduled court appearance at which the defendant appears, other  
11 than an appearance that occurs for the purpose of addressing the failure to appear;

12       “(b) A period of time between a scheduled fitness to proceed evaluation at which the de-  
13 fendant fails to appear and the next scheduled court appearance at which the defendant ap-  
14 pears;

15       “(c) A period of time during which the defendant is in violation of a release agreement  
16 condition that the court finds negatively impacts the defendant’s ability to participate or  
17 engage in community restoration services, as determined by the court;

18       “(d) A period of time during which the defendant is in the custody of a local or state  
19 correctional facility;

20       “(e) A period of time during which the defendant fails to make reasonable efforts toward  
21 gaining or regaining fitness to proceed, as determined by the court;

22       “(f) A period of time during which the defendant is not attending or complying with  
23 community restoration services treatment, and any nonattendance is not excused, as deter-  
24 mined by the court;

25       “(g) A period of time during which the defendant is noncompliant with taking or receiv-  
26 ing, or verbally refuses to take or receive, prescribed medications, as determined by the  
27 court; and

28       “(h) A period of time between the defendant’s absconsion from a secure residential  
29 treatment facility or other secure placement and the next scheduled court appearance at  
30 which the defendant appears.

31       “(5) When a defendant has been ordered to engage in community restoration services:

32       “(a) The court shall conduct regular status reviews at least every 45 days. The status  
33 review may consist of the court reviewing a report to the court by the community mental  
34 health program director concerning the defendant’s progress. Any report provided to the  
35 court for a status review must include information concerning whether the defendant is  
36 making progress toward gaining or regaining fitness to proceed, what services that are being  
37 provided to the defendant and the identification of any additional services that are required  
38 to meet the defendant’s restoration needs.

39       “(b) The court shall conduct a review hearing at least every 180 days, or every 90 days  
40 if the most serious offense in the charging instrument is a violation, a Class B or Class C  
41 misdemeanor or a Class A misdemeanor other than a person Class A misdemeanor. At the  
42 review hearing, the court shall determine whether the purpose of community restoration is  
43 being met, and the court may take any action authorized under ORS 161.370 (2)(c) at the  
44 hearing.

45       “(c) The defendant shall be evaluated to determine whether the defendant has gained or



1 regained fitness to proceed at least every 180 days.

2 “(d) If the most serious offense in the charging instrument is a violation, a Class B or  
3 Class C misdemeanor or a Class A misdemeanor other than a person Class A misdemeanor,  
4 the court shall order that an updated evaluation, to determine whether the defendant has  
5 gained or regained fitness to proceed, be conducted and a report submitted to the court prior  
6 to the review hearing occurring 90 days after the order to engage in community restoration  
7 services is entered.

8 “(e) A community restoration services provider shall immediately notify the court fol-  
9 lowing the defendant’s noncompliance with taking or receiving, or verbal refusal to take or  
10 receive, prescribed medications, or noncompliance or unexcused absence from community  
11 restoration services treatment. The notice shall contain a description of efforts taken to  
12 engage the defendant in taking or receiving medication or attending and complying with  
13 treatment services. The community restoration services provider shall additionally notify the  
14 court if the defendant thereafter begins taking or receiving prescribed medications or at-  
15 tending and complying with treatment services.

16 “SECTION 46. (1) Upon the issuance of a court order directed to the Oregon Health Au-  
17 thority or the Oregon State Hospital, pursuant to section 44 or 45 of this 2025 Act, continuing  
18 the maximum periods of commitment or community restoration services, or continuing  
19 commitment to a state mental hospital or other facility under ORS 161.371, the authority or  
20 the hospital, by and through counsel, may file a report with the court. The report must be  
21 submitted no later than 10 days after entry of the order. The report may consist of a review  
22 of the procedural facts of the case and an analysis of those facts under any applicable federal  
23 court order or statute.

24 “(2) Upon the request of the court, the Department of Justice may appear on behalf of  
25 the authority or hospital to present the report.

26 “(3) Nothing in this section is intended to make the Oregon Health Authority or the  
27 Oregon State Hospital a party to the underlying criminal proceeding.

28 “(4) Nothing in this section requires or obligates the court to modify an order described  
29 in subsection (1) of this section.

30 “SECTION 47. (1) Sections 44 to 46 of this 2025 Act become operative on September 29,  
31 2025.

32 “(2) Section 44 of this 2025 Act applies to persons:

33 “(a) Who currently lack fitness to proceed, as previously determined by a court under  
34 ORS 161.370, on September 29, 2025; and

35 “(b) Who are determined by a court, under ORS 161.370 and section 50 of this 2025 Act,  
36 to lack fitness to proceed on or after September 29, 2025.

37 “(3) Section 45 of this 2025 Act applies to persons who are determined by a court, under  
38 ORS 161.370 and section 50 of this 2025 Act, to lack fitness to proceed on or after September  
39 29, 2025.

40 “SECTION 48. Sections 44 to 46 of this 2025 Act are repealed on January 1, 2028.

43

44 “SECTION 49. Section 50 of this 2025 Act is added to and made a part of ORS 161.355 to  
45 161.371.

1       **“SECTION 50. (1) When the defendant’s fitness to proceed is drawn in question, the issue**  
2 **shall be determined by the court. In making the determination, the court may consider:**

3       **“(a) An examination ordered under ORS 161.365 (1)(c);**

4       **“(b) Evidence of a prior diagnosis of the defendant made by a certified evaluator or a**  
5 **qualified mental health practitioner;**

6       **“(c) A prior examination or evaluation of the defendant conducted under ORS 161.309,**  
7 **161.315, 161.365, 161.370 or 161.371;**

8       **“(d) Prior judicial determinations that the defendant lacked fitness to proceed;**

9       **“(e) Prior commitments of the defendant under ORS 427.235 to 427.292 or ORS chapter**  
10 **426;**

11       **“(f) The defendant’s conduct as observed by the court;**

12       **“(g) Prior court records or assessments relating to actions involving the defendant that**  
13 **contain a mental health diagnosis of the defendant;**

14       **“(h) Relevant information on the defendant’s mental health diagnosis in the possession**  
15 **of the local supervisory authority, if the defendant is under active supervision; and**

16       **“(i) Any other information the court deems relevant.**

17       **“(2)(a) The court may hear a motion to find that the defendant is fit to proceed or lacks**  
18 **fitness to proceed from either party. The motion may be made orally or in writing.**

19       **“(b) If a motion under this subsection is uncontested, the court may make the determi-**  
20 **nation of fitness based on the motion and any supporting evidence. If the motion is con-**  
21 **tested, the moving party shall file a written motion and supporting evidence with the court,**  
22 **if a written motion has not already been filed.**

23       **“(3)(a) The court shall hold a hearing on a contested motion as soon as practicable and**  
24 **in accordance with this subsection. If either party requests, or upon the court’s own motion,**  
25 **the court shall hold a status conference to determine when the contested motion hearing**  
26 **will occur and take up any preliminary matters, including whether to order an examination**  
27 **under ORS 161.365 or to allow additional time for either party to seek an examination or**

39       **“(E) Any other factor determined to be relevant to the court.**

40       **“(4) At the hearing:**

41       **“(a) The moving party has the burden of proving that the defendant is fit to proceed or**  
42 **lacks fitness to proceed, as applicable, by a preponderance of the evidence.**

43       **“(b) Either party may call and cross-examine witnesses. Unless the court orders other-**  
44 **wise or either party objects, any party or witness may appear at the hearing by simultaneous**  
45 **electronic transmission at the hearing.**

1       “(c) ORS 40.450 to 40.475, 40.505, 40.510 and 40.515 do not apply to the following evidence,  
2 if offered for the purpose of establishing a prior diagnosis:

3       “(A) A report from an examination or evaluation of the defendant filed with the court  
4 under ORS 161.365, 161.370 or 161.371 for the same defendant from the preceding five years;  
5 or

6       “(B) Records from a civil commitment proceeding under ORS 427.235 to 427.292 or ORS  
7 chapter 426 concerning the defendant from the preceding five years.

8       “(5) Notwithstanding ORS 161.362 and 426.160, the court may enter an order allowing ei-  
9 ther party to access or use one or more reports from examinations or evaluations of the  
10 defendant filed with the court under ORS 161.365, 161.370 or 161.371 in any case concerning  
11 the defendant from the preceding five years, or records from a civil commitment proceeding  
12 under ORS 427.235 to 427.292 or ORS chapter 426 concerning the defendant from the preced-  
13 ing five years. Records disclosed under this subsection may only be used for the determi-  
14 nation of fitness to proceed.

15       “(6) After the hearing described in this subsection, the court may enter a finding that  
16 the defendant is fit to proceed or lacks fitness to proceed, or may request additional infor-  
17 mation to aid in its determination.

18       “(7) If the court determines that the defendant lacks fitness to proceed, and the court  
19 did not receive an examination or evaluation from a certified evaluator for the proceeding  
20 before the court, there is a presumption that there is a substantial probability that the de-  
21 fendant may gain or regain fitness to proceed in the foreseeable future.

22       “(8) The failure to contest any issue relating to a fitness to proceed determination under  
23 this section does not preclude either party from contesting the same issue at a later time.

24       “SECTION 51. ORS 161.365 is amended to read:

25       “161.365. (1)(a) When the court has reason to doubt the defendant’s fitness to proceed by reason  
26 of incapacity as described in ORS 161.360, the court may call any witness to assist it in reaching

4       “(K) Kidnapping in the second degree;  
5       “(L) Rape in the first degree;  
6       “(M) Sodomy in the first degree;  
7       “(N) Unlawful sexual penetration in the first degree;  
8       “(O) Robbery in the first degree; or  
9       “(P) Robbery in the second degree.  
10       “(c) If the court determines the assistance of a psychiatrist or psychologist would be helpful **to**  
11 **the court in making a determination under section 50 of this 2025 Act**, the court may:  
12       “(A) Order that a psychiatric or psychological examination of the defendant be conducted by a  
13 certified evaluator and a report of the examination be prepared; or  
14       “(B) Order the defendant to be committed for the purpose of an examination to a state mental  
15 hospital or other facility designated by the Oregon Health Authority if the defendant is at least 18  
16 years of age, or to a secure intensive community inpatient facility designated by the authority if the  
17 defendant is under 18 years of age. The state mental hospital or other facility may retain custody

2 “(5) If the examination by the certified evaluator cannot be conducted by reason of the unwill-  
3 ingness of the defendant to participate in the examination, the report must so state and must in-  
4 clude, if possible, an opinion as to whether the unwillingness of the defendant was the result of a  
5 qualifying mental disorder affecting fitness to proceed.

6 “(6) The report resulting from the examination of a defendant under this section may be filed  
7 electronically and must be filed with the clerk of the court, who shall cause copies to be delivered  
8 to the district attorney and to counsel for defendant.

9 “(7)(a) When upon motion of the court or a financially eligible defendant, the court has ordered  
10 a psychiatric or psychological examination of the defendant, a county or justice court shall order  
11 the county to pay, a municipal court shall order the city to pay, and a circuit court shall order the  
12 executive director of the Oregon Public Defense Commission to pay from funds available for the

14 “(A) A reasonable fee if the examination of the defendant is conducted by a certified evaluator

1       “**SECTION 53.** ORS 161.371 is amended to read:

2       “161.371. (1) The superintendent of a state mental hospital or director of a facility to which the  
3 defendant is committed under ORS 161.370 shall cause the defendant to be evaluated within 60 days  
4 from the defendant’s delivery into the superintendent’s or director’s custody, for the purpose of de-  
5 termining whether there is a substantial probability that, in the foreseeable future, the defendant  
6 will have fitness to proceed. In addition, the superintendent or director shall:

7       “(a) Immediately notify the committing court if the defendant, at any time, gains or regains fit-  
8 ness to proceed or if there is no substantial probability that, within the foreseeable future, the de-  
9 fendant will gain or regain fitness to proceed.

10       “(b) Within 90 days of the defendant’s delivery into the superintendent’s or director’s custody,

"(c) At either party's request, or on the court's own motion, the court may defer hearing the objection until the placement hearing described in subsection (5) of this section.

"(d) If both parties object to all proposed placements, the defendant's commitment is continued, and no further action of the court is required except as described in subsection (6) of this subsection.

"(e) If both parties indicate, prior to the expiration of the time period for filing an objection, that neither party will be filing an objection, the court shall notify the community mental health program director and proceed as described in subsection (5) of this section.

"(f) At the hearing on the objection, the court shall determine whether to grant the objection to a proposed placement. If the court:

If no proposed placement options remain following the court's decision, the commitment of the defendant is continued, and no further action of the court is required except as described in subsection (6) of this section.

"(B) Finds that a proposed placement subject to an objection is appropriate, the court shall deny the motion with respect to that placement and proceed as described in subsection (5) of this section.

"(g) At a hearing described in this subsection, the court may enter an order continuing the defendant's commitment and directing the community mental health program director to discontinue attempts to identify appropriate placements for the defendant.

"(h) A hearing described in this subsection is a critical stage of the proceeding for purposes of ORS 147.500 to 147.550.

"(5)(a) If a motion to object to a proposed placement is not filed, if the court defers hearing an objection to a proposed placement or if an appropriate placement option remains following a hearing described in subsection (4) of this section, the community mental health program director shall continue to attempt to secure all proposed placements for the defendant that were not subject to a granted objection and shall provide a placement status update, in the form of a written memo or report, to the court no less frequently than every 30 days.

"(b) As soon as the director has secured a placement for the defendant and obtained an anticipated availability date for the placement, the director shall immediately notify the court and the parties, and when possible provide information concerning the availability date and the timing of transfer to the placement.

43 “161.362. (1) A recommendation provided by a certified evaluator, pursuant to ORS 161.355 to

45 symptoms must be based upon the defendant's current diagnosis and symptomology, the defendant's

1 current ability to engage in treatment, present safety concerns relating to the defendant and any

3 the evaluator may defer to the treatment provider's recommendation regarding whether a hospital
