SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure. The statement includes a measure digest written in compliance with applicable readability standards.

Digest: The Act keeps certain provider taxes in place. (Flesch Readability Score: 71.8). Extends the assessment on earnings from health plan premiums, the assessment on payments by

Extends the assessment on earnings from health plan premiums, the assessment on payments by the Oregon Health Authority to managed care organizations, the assessment on hospitals and the Oregon Reinsurance Program. Allows the Director of the Oregon Health Authority to adopt different rates of assessment for the net inpatient revenue and net outpatient revenue of hospitals.

Extends the temporary increase in net reimbursement guaranteed to the Oregon Health and Science University for the costs of services paid for with Medicaid funds. Takes effect on the 91st day following adjournment sine die.

interests of insureds, claimants, ceding insurers, assuming insurers and the public generally. The 1 2 Legislative Assembly declares that the intent of the Legislative Assembly is to ensure adequate regulation of insurers and reinsurers and adequate protection for those to whom insurers and re-3 insurers owe obligations. In furtherance of that state interest, the Legislative Assembly mandates 4 that upon the insolvency of an alien insurer or reinsurer that provides security to fund the alien 5 insurer's or reinsurer's United States obligations in accordance with ORS 731.509, 731.510, 731.511, 6 731.512 and 731.516, the assets representing the security must be maintained in the United States 7 and claims must be filed with and valued by the state insurance commissioner with regulatory 8 9 oversight, and the assets must be distributed in accordance with the insurance laws of the state in which the trust is domiciled that are applicable to the liquidation of domestic United States insurers. 10 The Legislative Assembly declares that the laws contained in ORS 731.509, 731.510, 731.511, 731.512 11 12 and 731.516 are fundamental to the business of insurance in accordance with 15 U.S.C. 1011 and 1012. 13

(10) If the board spends less than 12 percent of its total medical expenditures in self-insured health benefit plans on payments for primary care, the board shall implement a plan for increasing the percentage of total medical expenditures spent on payments for primary care by at least one percent each year.

(11) No later than February 1 of each year, the board shall report to the Legislative Assembly on any plan implemented under subsection (10) of this section and on the board's progress toward achieving the target of spending at least 12 percent of total medical expenditures in self-insured health benefit plans on payments for primary care.
