House Bill 2018

Sponsored by Representative ELMER (at the request of Doug Riggs for Business Oregon) (Presession filed.)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced.** The statement includes a measure digest written in compliance with applicable readability standards.

Digest: This Act expands Madras' ability to use an OBDD grant. (Flesch Readability Score: 64.9). Amends the allowable uses of moneys appropriated to the Oregon Business Development Department for distribution to the City of Madras.

Declares an emergency, effective on passage.

4 Be It Enacted by the People of the State of Oregon:

21 <u>SECTION 2.</u> This 2025 Act being necessary for the immediate preservation of the public 22 peace, health and safety, an emergency is declared to exist, and this 2025 Act takes effect 23 on its passage.
