

House Bill 2048

Sponsored by Representative WRIGHT (Pre-session filed.)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**. The statement includes a measure digest written in compliance with applicable readability standards.

Digest: The Act stops OHA from licensing a food cart that does not have a separate licensed kitchen for preparing food. (Flesch Readability Score: 63.8).

Prohibits the Oregon Health Authority from issuing a license to a food cart that does not have a licensed commissary as a base of operation.

A BILL FOR AN ACT

2 Relating to food carts; amending ORS 624.320.

3 **Be It Enacted by the People of the State of Oregon:**

4 **SECTION 1.** ORS 624.320 is amended to read:

5 624.320. (1) A person may not operate a vending machine, warehouse, commissary or mobile unit
6 without first procuring a license to do so from the Oregon Health Authority. The operator shall post
7 the license in a conspicuous place in the warehouse or commissary. The operator shall affix a card,
8 emblem or other device clearly showing the name and address of the licensee and the serial number
9 of the license to each vending machine or mobile unit as the case may be.

10 (2) Application for the license shall be in writing in the form prescribed by the authority and
11 shall contain the following information:

12 (a) Name and address of the applicant.

13 (b) Location of all warehouses or commissaries.

14 (c) Locations where supplies are kept.

15 (d) Locations where vending machines or mobile units are stored, repaired or renovated.

16 (e) Identity and form of food to be dispensed through vending machines.

17 (f) Number of each type of vending machine on location.

18 (3) The operator must keep the specific locations of the vending machines and specific itiner-
19 aries of the mobile units on file at the operator's business office and readily available to the au-
20 thority. If the mobile unit is moved to a *[delegate]* county other than *[a delegate]* **the** county that
21 licensed the mobile unit, the operator shall notify the *[local health department]* **local public health**
22 **authority** for the county to which the mobile unit is moved prior to operating the mobile unit within
23 that county. The operator shall furnish the authority with written details of the conversion of any
24 vending machine to dispense products other than those for which the license was issued.

25 **(4) The authority may not issue a license to a mobile unit that does not have a licensed**
26 **commissary as a base of operation to provide food, beverage, ingredients, containers and**
27 **supplies to the mobile unit.**
