

# A-Engrossed House Bill 2092

Ordered by the House March 18

Introduced and printed pursuant to House Rule 12.00. Pre-session filed (at the request of House Interim Committee on Revenue for Representative Nancy Nathanson)

## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure. The statement includes a measure digest written in compliance with applicable readability standards.

Digest: Updates the tie date to the federal Internal Revenue Code and other federal tax laws. Becomes law 91 days from sine die. (Flesch Readability Score: 64.9).

Updates the connection date to the federal Internal Revenue Code and other provisions of federal tax law. **Temporarily disconnects from the automatic, rolling connection to updates to the federal law definition of "taxable income." Applies to tax years beginning on or after January 1, 2025, and before January 1, 2026.**

Takes effect on the 91st day following adjournment sine die.

7 **Be It Enacted by the People of the State of Oregon:**

8 **SECTION 1.** ORS 178.300, as amended by section 1, chapter 75, Oregon Laws 2024, is amended  
9 to read:

10 178.300. As used in ORS 178.300 to 178.360:

11 (1) "Account" means an individual account established in accordance with ORS 178.300 to  
12 178.360.

13 (2) "Account owner" means the person who has the right to withdraw funds from the account.  
14 The account owner may also be the designated beneficiary of the account.

15 (3) "Board" means the Oregon 529 Savings Board established under ORS 178.310.

16 (4) "Designated beneficiary" means, except as provided in ORS 178.350, the individual designated  
17 at the time the account is opened as having the right to receive a qualified withdrawal for the  
18 payment of qualified higher education expenses, or if the designated beneficiary is replaced in ac-  
19 cordance with ORS 178.350, the replacement.

20 (5) "Financial institution" means a bank, a commercial bank, a national bank, a savings bank,  
21 a savings and loan, a thrift institution, a credit union, an insurance company, a trust company, a  
22 mutual fund, an investment firm or other similar entity authorized to do business in this state.

23 (6) "Higher education institution" means an eligible education institution as defined in section  
24 529(e)(5) of the Internal Revenue Code.

25 (7) "Internal Revenue Code" means the federal Internal Revenue Code as amended and in effect

5 (10) “Nonqualified withdrawal” means a withdrawal from an account that is not a qualified  
6 withdrawal.

7 (11) “Qualified higher education expenses” means tuition and other permitted expenses as set  
8 forth in section 529(e) of the Internal Revenue Code for the enrollment or attendance of a designated  
9 beneficiary at a higher education institution, expenses associated with registered apprenticeship  
10 programs described in section 529(c)(8) of the Internal Revenue Code and amounts paid as principal  
11 or interest on a qualified education loan to the extent allowed under section 529(c)(9) of the Internal  
12 Revenue Code.

13 (12) “Qualified withdrawal” means a withdrawal made as prescribed under ORS 178.355 and  
14 made:

15 (a) From an account to pay the qualified higher education expenses of the designated benefi-  
16 ciary;

17 (b) As the result of the death or disability of the designated beneficiary;

18 (c) As the result of a scholarship, allowance or payment described in section 135(d)(1)(A), (B)  
19 or (C) of the Internal Revenue Code that is received by the designated beneficiary, but only to the  
20 extent of the amount of the scholarship, allowance or payment; or

21 (d) As a rollover or change in the designated beneficiary described in ORS 178.350.

23 Service Retirement Plan pursuant to ORS 238A.070 (2).

24 (16) "Retired member" means a pension program member who is receiving a pension as provided  
25 in ORS 238A.180 to 238A.195.

26 (17)(a) "Salary" means the remuneration paid to an active member in return for services to the  
27 participating public employer, including remuneration in the form of living quarters, board or other  
28 items of value, to the extent the remuneration is, or would be if the member were an Oregon resi-  
29 dent, includable in the employee's taxable income under Oregon law. "Salary" includes the addi-  
30 tional amounts specified in paragraph (b) of this subsection, but does not include the amounts  
31 specified in paragraph (c) of this subsection, regardless of whether those amounts are includable in  
32 taxable income.

32 relating to the determination of taxable income or loss of corporate taxpayers, with the additions,  
33 subtractions, adjustments and other modifications as are specifically prescribed by this chapter ex-  
34 cept that in determining taxable income or loss for any year, no deduction under ORS 317.476 or  
35 317.478 and section 45b, chapter 293, Oregon Laws 1987, shall be allowed. If the corporation is a  
36 corporation to which ORS 314.280 or 314.605 to 314.675 (requiring or permitting apportionment of  
37 income from transactions or activities carried on both within and without the state) applies, to  
38 derive taxable income or loss, the following shall occur:

39 (a) From the amount otherwise determined under this subsection, subtract nonapportionable in-  
40 come, or add nonapportionable loss, whichever is applicable.

2 314.625 to 314.645. The resulting figure is “taxable income or loss” for those corporations carrying  
3 on taxable transactions or activities both within and without Oregon.

4 (11) As used in ORS 317.122 and 317.650 to 317.665, “insurer” means any domestic, foreign or  
5 alien insurer as defined in ORS 731.082 and any interinsurance and reciprocal exchange and its at-  
6 torney in fact with respect to its attorney in fact net income as a corporate attorney in fact acting  
7 as attorney in compliance with ORS 731.458, 731.462, 731.466 and 731.470 for the reciprocal or  
8 interinsurance exchange. However, “insurer” does not include title insurers or health care service  
9 contractors operating pursuant to ORS 750.005 to 750.095.

10 **SECTION 28.** ORS 317.018 is amended to read:

11 317.018. It is the intent of the Legislative Assembly:

12 (1) To make the Oregon corporate excise tax law, insofar as it relates to the measurement of  
13 taxable income, identical to the provisions of the federal Internal Revenue Code, as in effect and  
14 applicable [*for the tax year of the taxpayer*] **on December 31, 2024**, to the end that taxable income  
15 of a corporation for Oregon purposes is the same as it is for federal income tax purposes, subject  
16 to Oregon’s jurisdiction to tax, and subject to the additions, subtractions, adjustments and modifi-  
17 cations contained in this chapter.

18 (2) To achieve the results desired under subsection (1) of this section by application of the var-

24 (3) To impose on each corporation doing business within this state an excise tax for the privi-  
25 lege of carrying on or doing that business measured by its federal taxable income as adjusted in this  
26 chapter.

27 **SECTION 29.** ORS 317.097, as amended by section 25, chapter 75, Oregon Laws 2024, is

29 317.097. (1) As used in this section:

30 (a) “Annual rate” means the yearly interest rate specified on the note, and not the annual per-  
31 centage rate, if any, disclosed to the applicant to comply with the federal Truth in Lending Act.

36 by the lending institution, and other charges related to the cost of obtaining credit.

39 corporation that is organized under the Oregon Nonprofit Corporation Law.

40 (e) “Limited equity cooperative” means a cooperative corporation formed under ORS chapter 62  
41 whose articles of incorporation, in addition to the other requirements of ORS chapter 62, prohibit  
42 members from selling their ownership interests:

43 (A) To any person other than a low income person; or

44 (B) For a sales price that exceeds the sum of:

45 (i) The price the member paid for the ownership interest;

1 (ii) The cost of any permanent improvements the member made to the housing unit during the  
2 member's ownership;

3 (iii) Any special assessments the member paid to the limited equity cooperative during the  
4 member's ownership that were expended to make permanent improvements to the building in which  
5 the member's housing unit is located; and

6 (iv) A return on the amounts described in sub-subparagraphs (i) to (iii) of this subparagraph,  
7 computed from the year in which the respective amount was paid, that equals the greater of the  
8 result of adjusting each amount by the percentage increase, if any, in the Consumer Price Index for  
9 All Urban Consumers, West Region (All Items), as published by the Bureau of Labor Statistics of the  
10 United States Department of Labor, or of increasing each amount by three percent compounded  
11 annually.

12 (f) "Manufactured dwelling park" has the meaning given that term in ORS 446.003.

13 (g) "Nonprofit corporation" means a corporation that is exempt from income taxes under section  
14 501(c)(3) or (4) of the Internal Revenue Code as amended and in effect on December 31, [2023]  
15 **2024.**

16 (h) "Preservation project" means housing that was previously developed as affordable housing  
17 with a contract for rent assistance from the United States Department of Housing and Urban De-  
18 velopment or the United States Department of Agriculture and that is being acquired by a spon-  
19 soring entity.

20 (i) "Qualified assignee" means any investor participating in the secondary market for real estate  
21 loans.

22 (j) "Qualified borrower" means any borrower that is a sponsoring entity that has a controlling  
23 interest in the real property that is financed by a qualified loan. A controlling interest includes a  
24 controlling interest in the general partner of a limited partnership that owns the real property.

25 (k) "Qualified loan" means:

26 (A) A loan that meets the criteria stated in subsection (5) of this section or that is made to re-  
27 finance a loan that meets the criteria described in subsection (5) of this section; or

28 (B) The purchase by a lending institution of bonds, the proceeds of which are used to finance  
29 or refinance a loan that meets the criteria described in subsection (5) of this section.

30 (L) "Sponsoring entity" means a nonprofit corporation, nonprofit cooperative, state govern-  
31 mental entity, local unit of government as defined in ORS 466.706, housing authority or any other  
32 person, provided that the person has agreed to restrictive covenants imposed by a nonprofit corpo-  
33 ration, nonprofit cooperative, state governmental entity, local unit of government or housing au-  
34 thority.

35 (2) The Department of Revenue shall allow a credit against taxes otherwise due under this  
36 chapter for the tax year to a lending institution that makes a qualified loan certified by the Housing

15 and Community Services Department must execute a written certification for the qualified loan that:

37 (L) Manufactured dwelling park nonprofit cooperatives organized under ORS chapter 62.

38 (5) "Financial institution" has the meaning given that term in ORS 314.610, except that "finan-  
39 cial institution" does not include a credit union.

40 (6)(a) "FR Y-9" means the consolidated or parent-only financial statements that a holding com-  
41 pany is required to file with the Federal Reserve Board pursuant to 12 U.S.C. 1844.

42 (b) In the case of a holding company required to file both consolidated and parent-only financial  
43 statements, "FR Y-9" means the consolidated financial statements that the holding company is re-  
44 quired to file.

45 (7) "Governmental entity" means:

- 1 (a) The United States and any of its unincorporated agencies and instrumentalities.

8 of this subsection, any reference to the laws of the United States or to the Internal Revenue Code  
9 means the laws of the United States relating to income taxes or the Internal Revenue Code as they  
10 are amended on or before December 31, 2024, even when the amendments take effect or become  
11 operative after that date, except where the Legislative Assembly has specifically provided otherwise.

12 (3) Insofar as is practicable in the administration of this chapter, the department shall apply and  
13 follow the administrative and judicial interpretations of the federal income tax law. When a pro-  
14 vision of the federal income tax law is the subject of conflicting opinions by two or more federal  
15 courts, the department shall follow the rule observed by the United States Commissioner of Internal  
16 Revenue until the conflict is resolved. Nothing contained in this section limits the right or duty of  
17 the department to audit the return of any taxpayer or to determine any fact relating to the tax li-  
18 ability of any taxpayer.

19 (4) When portions of the Internal Revenue Code incorporated by reference as provided in sub-  
20 section (2) of this section refer to rules or regulations prescribed by the Secretary of the Treasury,  
21 then such rules or regulations shall be regarded as rules adopted by the department under and in

23 (5)(a) When portions of the Internal Revenue Code incorporated by reference as provided in  
24 subsection (2) of this section are later corrected by an Act or a Title within an Act of the United  
25 States Congress designated as an Act or Title making technical corrections, then notwithstanding  
26 the date that the Act or Title becomes law, those portions of the Internal Revenue Code, as so  
27 corrected, shall be the portions of the Internal Revenue Code incorporated by reference as provided  
28 in subsection (2) of this section and shall take effect, unless otherwise indicated by the Act or Title  
29 (in which case the provisions shall take effect as indicated in the Act or Title), as if originally in-  
30 cluded in the provisions of the Act being technically corrected. If, on account of this subsection, any  
31 adjustment is required to an Oregon return that would otherwise be prevented by operation of law  
32 or rule, the adjustment shall be made, notwithstanding any law or rule to the contrary, in the  
33 manner provided under ORS 314.135.

34 (b) As used in this subsection, "Act or Title" includes any subtitle, division or other part of an  
35 Act or Title.

36 **SECTION 35.** ORS 316.012, as amended by section 21, chapter 75, Oregon Laws 2024, and sec-  
37 tion 23 of this 2025 Act, is amended to read:

38 316.012. Any term used in this chapter has the same meaning as when used in a comparable  
39 context in the laws of the United States relating to federal income taxes, unless a different meaning  
40 is clearly required or the term is specifically defined in this chapter. Except where the Legislative  
41 Assembly has provided otherwise, any reference in this chapter to the laws of the United States or  
42 to the Internal Revenue Code refers to the laws of the United States or to the Internal Revenue  
43 Code as they are amended and in effect:

44 (1) On December 31, 2024[.]; or

45 (2) **If related to the definition of taxable income, as applicable to the tax year of the**

2 **SECTION 36.** ORS 316.013, as amended by section 24 of this 2025 Act, is amended to read:

3 316.013. Unless the context requires otherwise and notwithstanding ORS 316.012, whenever, in  
4 the calculation of Oregon taxable income, reference to the taxpayer's federal adjusted gross income  
5 is required to be made, the taxpayer's federal adjusted gross income shall be as determined under  
6 the provisions of the Internal Revenue Code as they may be in effect [on December 31, 2024] **for the**  
7 **tax year of the taxpayer** without any of the additions, subtractions or other modifications or ad-  
8 justments required under this chapter and other laws of this state applicable to personal income  
9 taxation.

10 **SECTION 37.** ORS 317.010, as amended by section 24, chapter 75, Oregon Laws 2024, and sec-  
11 tion 27 of this 2025 Act, is amended to read:

12 317.010. As used in this chapter, unless the context requires otherwise:

13 (1) "Centrally assessed corporation" means every corporation the property of which is assessed  
14 by the Department of Revenue under ORS 308.505 to 308.674.

15 (2) "Department" means the Department of Revenue.

16 (3)(a) "Consolidated federal return" means the return permitted or required to be filed by a  
17 group of affiliated corporations under section 1501 of the Internal Revenue Code.

18 (b) "Consolidated state return" means the return required to be filed under ORS 317.710 (5).

19 (4) "Doing business" means any transaction or transactions in the course of its activities con-  
20 ducted within the state by a national banking association, or any other corporation; provided, how-  
21 ever, that a foreign corporation whose activities in this state are confined to purchases of personal  
22 property, and the storage thereof incident to shipment outside the state, shall not be deemed to be  
23 doing business unless such foreign corporation is an affiliate of another foreign or domestic corpo-  
24 ration which is doing business in Oregon. Whether or not corporations are affiliated shall be de-

26 (5) "Excise tax" means a tax measured by or according to net income imposed upon national

38 (8) "Oregon taxable income" means taxable income, less the deduction allowed under ORS  
39 317.476, except as otherwise provided with respect to insurers in subsection (11) of this section and  
40 ORS 317.650 to 317.665.

41 (9) "Oregon net loss" means taxable loss, except as otherwise provided with respect to insurers  
42 in subsection (11) of this section and ORS 317.650 to 317.665.

43 (10) "Taxable income or loss" means the taxable income or loss determined, or in the case of a  
44 corporation for which no federal taxable income or loss is determined, as would be determined, un-  
45 der chapter 1, Subtitle A of the Internal Revenue Code and any other laws of the United States

1 relating to the determination of taxable income or loss of corporate taxpayers, with the additions,  
 2 subtractions, adjustments and other modifications as are specifically prescribed by this chapter ex-  
 3 cept that in determining taxable income or loss for any year, no deduction under ORS 317.476 or

 43 **Act apply to transactions or activities occurring on or after January 1, 2025, in tax years**  
 44 **beginning on or after January 1, 2025.**

45 (b) **The amendments to ORS 314.011, 316.012, 316.013, 317.010 and 317.018 by sections 20,**

1 23, 24, 27 and 28 of this 2025 Act apply to transactions or activities occurring on or after  
2 January 1, 2025, and before January 1, 2026, in tax years beginning on or after January 1,  
3 2025, and before January 1, 2026.

4 (2) The effective and applicable dates, and the exceptions, special rules and coordination  
5 with the Internal Revenue Code, as amended, relative to those dates, contained in federal law  
6 amending the Internal Revenue Code and enacted before January 1, 2025, apply for Oregon  
7 personal income and corporate excise and income tax purposes, to the extent they can be  
8 made applicable, in the same manner as they are applied under the Internal Revenue Code  
9 and related federal law.

10 (3)(a) If a deficiency is assessed against any taxpayer for a tax year beginning before  
11 January 1, 2025, and the deficiency or any portion thereof is attributable to any retroactive  
12 treatment under the amendments to ORS 178.300, 178.375, 305.239, 305.494, 305.690, 305.842,  
13 314.011, 314.306, 315.004, 316.012, 316.013, 316.147, 316.157, 317.010, 317.018, 317.097 and 317A.100  
14 by sections 1, 2 and 16 to 30 of this 2025 Act, then any interest or penalty assessed under  
15 ORS chapter 305, 314, 315, 316, 317, 317A or 318 with respect to the deficiency or portion  
16 thereof shall be canceled.

17 (b) If a refund is due any taxpayer for a tax year beginning before January 1, 2025, and  
18 the refund or any portion thereof is due the taxpayer on account of any retroactive treat-  
19 ment under the amendments to ORS 178.300, 178.375, 305.239, 305.494, 305.690, 305.842, 314.011,  
20 314.306, 315.004, 316.012, 316.013, 316.147, 316.157, 317.010, 317.018, 317.097 and 317A.100 by  
21 sections 1, 2 and 16 to 30 of this 2025 Act for a tax year beginning before January 1, 2025,  
22 then notwithstanding ORS 305.270 or 314.415 or any other law, the refund or portion thereof  
23 shall be paid without interest.

24 (c) Any changes required because of the amendments to ORS 178.300, 178.375, 305.239,  
25 305.494, 305.690, 305.842, 314.011, 314.306, 315.004, 316.012, 316.013, 316.147, 316.157, 317.010,  
26 317.018, 317.097 and 317A.100 by sections 1, 2 and 16 to 30 of this 2025 Act for a tax year be-  
27 ginning before January 1, 2025, shall be made by filing an amended return within the time  
28 prescribed by law.

29 (d) If a taxpayer fails to file an amended return under paragraph (c) of this subsection,  
30 the Department of Revenue shall make any changes under paragraph (c) of this subsection  
31 on the return to which the changes relate within the period specified for issuing a notice of  
32 deficiency or claiming a refund as otherwise provided by law with respect to that return, or  
33 within one year after a return for a tax year beginning on or after January 1, 2025, and be-  
34 fore January 1, 2026, is filed, whichever period expires later.

35 **SECTION 40.** The amendments to ORS 314.011, 316.012, 316.013, 317.010 and 317.018 by
