

House Bill 2092

Introduced and printed pursuant to House Rule 12.00. Pre-session filed (at the request of House Interim Committee on Revenue for Representative Nancy Nathanson)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**. The statement includes a measure digest written in compliance with applicable readability standards.

Digest: Updates the tie date to the federal Internal Revenue Code and other federal tax laws. Becomes law 91 days from sine die. (Flesch Readability Score: 64.9).

Updates the connection date to the federal Internal Revenue Code and other provisions of federal tax law.

Takes effect on the 91st day following adjournment sine die.

Be It Enacted by the People of the State of Oregon:

7 **SECTION 1.** ORS 178.300, as amended by section 1, chapter 75, Oregon Laws 2024, is amended
8 to read:
9

10 178.300. As used in ORS 178.300 to 178.360:

11 (1) "Account" means an individual account established in accordance with ORS 178.300 to
12 178.360.

13 (2) "Account owner" means the person who has the right to withdraw funds from the account.
14 The account owner may also be the designated beneficiary of the account.

15 (3) "Board" means the Oregon 529 Savings Board established under ORS 178.310.

16 (4) "Designated beneficiary" means, except as provided in ORS 178.350, the individual designated
17 at the time the account is opened as having the right to receive a qualified withdrawal for the
18 payment of qualified higher education expenses, or if the designated beneficiary is replaced in ac-
19 cordance with ORS 178.350, the replacement.

20 (5) "Financial institution" means a bank, a commercial bank, a national bank, a savings bank,
21 a savings and loan, a thrift institution, a credit union, an insurance company, a trust company, a
22 mutual fund, an investment firm or other similar entity authorized to do business in this state.

23 (6) "Higher education institution" means an eligible education institution as defined in section
24 529(e)(5) of the Internal Revenue Code.

25 (7) "Internal Revenue Code" means the federal Internal Revenue Code as amended and in effect
26 on December 31, [2023] **2024**.

27 (8) "Member of the family" shall have the same meaning as contained in section 529(e) of the
28 Internal Revenue Code.

1 (9) “Network” means the Oregon 529 Savings Network established under ORS 178.305.

2 (10) “Nonqualified withdrawal” means a withdrawal from an account that is not a qualified
3 withdrawal.

4 (11) “Qualified higher education expenses” means tuition and other permitted expenses as set
5 forth in section 529(e) of the Internal Revenue Code for the enrollment or attendance of a designated
6 beneficiary at a higher education institution, expenses associated with registered apprenticeship
7 programs described in section 529(c)(8) of the Internal Revenue Code and amounts paid as principal
8 or interest on a qualified education loan to the extent allowed under section 529(c)(9) of the Internal
9 Revenue Code.

10 (12) “Qualified withdrawal” means a withdrawal made as prescribed under ORS 178.355 and
11 made:

12 (a) From an account to pay the qualified higher education expenses of the designated benefi-
13 ciary;

14 (b) As the result of the death or disability of the designated beneficiary;

15 (c) As the result of a scholarship, allowance or payment described in section 135(d)(1)(A), (B)
16 or (C) of the Internal Revenue Code that is received by the designated beneficiary, but only to the
17 extent of the amount of the scholarship, allowance or payment; or

18 (d) As a rollover or change in the designated beneficiary described in ORS 178.350.

19 **SECTION 2.** ORS 178.375, as amended by section 2, chapter 75, Oregon Laws 2024, is amended
20 to read:

21 178.375. As used in this section and ORS 178.380 and 178.385:

22 (1) “ABLE account” means an account established by an eligible individual, owned by the eli-
23 gible individual and maintained under the qualified ABLE program established by the Oregon 529
24 Savings Board under ORS 178.380.

25 (2) “ABLE Act” means the Stephen Beck, Jr., Achieving a Better Life Experience Act of 2014
26 (Division B of P.L. 113-295).

27 (3) “Designated beneficiary” has the same meaning as contained in section 529A of the Internal
28 Revenue Code.

29 (4) “Eligible individual” has the same meaning as contained in section 529A of the Internal Re-
30 venue Code.

31 (5) “Internal Revenue Code” means the federal Internal Revenue Code as amended and in effect
32 on December 31, [2023] **2024**.

33 (6) “Qualified disability expense” has the same meaning as contained in section 529A of the
34 Internal Revenue Code.

35 **SECTION 3.** ORS 238A.005, as amended by section 3, chapter 75, Oregon Laws 2024, is amended
36 to read:

38 (1) “Active member” means a member of the pension program or the individual account program
39 of the Oregon Public Service Retirement Plan who is actively employed in a qualifying position.

40 (2) “Actuarial equivalent” means a payment or series of payments having the same value as the
41 payment or series of payments replaced, computed on the basis of interest rate and mortality as-
42 sumptions adopted by the board.

43 (3) “Board” means the Public Employees Retirement Board.

44 (4) “Eligible employee” means a person who performs services for a participating public em-
45 ployer, including persons considered employees of a participating public employer under 26 U.S.C.

1 3121(d)(2), as in effect on January 1, [2024] **2025**, and elected officials other than judges. “Eligible

13 optional retirement plan offered under ORS 243.815;

14 (i) Persons employed in positions classified as post-doctoral scholar positions by a public uni-
15 versity listed in ORS 352.002, or by the Oregon Health and Science University, under ORS 350.370;

16 (j) Any employee who belongs to a class of employees that was not eligible on August 28, 2003,
17 for membership in the system under the provisions of ORS chapter 238 or other law;

18 (k) Any person who belongs to a class of employees who are not eligible to become members
19 of the Oregon Public Service Retirement Plan under the provisions of ORS 238A.070 (2);

20 (L) Any person who is retired under ORS 238A.100 to 238A.250 or ORS chapter 238 and who
21 continues to receive retirement benefits while employed; and

22 (m) Judges.

23 (5) “Firefighter” means:

24 (a) A person employed by a local government, as defined in ORS 174.116, whose primary job
25 duties include the fighting of fires;

26 (b) The State Fire Marshal, chief deputy state fire marshals and deputy state fire marshals;

27 (c) An employee of the State Fire Marshal whose primary duties include fire investigation, fire
28 prevention, fire safety, fire control or fire suppression;

29 (d) An employee of the State Forestry Department who is certified by the State Forester as a
30 professional wildland firefighter and whose primary duties include the abatement of uncontrolled
31 fires as described in ORS 477.064; and

32 (e) An employee of the Oregon Military Department whose primary duties include fighting
33 structural, aircraft, wildland or other fires.

34 (6) “Fund” means the Public Employees Retirement Fund.

35 (7)(a) “Hour of service” means:

36 (A) An hour for which an eligible employee is directly or indirectly paid or entitled to payment
37 by a participating public employer for performance of duties in a qualifying position; and

38 (B) An hour of vacation, holiday, illness, incapacity, jury duty, military duty or authorized leave
39 during which an employee does not perform duties but for which the employee is directly or indi-
40 rectly paid or entitled to payment by a participating public employer for services in a qualifying
41 position, as long as the hour is within the number of hours regularly scheduled for the performance
42 of duties during the period of vacation, holiday, illness, incapacity, jury duty, military duty or au-
43 thorized leave.

44 (b) “Hour of service” does not include any hour for which payment is made or due under a plan
45 maintained solely for the purpose of complying with applicable unemployment compensation laws.

1 (8) “Inactive member” means a member of the pension program or the individual account pro-
 2 gram of the Oregon Public Service Retirement Plan whose membership has not been terminated, who
 3 is not a retired member and who is not employed in a qualifying position.

4 (9) “Individual account program” means the defined contribution individual account program of
 5 the Oregon Public Service Retirement Plan established under ORS 238A.025.

6 (10) “Institution of higher education” means a public university listed in ORS 352.002, the
 7 Oregon Health and Science University or a community college, as defined in ORS 341.005.

8 (11) “Member” means an eligible employee who has established membership in the pension pro-
 9 gram or the individual account program of the Oregon Public Service Retirement Plan and whose
 10 membership has not been terminated under ORS 238A.110 or 238A.310.

11 (12) “Participating public employer” means a public employer as defined in ORS 238.005 that
 12 provides retirement benefits for employees of the public employer under the system.

13 (13) “Pension program” means the defined benefit pension program of the Oregon Public Service
 14 Retirement Plan established under ORS 238A.025.

15 (14) “Police officer” means a police officer as described in ORS 238.005.

16 (15) “Qualifying position” means one or more jobs with one or more participating public em-
 17 ployers in which an eligible employee performs 600 or more hours of service in a full calendar year,
 18 or would perform 600 or more hours of service if the employee were employed for the full calendar
 19 year, excluding any service in a job for which benefits are not provided under the Oregon Public
 20 Service Retirement Plan pursuant to ORS 238A.070 (2).

21 (16) “Retired member” means a pension program member who is receiving a pension as provided
 22 in ORS 238A.180 to 238A.195.

23 (17)(a) “Salary” means the remuneration paid to an active member in return for services to the
 24 participating public employer, including remuneration in the form of living quarters, board or other
 25 items of value, to the extent the remuneration is, or would be if the member were an Oregon resi-
 26 dent, includable in the employee’s taxable income under Oregon law. “Salary” includes the addi-
 27 tional amounts specified in paragraph (b) of this subsection, but does not include the amounts
 28 specified in paragraph (c) of this subsection, regardless of whether those amounts are includable in
 29 taxable income.

30 (b) “Salary” includes the following amounts:

31 (A) Payments of employee and employer money into a deferred compensation plan that are made
 32 at the election of the employee.

33 (B) Contributions to a tax-sheltered or deferred annuity that are made at the election of the
 34 employee.

35 (C) Any amount that is contributed to a cafeteria plan or qualified transportation fringe benefit
 36 plan by the employer at the election of the employee and that is not includable in the taxable in-
 37 come of the employee by reason of 26 U.S.C. 125 or 132(f)(4), as in effect on December 31, [2023]
 38 **2024**.

39 (D) Any amount that is contributed to a cash or deferred arrangement by the employer at the
 40 election of the employee and that is not included in the taxable income of the employee by reason
 41 of 26 U.S.C. 402(e)(3), as in effect on December 31, [2023] **2024**.

42 (E) Retroactive payments described in ORS 238.008.

43 (F) The amount of an employee contribution to the individual account program that is paid by
 44 the employer and deducted from the compensation of the employee, as provided under ORS 238A.335
 45 (1) and (2)(a).

1 (G) The amount of an employee contribution to the individual account program that is not paid
 2 by the employer under ORS 238A.335.

3 (H) Wages of a deceased member paid to a surviving spouse or dependent children under ORS
 4 652.190.

5 (c) “Salary” does not include the following amounts:

6 (A) Travel or any other expenses incidental to employer’s business which is reimbursed by the
 7 employer.

8 (B) Payments made on account of an employee’s death.

9 (C) Any lump sum payment for accumulated unused sick leave, vacation leave or other paid
 10 leave.

11 (D) Any severance payment, accelerated payment of an employment contract for a future period
 12 or advance against future wages.

13 (E) Any retirement incentive, retirement bonus or retirement gratuitous payment.

14 (F) Payment for a leave of absence after the date the employer and employee have agreed that
 15 no future services in a qualifying position will be performed.

16 (G) Payments for instructional services rendered to public universities listed in ORS 352.002 or
 17 the Oregon Health and Science University when those services are in excess of full-time employment
 18 subject to this chapter. A person employed under a contract for less than 12 months is subject to
 19 this subparagraph only for the months covered by the contract.

20 (H) The amount of an employee contribution to the individual account program that is paid by
 21 the employer and is not deducted from the compensation of the employee, as provided under ORS
 22 238A.335 (1) and (2)(b).

23 (I) Compensation described and authorized under ORS 341.556 that is not paid by the community
 24 college employing the faculty member.

25 (J) Compensation described and authorized under ORS 352.232 that is not paid by the public
 26 university employing the officer or employee.

27 (K) Compensation described and authorized under ORS 353.270 that is not paid by Oregon
 28 Health and Science University.

29 (L) For years before 2020, any amount in excess of \$200,000 for a calendar year. If any period
 30 over which salary is determined is less than 12 months, the \$200,000 limitation for that period shall
 31 be multiplied by a fraction, the numerator of which is the number of months in the determination
 32 period and the denominator of which is 12. The board shall adopt rules adjusting this dollar limit
 33 to incorporate cost-of-living adjustments authorized by the Internal Revenue Service.

34 (M) For years beginning on or after January 1, 2020, any amount in excess of \$195,000 for a
 35 calendar year. If any period over which salary is determined is less than 12 months, the \$195,000
 36 limitation for that period shall be multiplied by a fraction, the numerator of which is the number
 37 of months in the determination period and the denominator of which is 12. On January 1 of each
 38 year, the board shall adjust the dollar limit provided by this subparagraph to reflect any percentage
 39 changes in the Consumer Price Index for All Urban Consumers, West Region (All Items), as pub-
 40 lished by the Bureau of Labor Statistics of the United States Department of Labor.

41 (18) “System” means the Public Employees Retirement System.

42 (19) “Workers’ compensation benefits” means:

43 (a) Payments made under ORS chapter 656; or

44 (b) Payments provided in lieu of workers’ compensation benefits under ORS 656.027 (6).

45 **SECTION 4.** ORS 238A.005, as amended by section 3, chapter 75, Oregon Laws 2024, and section

2, chapter 101, Oregon Laws 2024, is amended to read:

238A.005. For the purposes of this chapter:

(1) “Active member” means a member of the pension program or the individual account program of the Oregon Public Service Retirement Plan who is actively employed in a qualifying position.

(2) “Actuarial equivalent” means a payment or series of payments having the same value as the payment or series of payments replaced, computed on the basis of interest rate and mortality assumptions adopted by the board.

(3) “Board” means the Public Employees Retirement Board.

(4) “Eligible employee” means a person who performs services for a participating public employer, including persons considered employees of a participating public employer under 26 U.S.C. 3121(d)(2), as in effect on January 1, [2024] **2025**, and elected officials other than judges. “Eligible employee” does not include:

(a) Persons engaged as independent contractors;

(b) Aliens working under a training or educational visa;

(c) Persons provided sheltered employment or make-work by a public employer;

(d) Persons categorized by a participating public employer as student employees;

(e) Any person who is in custody in a state institution;

(f) Employees of foreign trade offices of the Oregon Business Development Department who live and perform services in foreign countries under the provisions of ORS 285A.075 (1)(g);

(g) An employee actively participating in an alternative retirement program established under ORS 353.250 or an optional retirement plan established under ORS 341.551;

(j) Any employee who belongs to a class of employees that was not eligible on August 28, 2003, for membership in the system under the provisions of ORS chapter 238 or other law;

(k) Any person who belongs to a class of employees who are not eligible to become members of the Oregon Public Service Retirement Plan under the provisions of ORS 238A.070 (2);

(L) Any person who is retired under ORS 238A.100 to 238A.250 or ORS chapter 238 and who continues to receive retirement benefits while employed; and

(m) Judges.

(5) “Firefighter” means:

(a) A person employed by a local government, as defined in ORS 174.116, whose primary job duties include the fighting of fires;

(b) The State Fire Marshal, chief deputy state fire marshals and deputy state fire marshals;

(c) An employee of the State Fire Marshal whose primary duties include fire investigation, fire prevention, fire safety, fire control or fire suppression;

(d) An employee of the State Forestry Department who is certified by the State Forester as a professional wildland firefighter and whose primary duties include the abatement of uncontrolled fires as described in ORS 477.064; and

(e) An employee of the Oregon Military Department whose primary duties include fighting structural, aircraft, wildland or other fires.

(6) “Fund” means the Public Employees Retirement Fund.

(7)(a) “Hazardous position” means a position that does not meet the definition of a qualified

1 public safety employee under section 72(t)(10)(B) of the Internal Revenue Code, but that:

2 (A) Requires the person holding the position to work with or manage emergency or traumatic
3 events in the regular course of work; or

4 (B) Carries a high risk of physical harm.

5 (b) “Hazardous position” includes and is limited to:

6 (A) Employees of the Oregon State Hospital who have direct contact with patients; and

7 (B) Telecommunicators, as defined in ORS 181A.355.

8 (8)(a) “Hour of service” means:

9 (A) An hour for which an eligible employee is directly or indirectly paid or entitled to payment
10 by a participating public employer for performance of duties in a qualifying position; and

11 (B) An hour of vacation, holiday, illness, incapacity, jury duty, military duty or authorized leave
12 during which an employee does not perform duties but for which the employee is directly or indi-
13 rectly paid or entitled to payment by a participating public employer for services in a qualifying
14 position, as long as the hour is within the number of hours regularly scheduled for the performance
15 of duties during the period of vacation, holiday, illness, incapacity, jury duty, military duty or au-
16 thorized leave.

17 (b) “Hour of service” does not include any hour for which payment is made or due under a plan
18 maintained solely for the purpose of complying with applicable unemployment compensation laws.

19 (9) “Inactive member” means a member of the pension program or the individual account pro-
20 gram of the Oregon Public Service Retirement Plan whose membership has not been terminated, who
21 is not a retired member and who is not employed in a qualifying position.

22 (10) “Individual account program” means the defined contribution individual account program
23 of the Oregon Public Service Retirement Plan established under ORS 238A.025.

24 (11) “Institution of higher education” means a public university listed in ORS 352.002, the
25 Oregon Health and Science University or a community college, as defined in ORS 341.005.

26 (12) “Member” means an eligible employee who has established membership in the pension pro-
27 gram or the individual account program of the Oregon Public Service Retirement Plan and whose
28 membership has not been terminated under ORS 238A.110 or 238A.310.

29 (13) “Participating public employer” means a public employer as defined in ORS 238.005 that
30 provides retirement benefits for employees of the public employer under the system.

31 (14) “Pension program” means the defined benefit pension program of the Oregon Public Service
32 Retirement Plan established under ORS 238A.025.

33 (15) “Police officer” means a police officer as described in ORS 238.005.

34 (16) “Qualifying position” means one or more jobs with one or more participating public em-
35 ployers in which an eligible employee performs 600 or more hours of service in a full calendar year,
36 or would perform 600 or more hours of service if the employee were employed for the full calendar
37 year, excluding any service in a job for which benefits are not provided under the Oregon Public
38 Service Retirement Plan pursuant to ORS 238A.070 (2).

39 (17) “Retired member” means a pension program member who is receiving a pension as provided
40 in ORS 238A.180 to 238A.195.

41 (18)(a) “Salary” means the remuneration paid to an active member in return for services to the
42 participating public employer, including remuneration in the form of living quarters, board or other
43 items of value, to the extent the remuneration is, or would be if the member were an Oregon resi-
44 dent, includable in the employee’s taxable income under Oregon law. “Salary” includes the addi-
45 tional amounts specified in paragraph (b) of this subsection, but does not include the amounts

1 specified in paragraph (c) of this subsection, regardless of whether those amounts are includable in
 2 taxable income.

3 (b) "Salary" includes the following amounts:

4 (A) Payments of employee and employer money into a deferred compensation plan that are made
 5 at the election of the employee.

6 (B) Contributions to a tax-sheltered or deferred annuity that are made at the election of the
 7 employee.

8 (C) Any amount that is contributed to a cafeteria plan or qualified transportation fringe benefit
 9 plan by the employer at the election of the employee and that is not includable in the taxable in-
 10 come of the employee by reason of 26 U.S.C. 125 or 132(f)(4), as in effect on December 31, [2023]
 11 **2024**.

12 (D) Any amount that is contributed to a cash or deferred arrangement by the employer at the
 13 election of the employee and that is not included in the taxable income of the employee by reason
 14 of 26 U.S.C. 402(e)(3), as in effect on December 31, [2023] **2024**.

15 (E) Retroactive payments described in ORS 238.008.

16 (F) The amount of an employee contribution to the individual account program that is paid by
 17 the employer and deducted from the compensation of the employee, as provided under ORS 238A.335
 18 (1) and (2)(a).

19 (G) The amount of an employee contribution to the individual account program that is not paid
 20 by the employer under ORS 238A.335.

21 (H) Wages of a deceased member paid to a surviving spouse or dependent children under ORS
 22 652.190.

23 (c) "Salary" does not include the following amounts:

24 (A) Travel or any other expenses incidental to employer's business which is reimbursed by the
 25 employer.

26 (B) Payments made on account of an employee's death.

27 (C) Any lump sum payment for accumulated unused sick leave, vacation leave or other paid
 28 leave.

29 (D) Any severance payment, accelerated payment of an employment contract for a future period
 30 or advance against future wages.

31 (E) Any retirement incentive, retirement bonus or retirement gratuitous payment.

32 (F) Payment for a leave of absence after the date the employer and employee have agreed that

1 Health and Science University.

2 (L) For years before 2020, any amount in excess of \$200,000 for a calendar year. If any period
 3 over which salary is determined is less than 12 months, the \$200,000 limitation for that period shall
 4 be multiplied by a fraction, the numerator of which is the number of months in the determination
 5 period and the denominator of which is 12. The board shall adopt rules adjusting this dollar limit
 6 to incorporate cost-of-living adjustments authorized by the Internal Revenue Service.

7 (M) For years beginning on or after January 1, 2020, any amount in excess of \$195,000 for a
 8 calendar year. If any period over which salary is determined is less than 12 months, the \$195,000

 10 of months in the determination period and the denominator of which is 12. On January 1 of each
 11 year, the board shall adjust the dollar limit provided by this subparagraph to reflect any percentage

 13 lished by the Bureau of Labor Statistics of the United States Department of Labor.

14 (19) "System" means the Public Employees Retirement System.

15 (20) "Workers' compensation benefits" means:

16 (a) Payments made under ORS chapter 656; or

17 (b) Payments provided in lieu of workers' compensation benefits under ORS 656.027 (6).

18 **SECTION 5.** ORS 238A.125, as amended by section 4, chapter 75, Oregon Laws 2024, is amended
 19 to read:

20 238A.125. (1) Upon retiring at normal retirement age, a vested pension program member shall
 21 be paid an annual pension for the life of the member as follows:

22 (a) For service as a police officer or firefighter, 1.8 percent of final average salary multiplied

5 Community Services Department, or bonds, as defined in ORS 456.055, if issued by a housing au-
6 thority.

7 (c) “Finance charge” means the total of all interest, loan fees, interest on any loan fees financed
8 by the lending institution, and other charges related to the cost of obtaining credit.

9 (d) “Lending institution” means any insured institution, as that term is defined in ORS 706.008,
10 any mortgage banking company that maintains an office in this state or any community development
11 corporation that is organized under the Oregon Nonprofit Corporation Law.

12 (e) “Limited equity cooperative” means a cooperative corporation formed under ORS chapter 62
13 whose articles of incorporation, in addition to the other requirements of ORS chapter 62, prohibit
14 members from selling their ownership interests:

15 (A) To any person other than a low income person; or

16 (B) For a sales price that exceeds the sum of:

17 (i) The price the member paid for the ownership interest;

18 (ii) The cost of any permanent improvements the member made to the housing unit during the
19 member’s ownership;

20 (iii) Any special assessments the member paid to the limited equity cooperative during the
21 member’s ownership that were expended to make permanent improvements to the building in which
22 the member’s housing unit is located; and

23 (iv) A return on the amounts described in sub-subparagraphs (i) to (iii) of this subparagraph,
24 computed from the year in which the respective amount was paid, that equals the greater of the
25 result of adjusting each amount by the percentage increase, if any, in the Consumer Price Index for
26 All Urban Consumers, West Region (All Items), as published by the Bureau of Labor Statistics of the
27 United States Department of Labor, or of increasing each amount by three percent compounded
28 annually.

29 (f) “Manufactured dwelling park” has the meaning given that term in ORS 446.003.

30 (g) “Nonprofit corporation” means a corporation that is exempt from income taxes under section
31 501(c)(3) or (4) of the Internal Revenue Code as amended and in effect on December 31, [2023]
32 **2024**.

33 (h) “Preservation project” means housing that was previously developed as affordable housing
34 with a contract for rent assistance from the United States Department of Housing and Urban De-
35 velopment or the United States Department of Agriculture and that is being acquired by a spon-
36 soring entity.

37 (i) “Qualified assignee” means any investor participating in the secondary market for real estate
38 loans.

39 (j) “Qualified borrower” means any borrower that is a sponsoring entity that has a controlling
40 interest in the real property that is financed by a qualified loan. A controlling interest includes a
41 controlling interest in the general partner of a limited partnership that owns the real property.

42 (k) “Qualified loan” means:

43 (A) A loan that meets the criteria stated in subsection (5) of this section or that is made to re-
44 finance a loan that meets the criteria described in subsection (5) of this section; or

45 (B) The purchase by a lending institution of bonds, the proceeds of which are used to finance

1 or refinance a loan that meets the criteria described in subsection (5) of this section.

2 (L) "Sponsoring entity" means a nonprofit corporation, nonprofit cooperative, state govern-
 3 mental entity, local unit of government as defined in ORS 466.706, housing authority or any other
 4 person, provided that the person has agreed to restrictive covenants imposed by a nonprofit corpo-
 5 ration, nonprofit cooperative, state governmental entity, local unit of government or housing au-
 6 thority.

7 (2) The Department of Revenue shall allow a credit against taxes otherwise due under this
 8 chapter for the tax year to a lending institution that makes a qualified loan certified by the Housing
 9 and Community Services Department as provided in subsection (7) of this section. The amount of the
 10 credit is equal to the difference between:

11 (a) The amount of finance charge charged by the lending institution during the tax year at an
 12 annual rate less than the market rate for a qualified loan that is made before January 1, 2026, that
 13 complies with the requirements of this section; and

14 (b) The amount of finance charge that would have been charged during the tax year by the
 15 lending institution for the qualified loan for housing construction, development, acquisition or re-
 16 habilitation measured at the annual rate charged by the lending institution for nonsubsidized loans
 17 made under like terms and conditions at the time the qualified loan for housing construction, de-
 18 velopment, acquisition or rehabilitation is made.

19 (3) The maximum amount of credit for the difference between the amounts described in sub-
 20 section (2)(a) and (b) of this section may not exceed four percent of the average unpaid balance of
 21 the qualified loan during the tax year for which the credit is claimed.

22 (4) Any tax credit allowed under this section that is not used by the taxpayer in a particular
 23 year may be carried forward and offset against the taxpayer's tax liability for the next succeeding
 24 tax year. Any credit remaining unused in the next succeeding tax year may be carried forward and
 25 used in the second succeeding tax year, and likewise, any credit not used in that second succeeding
 26 tax year may be carried forward and used in the third succeeding tax year, and any credit not used
 27 in that third succeeding tax year may be carried forward and used in the fourth succeeding tax year,
 28 and any credit not used in that fourth succeeding tax year may be carried forward and used in the
 29 fifth succeeding tax year, but may not be carried forward for any tax year thereafter.

30 (5) To be eligible for the tax credit allowable under this section, a lending institution must make
 31 a qualified loan by either purchasing bonds, the proceeds of which are used to finance or refinance
 32 a loan that meets the criteria stated in this subsection, or making a loan directly to:

33 (a) An individual or individuals who own a dwelling, participate in an owner-occupied commu-
 34 nity rehabilitation program and are certified by the local government or its designated agent as
 35 having an income level when the loan is made of 80 percent of the area median income or less;

36 (b) A qualified borrower who:

37 (A) Uses the loan proceeds to finance construction, development, acquisition or rehabilitation
 38 of housing, including housing in the form of a limited equity cooperative; and

39 (B) Provides a written certification executed by the Housing and Community Services Depart-
 40 ment that the:

41 (i) Housing created by the loan is or will be occupied by households earning 80 percent of the
 42 area median income or less; and

43 (ii) Full amount of savings from the reduced interest rate provided by the lending institution is
 44 or will be passed on, in the form of reduced housing payments, to the tenants or to the holders of
 45 proprietary leases in a limited equity cooperative;

- 1 (c) Subject to subsection (14) of this section, a qualified borrower who:
- 2 (A) Uses the loan proceeds to finance construction, development, acquisition or rehabilitation
3 of housing consisting of a manufactured dwelling park; and
- 4 (B) Provides a written certification executed by the Housing and Community Services Depart-
5 ment that the housing will continue to be operated as a manufactured dwelling park during the pe-
6 riod for which the tax credit is allowed;
- 7 (d) A qualified borrower who:
- 8 (A) Uses the loan proceeds to finance acquisition or rehabilitation of housing consisting of a
9 preservation project; and
- 10 (B) Provides a written certification executed by the Housing and Community Services Depart-
11 ment that the housing preserved by the loan:
- 12 (i) Is or will be occupied by households earning 80 percent of the area median income or less;
13 and
- 14 (ii) Is the subject of a rent assistance contract with the United States Department of Housing
15 and Urban Development or the United States Department of Agriculture that will be maintained by
16 the qualified borrower; or
- 17 (e) A qualified borrower who:
- 18 (A) Uses the loan proceeds to finance construction, development, acquisition or rehabilitation
19 of housing; and
- 20 (B) Provides a written certification executed by the Housing and Community Services Depart-
21 ment or the governmental party to the rent assistance contract that the housing preserved by the
22 loan:
- 23 (i) Is or will be occupied by households earning 80 percent of the area median income or less;
24 and
- 25 (ii) Is the subject of a rent assistance contract with the federal government or with a state or
26 local government that will be maintained by the qualified borrower and that limits a tenant's rent
27 to no more than 30 percent of their income.
- 28 (6) A loan made to refinance a loan that meets the criteria stated in subsection (5) of this sec-
29 tion must be treated the same as a loan that meets the criteria stated in subsection (5) of this sec-
30 tion.
- 31 (7) For a qualified loan to be eligible for the tax credit allowable under this section, the Housing
32 and Community Services Department must execute a written certification for the qualified loan that:
- 33 (a) States that the qualified loan is within the limitation imposed by subsection (8) of this sec-
34 tion; and
- 35 (b) Specifies the period, as determined by the Housing and Community Services Department,
36 during which the tax credit is allowed for the qualified loan, not to exceed:
- 37 (A) 30 years, for a qualified loan with a contract for rent assistance or financing resources from
38 the United States Department of Agriculture, for new housing construction, acquisition of housing
39 or a preservation project; or
- 40 (B) 20 years, for any other type of qualified loan.
- 41 (8) The Housing and Community Services Department may certify qualified loans that are eligi-
42 ble under subsection (5) of this section if the total credits attributable to all qualified loans eligible
43 for credits under this section and then outstanding do not exceed \$35 million for any fiscal year. In
44 making loan certifications under subsection (7) of this section, the Housing and Community Services
45 Department shall attempt to distribute the tax credits statewide, but shall concentrate the tax

1 credits in those areas of the state that are determined by the Oregon Housing Stability Council to
 2 have the greatest need for affordable housing.

3 (9) The tax credit provided for in this section may be taken whether or not:

4 (a) The financial institution is eligible to take a federal income tax credit under section 42 of
 5 the Internal Revenue Code with respect to the project financed by the qualified loan; or

6 (b) The project receives financing from bonds, the interest on which is exempt from federal
 7 taxation under section 103 of the Internal Revenue Code.

8 (10) For a qualified loan defined in subsection (1)(k)(B) of this section financed through the
 9 purchase of bonds, the interest of which is exempt from federal taxation under section 103 of the
 10 Internal Revenue Code, the amount of finance charge that would have been charged under sub-
 11 section (2)(b) of this section is determined by reference to the finance charge that would have been
 12 charged if the federally tax exempt bonds had been issued and the tax credit under this section did
 13 not apply.

14 (11) A lending institution may sell a qualified loan for which a certification has been executed
 15 to a qualified assignee whether or not the lending institution retains servicing of the qualified loan
 16 so long as a designated lending institution maintains records, annually verified by a loan servicer,
 17 that establish the amount of tax credit earned by the taxpayer throughout each year of eligibility.

18 (12) Notwithstanding any other provision of law, a lending institution that is a community de-
 19 velopment corporation organized under the Oregon Nonprofit Corporation Law may transfer all or
 20 part of a tax credit allowed under this section to one or more other lending institutions that are
 21 stockholders or members of the community development corporation or that otherwise participate
 22 through the community development corporation in the making of one or more qualified loans for
 23 which the tax credit under this section is allowed.

24 (13) The lending institution shall file an annual statement with the Housing and Community
 25 Services Department, specifying that it has conformed with all requirements imposed by law to
 26 qualify for a tax credit under this section.

27 (14) Notwithstanding subsection (1)(j) and (L) of this section, a qualified borrower on a loan to
 28 finance the construction, development, acquisition or rehabilitation of a manufactured dwelling park
 29 under subsection (5)(c) of this section must be:

30 (a) A nonprofit corporation, manufactured dwelling park nonprofit cooperative, state govern-
 31 mental entity, local unit of government as defined in ORS 466.706 or housing authority; or

32 (b) A nonprofit corporation or housing authority that has a controlling interest in the real
 33 property that is financed by a qualified loan. A controlling interest includes a controlling interest
 34 in the general partner of a limited partnership that owns the real property.

35 (15) The Department of Revenue may require that a lending institution that has earned the
 36 credit and a lending institution that intends to claim the credit jointly file a notice, as prescribed
 37 by the Department of Revenue. The notice must comply with ORS 315.056 (2) or 315.058 (2).

38 (16) The Housing and Community Services Department shall provide information to the Depart-
 39 ment of Revenue about all certifications executed under this section, if required by ORS 315.058.

40 (17) The Housing and Community Services Department and the Department of Revenue may
 41 adopt rules to carry out the provisions of this section.

42 **SECTION 28.** ORS 317A.100, as amended by section 26, chapter 75, Oregon Laws 2024, is

17 (b) "Commercial activity" does not include:

18 (A) Interest income except:

19 (i) Interest on credit sales; or

20 (ii) Interest income, including service charges, received by financial institutions;

21 (B) Receipts from the sale, exchange or other disposition of an asset described in section 1221
 22 or 1231 of the Internal Revenue Code, without regard to the length of time the person held the asset;

23 (C) If received by an insurer, federally reinsured premiums or income from transactions between
 24 a reciprocal insurer and its attorney in fact operating under ORS 731.142;

25 (D) Receipts from hedging transactions, to the extent that the transactions are entered into
 26 primarily to protect a financial position, including transactions intended to manage the risk of ex-
 27 posure to foreign currency fluctuations that affect assets, liabilities, profits, losses, equity or in-
 28 vestments in foreign operations, risk of exposure to interest rate fluctuations or risk of commodity
 29 price fluctuations;

30 (E) Proceeds received attributable to the repayment, maturity or redemption of the principal of
 31 a loan, bond, mutual fund, certificate of deposit or marketable instrument;

32 (F) The principal amount received under a repurchase agreement or on account of any trans-
 33 action properly characterized as a loan to the person;

34 (G) Contributions received by a trust, plan or other arrangement, any of which is described in

 41 pendent care spending account, legal services plan, any cafeteria plan described in section 125 of
 42 the Internal Revenue Code or any similar employee reimbursement;

 44 calls, or from the sale of the taxpayer's treasury stock;

1 surance policies, owned by the taxpayer, except those proceeds received for the loss of commercial
2 activity;

3 (K) Gifts or charitable contributions received, membership dues received by trade, professional,
4 homeowners' or condominium associations, payments received for educational courses, meetings or
5 meals, or similar payments to a trade, professional or other similar association, and fundraising re-
6 cepts received by any person when any excess receipts are donated or used exclusively for chari-
7 table purposes;

8 (L) Damages received as the result of litigation in excess of amounts that, if received without
9 litigation, would be treated as commercial activity;

10 (M) Property, money and other amounts received or acquired by an agent on behalf of another
11 in excess of the agent's commission, fee or other remuneration;

12 (N) Tax refunds from any tax program, other tax benefit recoveries and reimbursements for the
13 tax imposed under ORS 317A.100 to 317A.158 made by entities that are part of the same unitary
14 group as provided under ORS 317A.106, and reimbursements made by entities that are not members
15 of a unitary group that are required to be made for economic parity among multiple owners of an
16 entity whose tax obligation under ORS 317A.100 to 317A.158 is required to be reported and paid
17 entirely by one owner, as provided in ORS 317A.106;

18 (O) Pension reversions;

19 (P) Contributions to capital;

20 (Q) Receipts from the sale, transfer, exchange or other disposition of motor vehicle fuel or any
21 other product used for the propulsion of motor vehicles;

22 (R) In the case of receipts from the sale of cigarettes or tobacco products by a wholesale dealer,
23 retail dealer, distributor, manufacturer or seller, an amount equal to the federal and state excise
24 taxes paid by any person on or for such cigarettes or tobacco products under subtitle E of the

43 to another vehicle dealer for the purpose of resale by the transferee vehicle dealer, but only if the
44 sale or other transfer was based upon the transferee's need to meet a specific customer's preference
45 for a motor vehicle or is an exchange of new vehicles between franchised motor vehicle dealerships;

1 (X) Registration fees or taxes collected by a vehicle dealer certified under ORS 822.020 or a
2 person described in ORS 320.400 (8)(a)(B) at the sale or other transfer of a motor vehicle, as defined
3 in ORS 801.360, that are owed to a third party by the purchaser of the motor vehicle and passed to
4 the third party by the dealer;

5 (Y) Receipts from a financial institution for services provided to the financial institution in
6 connection with the issuance, processing, servicing and management of loans or credit accounts, if
7 the financial institution and the recipient of the receipts have at least 50 percent of their ownership
8 interests owned or controlled, directly or constructively through related interests, by common own-
9 ers;

10 (Z) In the case of amounts retained as commissions by a holder of a license under ORS chapter
11 462, an amount equal to the amounts specified under ORS chapter 462 that must be paid to or col-
12 lected by the Department of Revenue as a tax and the amounts specified under ORS chapter 462 to
13 be used as purse money;

14 (AA) Receipts of residential care facilities as defined in ORS 443.400 or in-home care agencies
15 as defined in ORS 443.305, to the extent that the receipts are derived from or received as compen-
16 sation for providing services to a medical assistance or Medicare recipient;

18 (CC) Distributive income received from a pass-through entity;

30 that support energy conservation, renewable resource acquisition and low-income assistance pro-
31 grams;

32 (HH) Moneys collected by a utility from customers for the payment of loans through on-bill fi-
33 nancing;

44 (MM) Universal service surcharge moneys collected or recovered and paid into the universal
45 service fund established in ORS 759.425;

- 1 (NN) Moneys collected for public purpose funding as described in ORS 759.430;
- 2 (OO) Moneys collected or recovered and paid into the federal universal service fund as deter-
- 3 mined by the Federal Communications Commission;
- 4 (PP) In the case of a seller or provider of telecommunications services, the amount of tax im-
- 5 posed under ORS 403.200 for access to the emergency communications system that is collected from
- 6 subscribers or consumers;
- 7 (QQ) In the case of a transient lodging tax collector, the amount of tax imposed under ORS
- 8 320.305 and of any local transient lodging tax imposed upon the occupancy of transit lodging;

9 (L) Manufactured dwelling park nonprofit cooperatives organized under ORS chapter 62.

10 (5) “Financial institution” has the meaning given that term in ORS 314.610, except that “finan-
11 cial institution” does not include a credit union.

12 (6)(a) “FR Y-9” means the consolidated or parent-only financial statements that a holding com-
13 pany is required to file with the Federal Reserve Board pursuant to 12 U.S.C. 1844.

14 (b) In the case of a holding company required to file both consolidated and parent-only financial
15 statements, “FR Y-9” means the consolidated financial statements that the holding company is re-
16 quired to file.

17 (7) “Governmental entity” means:

18 (a) The United States and any of its unincorporated agencies and instrumentalities.

19 (b) Any incorporated agency or instrumentality of the United States wholly owned by the United
20 States or by a corporation wholly owned by the United States.

21 (c) The State of Oregon and any of its unincorporated agencies and instrumentalities.

22 (d) Any county, city, district or other political subdivision of the state.

23 (e) A special government body as defined in ORS 174.117.

24 (f) A federally recognized Indian tribe.

25 (8) “Groceries” means food as defined in 7 U.S.C. 2012(k), but does not include cannabinoid
26 edibles or marijuana seeds.

27 (9)(a) “Hedging transaction” means a hedging transaction as defined in section 1221 of the
28 Internal Revenue Code or a transaction accorded hedge accounting treatment under Financial Ac-
29 counting Standards Board Statement No. 133.

30 (b) “Hedging transaction” does not include a transaction in which an actual transfer of title of
31 real or tangible property to another entity occurs.

32 (10) “Insurer” has the meaning given that term in ORS 317.010.

33 (11) “Internal Revenue Code,” except where the Legislative Assembly has provided otherwise,
34 refers to the laws of the United States or to the Internal Revenue Code as they are amended and
35 in effect on December 31, [2023] **2024**.

36 (12) “Labor costs” means total compensation of all employees, not to include compensation paid
37 to any single employee in excess of \$500,000.

38 (13)(a) “Motor vehicle fuel or any other product used for the propulsion of motor vehicles”
39 means:

40 (A) Motor vehicle fuel as defined in ORS 319.010; and

41 (B) Fuel the use of which in a motor vehicle is subject to taxation under ORS 319.530.

42 (b) “Motor vehicle fuel or any other product used for the propulsion of motor vehicles” does not
43 mean:

44 (A) Electricity; or

45 (B) Electric batteries or any other mechanical or physical component or accessory of a motor

1 vehicle.

2 (14) "Person" includes individuals, combinations of individuals of any form, receivers, assignees,
3 trustees in bankruptcy, firms, companies, joint-stock companies, business trusts, estates, partner-
4 ships, limited liability partnerships, limited liability companies, associations, joint ventures, clubs,
5 societies, entities organized as for-profit corporations under ORS chapter 60, C corporations, S cor-
6 porations, qualified subchapter S subsidiaries, qualified subchapter S trusts, trusts, entities that are
7 disregarded for federal income tax purposes and any other entities.

8 (15) "Retailer" means a person doing business by selling tangible personal property to a pur-
9 chaser for a purpose other than:

10 (a) Resale by the purchaser of the property as tangible personal property in the regular course
11 of business;

12 (b) Incorporation by the purchaser of the property in the course of regular business as an in-
13 gredient or component of real or personal property; or

14 (c) Consumption by the purchaser of the property in the production for sale of a new article of
15 tangible personal property.

16 (16) "Taxable commercial activity" means commercial activity sourced to this state under ORS
17 317A.128, less any subtraction pursuant to ORS 317A.119.

18 (17)(a) "Taxpayer" means any person or unitary group required to register, file or pay tax under
19 ORS 317A.100 to 317A.158.

20 (b) "Taxpayer" does not include excluded persons, except to the extent that a tax-exempt entity
21 has unrelated business income as described in the Internal Revenue Code.

22 (18) "Tax year" means, except as otherwise provided in ORS 317A.103, a taxpayer's annual ac-
23 counting period used for federal income tax purposes under section 441 of the Internal Revenue
24 Code.

25 (19)(a) "Unitary business" means a business enterprise in which there exists directly or indi-
26 rectly between the members or parts of the enterprise a sharing or exchange of value as demon-
27 strated by:

28 (A) Centralized management or a common executive force;

29 (B) Centralized administrative services or functions resulting in economies of scale; or

30 (C) Flow of goods, capital resources or services demonstrating functional integration.

31 (b) "Unitary business" may include a business enterprise the activities of which:

32 (A) Are in the same general line of business, such as manufacturing, wholesaling or retailing;

33 or

34 (B) Constitute steps in a vertically integrated process, such as the steps involved in the pro-
35 duction of natural resources, which might include exploration, mining, refining and marketing.

36 (20) "Unitary group" means a group of persons with more than 50 percent common ownership,
37 either direct or indirect, that is engaged in business activities that constitute a unitary business.

38 (21) "Wholesaler" means a person primarily doing business by merchant distribution of tangible
39 personal property to retailers or to other wholesalers.

40 **SECTION 29.** ORS 458.670, as amended by section 27, chapter 75, Oregon Laws 2024, is
41 amended to read:

42 458.670. As used in this section and ORS 458.675 to 458.700, unless the context requires other-
43 wise:

44 (1) "Account holder" means a resident of this state who:

45 (a) Is 12 years of age or older;

1 (b) Is a member of a lower income household; and

2 (c) Has established an individual development account with a fiduciary organization.

3 (2) "Fiduciary organization" means an organization selected under ORS 458.695 to administer
4 state moneys directed to individual development accounts and that is:

5 (a) A nonprofit, fund raising organization that is exempt from taxation under section 501(c)(3)
6 of the Internal Revenue Code as amended and in effect on December 31, [2023] **2024**; or

7 (b) A federally recognized Oregon Indian tribe that is located, to a significant degree, within the
8 boundaries of this state.

9 (3) "Financial institution" means:

10 (a) An organization regulated under ORS chapters 706 to 716 or 723; or

11 (b) In the case of individual development accounts established for the purpose described in ORS
12 458.685 (1)(c), a financial institution as defined in ORS 178.300.

13 (4) "Individual development account" means a contract between an account holder and a
14 fiduciary organization, for the deposit of funds into a financial institution by the account holder and
15 the deposit of matching funds into a designated account by the fiduciary organization, to allow the
16 account holder to accumulate assets for use toward achieving a specific purpose approved by the
17 fiduciary organization.

18 (5) "Lower income household" means a household having an income equal to or less than the
19 greater of the following:

20 (a) 80 percent of the median household income for the area as determined by the Housing and
21 Community Services Department. In making the determination, the department shall give consider-
22 ation to any data on area household income published by the United States Department of Housing
23 and Urban Development.

24 (b) 200 percent of the poverty guidelines as determined by the Housing and Community Services
25 Department. In making the determination, the department shall give consideration to poverty

32 (B) Holdings in pension accounts valued at less than \$120,000.

33 (7) "Resident of this state" has the meaning given that term in ORS 316.027.

34 **SECTION 30.** ORS 657.010, as amended by section 28, chapter 75, Oregon Laws 2024, is
35 amended to read:

36 657.010. As used in this chapter, unless the context requires otherwise:

37 (1) "Base year" means the first four of the last five completed calendar quarters preceding the
38 benefit year.

39 (2) "Benefits" means the money allowances payable to unemployed persons under this chapter.

40 (3) "Benefit year" means a period of 52 consecutive weeks commencing with the first week with
41 respect to which an individual files an initial valid claim for benefits, and thereafter the 52 consec-
42 utive weeks period beginning with the first week with respect to which the individual next files an
43 initial valid claim after the termination of the individual's last preceding benefit year except that
44 the benefit year shall be 53 weeks if the filing of an initial valid claim would result in overlapping
45 any quarter of the base year of a previously filed initial valid claim.

1 (4) “Calendar quarter” means the period of three consecutive calendar months ending on March
 2 31, June 30, September 30 or December 31, or the approximate equivalent thereof, as the Director
 3 of the Employment Department may, by rule, prescribe.

4 (5) “Contribution” or “contributions” means the taxes that are the money payments required by
 5 this chapter, or voluntary payments permitted, to be made to the Unemployment Compensation Trust
 6 Fund.

7 (6) “Educational institution,” including an institution of higher education, means an institution:

8 (a) In which participants, trainees or students are offered an organized course of study or
 9 training designed to transfer to them knowledge, skills, information, doctrines, attitudes or abilities
 10 from, by or under the guidance of an instructor or teacher;

11 (b) That is accredited, registered, approved, licensed or issued a permit to operate as a school
 12 by the Department of Education or other government agency, or that offers courses for credit that
 13 are transferable to an approved, registered or accredited school;

14 (c) In which the course or courses of study or training that it offers may be academic, technical,
 15 trade or preparation for gainful employment in a recognized occupation; and

16 (d) In which the course or courses of study or training are offered on a regular and continuing
 17 basis.

18 (7) “Employment office” means a free public employment office or branch thereof, operated by
 19 this state or maintained as a part of a state-controlled system of public employment offices.

20 (8) “Hospital” has the meaning given that term in ORS 442.015.

21 (9) “Institution of higher education” means an educational institution that:

22 (a) Admits as regular students only individuals having a certificate of graduation from a high
 23 school, or the recognized equivalent of such a certificate;

24 (b) Is legally authorized in this state to provide a program of education beyond high school;

25 (c) Provides an educational program for which it awards a bachelor’s or higher degree, or pro-
 26 vides a program that is acceptable for full credit toward such a degree, a program of post-graduate
 27 or post-doctoral studies, or a program of training to prepare students for gainful employment in a
 28 recognized occupation; and

29 (d) Is a public or other nonprofit institution.

30 (10) “Instructional capacity” does not include services performed as an instructional assistant
 31 as defined in ORS 342.120.

32 (11) “Internal Revenue Code” means the federal Internal Revenue Code, as amended and in ef-
 33 fect on December 31, [2023] **2024**.

34 (12) “Nonprofit employing unit” means an organization, or group of organizations, described in
 35 section 501(c)(3) of the Internal Revenue Code that is exempt from income tax under section 501(a)
 36 of the Internal Revenue Code.

37 (13) “State” includes, in addition to the states of the United States of America, the District of
 38 Columbia and Puerto Rico. However, for all purposes of this chapter the Virgin Islands shall be
 39 considered a state on and after the day on which the United States Secretary of Labor first approves
 40 the Virgin Islands’ law under section 3304(a) of the Federal Unemployment Tax Act as amended by
 41 Public Law 94-566.

42 (14) “Taxes” means the money payments to the Unemployment Compensation Trust Fund re-
 43 quired, or voluntary payments permitted, by this chapter.

44 (15) “Valid claim” means any claim for benefits made in accordance with ORS 657.260 if the
 45 individual meets the wages-paid-for-employment requirements of ORS 657.150.

1 (16) “Week” means any period of seven consecutive calendar days ending at midnight, as the
2 director may prescribe by rule.

3 **SECTION 31.** ORS 657B.010, as amended by sections 3 and 4, chapter 20, Oregon Laws 2024,
4 and section 29, chapter 75, Oregon Laws 2024, is amended to read:

5 657B.010. As used in this chapter:

6 (1) “Alternate base year” means the last four completed calendar quarters preceding the benefit
7 year.

8 (2) “Average weekly wage” means the amount calculated by the Employment Department as the
9 state average weekly covered wage under ORS 657.150 (4)(e) as determined not more than once per
10 year.

11 (3) “Base year” means the first four of the last five completed calendar quarters preceding the
12 benefit year.

13 (4) “Benefits” means family and medical leave insurance benefits.

14 (5)(a) “Benefit year” means, except as provided in paragraph (b) of this subsection, a period of
15 52 consecutive weeks beginning on the Sunday immediately preceding the date on which family
16 leave, medical leave or safe leave commences.

17 (b) “Benefit year” means, in the event that the 52-week period described in paragraph (a) of this
18 subsection would result in an overlap of any quarter of the base year of a previously filed valid
19 claim, a period of 53 consecutive weeks beginning on the Sunday immediately preceding the date
20 on which family leave, medical leave or safe leave commences.

21 (6) “Child” means:

22 (a) A biological child, adopted child, stepchild or foster child of a covered individual or of the
23 covered individual’s spouse or domestic partner;

24 (b) A person who is or was a legal ward of a covered individual or of the covered individual’s
25 spouse or domestic partner; or

26 (c) A person who is or was in a relationship of in loco parentis with a covered individual or
27 with the covered individual’s spouse or domestic partner.

28 (7) “Claimant” means an individual who has submitted an application or established a claim for
29 benefits.

30 (8) “Contribution” or “contributions” means the money payments made by any of the following
31 under ORS 657B.150:

32 (a) An employer;

33 (b) An employee;

34 (c) A self-employed individual;

35 (d) A tribal government; or

36 (e) An employee of a tribal government.

37 (9) “Covered individual” means any one of the following who qualifies under ORS 657B.015 to
38 receive family and medical leave insurance benefits:

39 (a) An eligible employee;

40 (b) A self-employed individual; or

41 (c) An employee of a tribal government.

42 (10) “Domestic partner” means an individual joined in a domestic partnership.

43 (11) “Domestic partnership” has the meaning given that term in ORS 106.310.

44 (12) “Eligible employee” means:

45 (a)(A) An employee who has earned at least \$1,000 in wages during the base year; or

1 (B) If an employee has not earned at least \$1,000 in wages during the base year, an employee
2 who has earned at least \$1,000 in wages during the alternate base year; and

3 (b) An employee to whom paid family and medical leave insurance benefits may be available
4 under ORS 657B.015.

5 (13) "Eligible employee's average weekly wage" means an amount calculated by the Director of
6 the Employment Department by dividing the total wages earned by an eligible employee during the
7 base year by the number of weeks in the base year.

8 (14)(a) "Employee" means:

9 (A) An individual performing services for an employer for remuneration or under any contract
10 of hire, written or oral, express or implied.

11 (B) A home care worker as defined in ORS 410.600.

12 (b) "Employee" does not include:

13 (A) An independent contractor as defined in ORS 670.600.

14 (B) A participant in a work training program administered under a state or federal assistance
15 program.

16 (C) A participant in a work-study program that provides students in secondary or postsecondary
17 educational institutions with employment opportunities for financial assistance or vocational train-
18 ing.

19 (D) A railroad worker exempted under the federal Railroad Unemployment Insurance Act.

20 (E) A volunteer.

21 (F) A judge as defined in ORS 260.005.

22 (G) A member of the Legislative Assembly.

23 (H) A holder of public office as defined in ORS 260.005.

24 (15)(a) "Employer" means any person that employs one or more employees working anywhere in
25 this state or any agent or employee of such person to whom the duties of the person under this
26 chapter have been delegated.

27 (b) "Employer" includes:

28 (A) A political subdivision of this state or any county, city, district, authority or public corpo-
29 ration, or any instrumentality of a county, city, district, authority or public corporation, organized
30 and existing under law or charter;

31 (B) An individual;

32 (C) Any type of organization, corporation, partnership, limited liability company, association,
33 trust, estate, joint stock company or insurance company;

34 (D) Any successor in interest to an entity described in subparagraph (C) of this paragraph;

35 (E) A trustee, trustee in bankruptcy or receiver; or

36 (F) A trustee or legal representative of a deceased person.

37 (c) "Employer" does not include the federal government or a tribal government.

38 (16) "Employment agency" has the meaning given that term in ORS 658.005.

39 (17) "Family and medical leave insurance benefits" means the wage replacement benefits that
40 are available to a covered individual under ORS 657B.050 or under the terms of an employer plan
41 approved under ORS 657B.210, for family leave, medical leave or safe leave.

42 (18)(a) "Family leave" means leave from work taken by a covered individual:

43 (A) To care for and bond with a child during the first year after the child's birth or during the
44 first year after the placement of the child through foster care or adoption;

45 (B) To effectuate the legal process required for placement of a foster child or the adoption of

- 1 a child; or
- 2 (C) To care for a family member with a serious health condition.
- 3 (b) “Family leave” does not mean:
- 4 (A) Leave described in ORS 659A.159 (1)(a) except for leave to care for a child who requires
- 5 home care due to an illness, injury or condition that is a serious health condition;
- 6 (B) Leave described in ORS 659A.159 (1)(b); or
- 7 (C) Leave authorized under ORS 659A.093.
- 8 (19) “Family member” means:
- 9 (a) The spouse of a covered individual;
- 10 (b) A child or the child’s spouse or domestic partner;
- 11 (c) A parent or the parent’s spouse or domestic partner;
- 12 (d) A sibling or stepsibling of a covered individual or the sibling’s or stepsibling’s spouse or
- 13 domestic partner;
- 14 (e) A grandparent of a covered individual or the grandparent’s spouse or domestic partner;
- 15 (f) A grandchild of a covered individual or the grandchild’s spouse or domestic partner;
- 16 (g) The domestic partner of a covered individual; or
- 17 (h) Any individual related by blood or affinity whose close association with a covered individual
- 18 is the equivalent of a family relationship.
- 19 (20) “Medical leave” means leave from work taken by a covered individual that is made neces-
- 20 sary by the individual’s own serious health condition.
- 21 (21) “Parent” means:
- 22 (a) A biological parent, adoptive parent, stepparent or foster parent of a covered individual;
- 23 (b) A person who was a foster parent of a covered individual when the covered individual was
- 24 a minor;
- 25 (c) A person designated as the legal guardian of a covered individual at the time the covered
- 26 individual was a minor or required a legal guardian;
- 27 (d) A person with whom a covered individual was or is in a relationship of in loco parentis; or
- 28 (e) A parent of a covered individual’s spouse or domestic partner who meets a description under
- 29 paragraphs (a) to (d) of this subsection.
- 30 (22) “Safe leave” means leave taken for any purpose described in ORS 659A.272.
- 31 (23) “Self-employed individual” means:
- 32 (a) An individual who has self-employment income as defined in section 1402(b) of the Internal
- 33 Revenue Code as amended and in effect on December 31, [2023] **2024**; or
- 34 (b) An independent contractor as defined in ORS 670.600.
- 35 (24) “Serious health condition” means:
- 36 (a) An illness, injury, impairment or physical or mental condition that requires inpatient care
- 37 in a hospital, hospice or residential medical care facility;
- 38 (b) An illness, disease or condition that in the medical judgment of the treating health care
- 39 provider poses an imminent danger of death, is terminal in prognosis with a reasonable possibility
- 40 of death in the near future, or requires constant care;
- 41 (c) Any period of disability due to pregnancy, or period of absence for prenatal care; or
- 42 (d) Any period of absence for the donation of a body part, organ or tissue, including preoperative
- 43 or diagnostic services, surgery, post-operative treatment and recovery.
- 44 (25) “Third party administrator” means a third party that enters into an agreement with the
- 45 Director of the Employment Department to implement and administer the paid family and medical

1 leave program established under this chapter.

2 (26) "Tribal government" means:

3 (a) A tribal government as defined in ORS 181A.940; or

4 (b) A federally recognized Indian tribe.

5 (27)(a) "Wages" has the meaning given that term in ORS 657.105.

6 (b) "Wages" does not mean contribution amounts paid to the Paid Family and Medical Leave
7 Insurance Fund by an employer on behalf of an employee under ORS 657B.150 (5).

8 **SECTION 32.** (1) **Except as provided in subsections (2) and (3) of this section, the**
9 **amendments to statutes by sections 1 to 31 of this 2025 Act apply to transactions or activities**
10 **occurring on or after January 1, 2025, in tax years beginning on or after January 1, 2025.**

11 (2) **The effective and applicable dates, and the exceptions, special rules and coordination**
12 **with the Internal Revenue Code, as amended, relative to those dates, contained in federal law**
13 **amending the Internal Revenue Code and enacted before January 1, 2025, apply for Oregon**
14 **personal income and corporate excise and income tax purposes, to the extent they can be**
15 **made applicable, in the same manner as they are applied under the Internal Revenue Code**
16 **and related federal law.**

17 (3)(a) **If a deficiency is assessed against any taxpayer for a tax year beginning before**
18 **January 1, 2025, and the deficiency or any portion thereof is attributable to any retroactive**
19 **treatment under the amendments to ORS 178.300, 178.375, 305.239, 305.494, 305.690, 305.842,**
20 **314.011, 314.306, 315.004, 316.012, 316.147, 316.157, 317.010, 317.097 and 317A.100 by sections 1, 2**
21 **and 16 to 28 of this 2025 Act, then any interest or penalty assessed under ORS chapter 305,**
22 **314, 315, 316, 317, 317A or 318 with respect to the deficiency or portion thereof shall be can-**
23 **celed.**

24 (b) **If a refund is due any taxpayer for a tax year beginning before January 1, 2025, and**
25 **the refund or any portion thereof is due the taxpayer on account of any retroactive treat-**
26 **ment under the amendments to ORS 178.300, 178.375, 305.239, 305.494, 305.690, 305.842, 314.011,**
27 **314.306, 315.004, 316.012, 316.147, 316.157, 317.010, 317.097 and 317A.100 by sections 1, 2 and 16**
28 **to 28 of this 2025 Act for a tax year beginning before January 1, 2025, then notwithstanding**
29 **ORS 305.270 or 314.415 or any other law, the refund or portion thereof shall be paid without**
30 **interest.**

31 (c) **Any changes required because of the amendments to ORS 178.300, 178.375, 305.239,**
32 **305.494, 305.690, 305.842, 314.011, 314.306, 315.004, 316.012, 316.147, 316.157, 317.010, 317.097 and**
33 **317A.100 by sections 1, 2 and 16 to 28 of this 2025 Act for a tax year beginning before January**
34 **1, 2025, shall be made by filing an amended return within the time prescribed by law.**

35 (d) **If a taxpayer fails to file an amended return under paragraph (c) of this subsection,**
36 **the Department of Revenue shall make any changes under paragraph (c) of this subsection**
37 **on the return to which the changes relate within the period specified for issuing a notice of**
38 **deficiency or claiming a refund as otherwise provided by law with respect to that return, or**
39 **within one year after a return for a tax year beginning on or after January 1, 2025, and be-**
40 **fore January 1, 2026, is filed, whichever period expires later.**
